President's Message

Message from the President of LWVUS — Dianna Wynn: "We Will Speak Up and Speak Out."

As we take stock of the work before us in the aftermath of the election, we can take comfort in the following reminders from Dianna Wynn, President of the League of Women Voters US that she shared in her blog to League members.

The League is expert in nonpartisanship with over a century of experience in pro-democracy work. Navigating through a hyper-partisan political environment in a nonpartisan manner can be confusing to some. Despite what political parties may have you believe, issues are not inherently partisan. Of course, political parties take partisan positions on issues, but that does not alter the League's nonpartisan approach.

Advocating for gender and racial equity is not partisan. Calling out attacks on democracy is not partisan. After all, our mission is to "defend democracy." We cannot live up to our mission if we are unwilling to speak up and speak out.

Our concern for and commitment to women's empowerment is grounded in our core values. To claim this commitment is partisan is to belittle — and seek to silence — us.

Women's Equality is Not Partisan.

Support for women's equality is nonpartisan. Our belief in the rights of women is not derived from a specific candidate or party. Nobody — Democrat, Republican, or other — has an exclusive claim on equality.

The League has stood for the political rights and representation of women for over a century, and in that time, political support and public opinion around issues like suffrage, abortion, workplace discrimination, maternal rights, and more have evolved and shifted. Yet, we have always stood firm in our values.

Our concern for and commitment to women's empowerment is grounded in our core values. To claim this commitment is partisan is to belittle — and seek to silence — us.

ADVOCACY

Because of the election there was only one advocacy petition sent out November, and it was on overturning Citizens United to get big money out of politics. The major effort was a request from LWVC to set up interviews with our California State Senators and Assembly Members and to submit a report by February 24, 2025.

VOLUNTEERS NEEDED FOR LEGISLATOR INTERVIEWS

LWVNOC has the task of interviewing our State Legislators and submitting a report to LWVC by There will be five to seven February 24, 2025. interviews and three to five people are needed for each interview. We need several volunteers since the time and date of each interview is determined by the Legislator and not every volunteer will be available at that time and date. The interviews may be in person or by Zoom, though in person is preferred. Each interview will include at least a greeter, a note keeper, and a question asker. Any additional people are to participate in discussions or ask one of the questions. We will ask the Legislator two questions provided by LWVC and possibly one more that is of interest to LWVNOC. The purpose of the interviews is to provide LWVC insight on issues of interest to the Legislator and provide introduction of the Legislator to LWVNOC.

I'd like to gather a list of those interested in being part of the legislator interviews and also to know what roles each team member would prefer. I'll keep the team informed of interview activity and provide times and details to see who available. The League would like the team to be as diverse as possible. In some cases we may need help setting up the interview. If you know or have some contact with any of the Legislators let me know.

Observer Corps Report by Karen Bender

Front and center in this report is the 11/19 **Fullerton City Council** meeting, because over fifty percent of our North Orange County League resides there. The major focus was the Full ten General Plan Housing Element amendment to implement the state required housing incentive zoning. The proposal by the city staff produced far more than the state imposed minimum requirement of about 13,000 residences. Discussion ranged over the impacts on city water, transportation, streets, infrastructure, schools, crime, small businesses replaced, small affordable rentals replaced, and the potential increase in population of about 40,000 people. Recommendations included adding a "middle income" purchase category to developer requirements in addition to the current "low income" ones for affordable housing; increasing parking space requirements, setting building height limits (3 stories suggested); and placing geographic limits to projects built in the Chapman to Commonwealth corridor (State College to Berkeley). City staff has been assigned to revise the proposal and present it at the Dec. 17 City Council meeting. (See our website for R. Zemke's full report).

On October 22, the **Orange County Board of Supervisors** meeting was essentially disrupted by events outside of that meeting. The Department of Justice and the District Attorney had just held a press conference to announce that District 1 Supervisor Andrew Do had pled guilty under indictment and resigned his Supervisor position.

The November 5th meeting was short because it was Voting Day. Meanwhile, workers continue to remove hazardous waste material from the area burnt by the Trabuco Canyon airport fire. Some surrounding properties have been contaminated by ash and debris. Five government agencies are working to clear Trabuco Canyon and Holy Jim properties as soon as possible to mitigate further environmental contamination to the surrounding area and watershed.

On November 19, the legislative agenda for the coming year was presented via supplementary materials. About an hour was spent discussing whether, following the Do scandal, an independent external auditor should also review county procedures regarding contracts, in addition to 1) the Procurement Office and 2) the Campaign Finance and Ethics Committee. The discussion was continued to the next meeting on 12/3.

The Orange Coast Observer Corps reports that the **Orange County Board of Education** voted 5-0 to approve Board travel to Washington, D.C. to meet with lobbyists and federal government officials. Public comment asked the Board to publicly disclose and agendize their plan in advance of voting; the Board thanked the speaker for her comments and immediately approved the travel.

"YE LOOK LIKE SOMETHING THE CAT DRAGGED IN." Translation: "You look like a disheveled mess."

"DINNAE BE A WEE CLIPE." Translation: "Stop being a little gossip."

"KEEP THE HEID." Translation: "Keep calm, and carry on – everything will be ok."

"HAUD YER WHEESHT!" Translation: "Keep your mouth shut!"

"WHIT'S FUR YE'LL NO GO PAST YE." Translation: "If it's meant to be, then it will happen for you."

"YER BUM'S OOT THE WINDAE." Translation: "You're talking absolute nonsense."

"A' YER EGGS ARE DOUBLE-YOAKIT." Translation: "You're always embellishing your stories."

"YER A LONG TIME DEID." Translation: "Seize the day and live life to the fullest, you never know what might happen."

"LANG MAY YER LUM REEK." Translation: "I wish you good luck and good fortune for the future."

"GUID GEAR COMES IN SMA' BULK." Translation: "Good things come in small packages."

"YER HEID'S FU' O' MINCE." Translation: "Your head is in the clouds."

"TATTIES O'WER THE SIDE." Translation: "It's all gone horribly wrong – a disaster"

"YER AYWIS AT THE COW'S TAIL." Translation: "You're always walking slowly, dragging your heels."

"AH EH IH OH!" Translation: "I ate it all."

Why I Feel the LWV is Important by Richard Larsen

The LWV's primary goal as far as I am concerned is to urge people to get registered and to vote, regardless of political party. Why this is important and a real concern to me is detailed below.

In the 1950s and 1960s our politicians were saying how bad the Russian Communist party was, and that they only represented twenty percent of the population. They never mentioned that we were not much different. Our presidential election this year is not much different than most presidential elections. Regardless of how you feel about this year's outcome, consider this:

- A. The President elect so far has received 78,842,134 votes.
- B. This number represents just 47% of registered voters, not a majority.
- C. This also represents just 30% of voting age population, not a majority.
- D. And finally this represents just 23% of our total population, similar to typical USSR percentages.
