During my career, I promised myself that if I was fortunate enough to retire in good health I would try to give back to the community. When I retired in 2017, I keep that pledge by volunteering to serve on the Village Council and by winning election to the Council two years ago. I hope to continue "giving back" if I am re-elected this year. My accounting background enables me to review the Village's financial statements with an understanding that not everyone has. My legal background enables me, the only lawyer on the Council, to be aware of potential legal problems the Village and the Council may face. I used my legal knowledge to spearhead the effort to update the Village Charter a couple of years ago. I used the negotiating skills I learned as a bank attorney to help negotiate a more favorable deal with the developer of the project at 14 Mile and Telegraph Road.	<ol style="list-style-type: none"> 1. Expenses are increasing faster than income, leading the Council to increase the millage rate the last two years. I will, as I have for the past three years, oppose any spending that is not essential to the Village. This past year I helped lead the renegotiation of the Village's contract with the Baldwin Public Library that resulted in a cap on any annual increase in the amount the Village will have to pay for this service. I hope to help limit the costs of the Village's other contracts for services as they come up for renewal. I voted against this year's millage increase since I believed it was not wise to raise the rate during the current coronavirus pandemic. 2. Encouraging development of the few remaining undeveloped parcels in the Village in a manner consistent with the Village's zoning ordinances and character while also increasing the Village's tax base. 3. While not necessarily a Village priority, I hope to continue to represent the Village as its representative to SOCWA.
