The funding of public education must be a top priority in our state. Improving educational outcomes requires that we equitably fund our public schools so that all children can access a quality education regardless of their socioeconomic status. Unfortunately, increases to the School Aid Fund have barely kept up with the cost of inflation. We must increase funding to the School Aid Fund and prioritize making pre-K available to all children. Studies have shown that children who participate in pre-K learning have overall better educational outcomes.

One way to increase the availability of jobs in Michigan is to require that any company who receives tax incentives hires Michigan workers. Additionally, emphasizing the availability of jobs in the skilled trades will also help direct young people towards these careers. Increasing the minimum wage, re-establishing protections for workers' unions, and strengthening paid sick time policies will further help Michiganders improve their economic positions.

Michigan needs to focus on policies that promote equity, not just equality. Not everyone in our state starts at the same point, and equitable policies work to offset that. We need to prioritize addressing the disparity between health outcomes for black and white mothers and newborns. Equitable education funding will address some education disparities. While not a complete solution, repealing the pension tax will partially address the poverty some seniors are facing. Addressing prescription drug pricing and health care costs will also help combat the poverty we see across our state.

# WAYNE RESA PROPOSAL REGIONAL ENHANCEMENT MILLAGE RENEWAL PROPOSAL

Pursuant to state law, the revenue raised by the proposed enhancement millage will be collected by the Wayne County Regional Educational Service Agency and distributed to local constituent public school districts including eligible public school academies within the boundaries of the Wayne County Regional Educational Service Agency based on pupil membership count. As a renewal of authority which expires with the 2021 levy, shall the limitation on the amount of ad valorem taxes which may be imposed on taxable property in the Wayne County Regional Educational Service Agency, Michigan, be increased by 2 mills (\$2.00 per thousand dollars of taxable value) for a period of six (6) years, 2022 to 2027, inclusive, to provide operating funds to enhance other state and local funding for local school district operating purposes? It is estimated that 2 mills would raise approximately \$90.4 million when first levied in 2022. The revenue from this millage will be disbursed to public school academies within the boundaries of the Wayne County Regional Educational Service Agency which are eligible to receive enhancement millage under the Revised School Code and the following school districts: Allen Park Public Schools, Crestwood School District, Dearborn City School District, Dearborn Heights School District #7, Detroit Public Schools Community District, Ecorse Public School District, Flat Rock Community Schools, School District of the City of Garden City, Gibraltar School District, Grosse Ile Township Schools ,The Grosse Pointe Public School System, Hamtramck Public Schools City of Harper Woods Schools, School District of the City of Highland Park, Huron School District, School District of the City of Lincoln Park, Livonia Public Schools, Melvindale - Northern Allen Park Schools, Northville Public Schools, Plymouth-Canton Community Schools, Redford Union School District, River Rouge School District, Riverview Community School District, Romulus Community Schools, Southgate Community School District, South Redford School District, Taylor School District, Trenton Public Schools, Van Buren Public Schools, Wayne-Westland Community School District Westwood Community Schools, Woodhaven-Brownstown School District, Wyandotte City School District.

I am a Lead Attorney with the Wayne County Prosecutor's Office. I head the Wayne Arson Reduction Unit which prosecutes arson for-profit crimes involving real property (insurance fraud) and arson where someone has been killed or injured. I was awarded Prosecutor of the Year 2017-2018 by the International Association of Arson Investigators for my work combating arson in Wayne County. I have been a prosecutor for over 12 years. I have litigated felonies of all kinds including capital cases such as homicide and armed robberies. Previous to joining the WCPS, I was an associate with Miller, Canfield, Paddock and Stone, P.L.C. a civil defense firm. At MCPS, I practiced Labor and Employment Discrimination Law. I am running for this office because I am qualified, knowledgeable and compassionate. I want to make a difference in the lives of both victims and defendants.

One of the top issues facing the criminal court is mental health. Although Wayne County has a mental health court, the facilities who take defendants with mental health issues will not take defendants who are facing arson charges because of the liability.
