Photo ID Requirement

People voting in person must present a form of photo ID or alternative approved by the state or else may only vote provisionally. For more information and exceptions see DallasCountyVotes.org or call 214.819.6300.

Eligibility for Voting

You must be a citizen of the United State, registered to vote in the county of your residence 30 days prior to election day, and must be at least 18 years old on election day. You cannot vote if you have been declared by a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote or are a convicted felon who has not completed your sentence, probation and/or parole.

Cedar Hill has a council-manager form of government. The City Council sets the policies for the city's operation while the City Manager (appointed by Council) has administrative responsibilities. The City Council has 7 members (Mayor and 6 Council members). The Mayor and 2 Council members are elected at large. If no candidate receives at least 50% of the vote, there will be a runoff election.

ECONOMIC DEVELOPMENT: I believe Cedar Hill is the Jewel of the Metroplex. It offers opportunities unlike any other city in North Texas. A key to keeping our local economy strong will be to support the current efforts of our economic development department as well as look for innovative ways to help both local businesses flourish and attract new businesses as well. ECONOMIC DEVELOPMENT: I would support boasting a diverse and robust business community which offers a wide array of products and services for residents, as well as attractions for visitors. AFFORDABLE HOUSING: I support affordable housing, however, at this time Cedar Hill does not need additional apartments in the city. PUBLIC SAFETY: The city is doing a phenomenal job in regards to public safety. In 2012, voters approved a ballot measure that allowed the City to designate 1/8 of one percent of existing sales tax revenue to fund community safety and crime prevention initiatives. The initial five year term of the CCPD expired in November 2017, and citizens approved extending the CCPD for an additional 15 years during the bond election in 2017.

CHALLENGE/OPPORTUNITY: The widening gap between the haves and have-nots will be accentuated in the future. Such inequalities, when left unchecked, can destabilize a city and upend any benefits of urban development. There is a critical need for policy-makers to ensure that the fruits of progress are shared equitably. Good governance is imperative. As the city increase in size and the population become more diverse governing will, therefore, be progressively complex and require the most dedicated of minds.

ECONOMIC DEVELOPMENT: During my 15 years as city manager of Cedar Hill, we significantly increased options for retail goods and services. However, as a predominantly bedroom community, Cedar Hill lacks day time population. I support aggressive efforts to target commercial development of professional office space for personnel in the medical fields, architects, engineers, attorneys, accountants, technology, insurance and finance related entities. Professional office development would allow the tax burden that pays for city services to shift from residential to commercial. It would also increase the future possibility of lowering taxes.

INFRASTRUCTURE: Infrastructure can be best described as either pay for it now or pay more later. As the former city manager, we annually transferred funds from the operating budget to capital accounts to build up revenue for minor street improvements, drainage projects and facility maintenance. Regarding major capital improvements for roads, voters would have to authorize the issuance of bonds. For water and sewer, an engineering firm was hired to analyze the current and future needs and to recommend the necessary rate model structure to pay for the improvements. That plan has been implemented.

AFFORDABLE HOUSING: The recent addition of over several hundred new apartment units has significantly increased the inventory to meet the demand for affordable housing. At this point, it is inconceivable that additional apartments are needed right now. Additionally, in the earliest years of development of Cedar Hill, a strong inventory of low cost, entry level single family homes were constructed that have helped address the demand for affordable housing.

PUBLIC SAFETY: Consistent with my tenure as city manager, my number one priority is public safety! Cedar Hill currently has the lowest crime rate of all the Best Southwest cities. However, as a member of the city council, my plan is to provide direction to the city manager to develop a long term, sustainable plan to fortify our public safety operations and lower the crime rate. That plan would be presented to the city council for review, consideration, adoption and implementation.

CHALLENGE/OPPORTUNITY: Almost two thirds of the city budget is devoted to public safety. If the State Legislature enacts significant reductions in the current property tax cap, it could have a negative impact on our ability to deliver public safety services unless there is an exemption granted. The city also needs to expand its community engagement efforts with our residents toward the goal of strengthening neighborhoods, fostering ongoing dialogue and communication and minimizing misperceptions and distrust. Lastly, the entire community needs to rally around efforts to improve the educational excellence in our public schools.

ECONOMIC DEVELOPMENT: I would support the completion of the mixed-use development project for historic downtown Cedar Hill and the Preston Trail project as well as the completion of the hotel/conference center project at Hillside Village.

INFRASTRUCTURE: Cedar Hill's infrastructure needs to be able to carry us through today and into the future. Keeping streets, drainage systems, and water mains in good condition is a necessity for citizens in any city and thus should be, and is a high priority. In 2017, Cedar Hill voters approved a \$45 million Bond with \$10 million appropriated to street repair and drainage system projects. Street repair projects have already begun.

AFFORDABLE HOUSING: While I do recognize the need for affordable housing, I also understand that there needs to be a balance in the city with regards to apartment construction. Cedar Hill currently has a number of apartment complexes spread throughout the city including a current mixed-use complex and another mixed-use complex currently under construction. Cedar Hill also utilizes a Tax Increment Financing tool to finance revitalization of blighted areas of the city and to help finance construction of low to moderate income housing.

PUBLIC SAFETY: Public safety is a high priority in Cedar Hill and its performance in the area of public safety is exceptional. Our Police and Fire Departments remain on the cutting edge of public safety with advanced training, and acquisition of technologically advanced equipment. The results of this are reflected in lower crime statistics and elevated citizen involvement. Cedar Hill created, and voters approved, a Crime Control and Prevention District (CCPD) where 1/8th of 1% of sales tax revenue is used to financially support many of the community outreach policing programs. I would continue to support our Police and Fire Depts.

CHALLENGE/OPPORTUNITY: I think Cedar Hill's greatest challenge in the next several years will be administrating growth of the city, both residential and commercial, while continuing to provide high quality services to current citizens and businesses in a fiscally responsible manner. I think Cedar Hill's greatest opportunity will be employing the natural beauty and the distinctive character of Cedar Hill to attract businesses, large and small, as well as residents to live, work and play here, now and for generations to come.

CHALLENGE/OPPORTUNITY: In 2017, roughly 150,000 people migrated to the DFW area. Cedar Hill will continue to expand just as the DFW does. With this expansion, I will work to safe-guard our future population growth by ensuring we have robust policies in place to handle the population boom.

DALLAS COUNTY COMMUNITY COLLEGE DISTRICT SPECIAL BOND ELECTION

PROPOSITION A

Shall the Board of Trustees of Dallas County Community College District (the "District"), be authorized to issue and sell the bonds and notes of the District as authorized by law at the time of issuance thereof, in the aggregate principal amount of \$1,102,000,000, for the purpose of constructing, improving, renovating and equipping school buildings of the District and acquiring real property therefor; with said bonds or notes to be issued in one or more series or issues, to mature serially or otherwise not to exceed 40 years from their date and bear interest at such rate or rates, not to exceed the respective limits prescribed by law at the time of issuance, and to be sold at such price or prices, as the Board of Trustees in its discretion shall determine; and shall there be levied and pledged, assessed and collected annually Ad Valorem taxes on all taxable property in the District in an amount sufficient, within the limits prescribed by law, to pay the annual interest on said bonds and notes and the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with said bonds and notes; with said bonds and notes to be issued and said taxes to be levied, pledged, assessed, and collected under the Constitution and laws of the state of Texas, including the Texas Education Code.

Explanation

The Dallas County College District ("DCCCD" or the "District") operates the 7 community colleges in Dallas County. The District currently serves 80,000 credit students and 20,000 continuing education (non-credit) students. In the next 11 years, the District expects the number of credit students will increase by 12,000. The \$1.1 billion bond issue will be used to expand the District's resources to enhance the educational experience and meet the expanding student population.

The 7 Dallas County community colleges have served over 3 million people since their inception in 1965. One of the largest community college systems in Texas, these colleges offer over 300 associate degree and career technical certifications. These colleges have been an instrumental contributor to the vibrant economic success of Dallas County.

The general obligation bonds will be sold over 6 years and under current conditions, will not increase property taxes. The District's last bond issue was 15 years ago and will be fully repaid in the next few years. The District's past performance on its prior bond issues is part of what makes it a good credit risk for this issuance.

The money from the bond issue will be used for 3 distinct initiatives: (1) Expand industry aligned workforce programs (\$235 million) – to train student to work in industries with high demand for jobs in the near future (health, IT, construction, advanced manufacturing); (2) Expand student instructional programs (\$332 million) – to expand the programs which permit high school students to take college courses and enhance student learning through technology and instructional innovation; and (3) Build a new Education and Innovation Hub in downtown Dallas (\$535 million) – would completely redesign the El Centro College campus and include a new Business Training Center to facilitate innovation and technology adaption in coordination with businesses in North Texas.

Reasons to Vote For

- 1. Expands the resources of the Dallas County Community colleges to meet the growing student population.
- 2. Maintains the current property tax rate; no increase in property taxes under current conditions.
- 3. Increases the instructional innovation to enhance student learning with new instructional tools, technology and modern student learning space.
- 4. Provides a center for industry aligned education and training programs to enable students to meet the changing needs of the workforce in North Texas.

Reasons to Vote Against

- 1. There is no increase in the current tax rate only if current conditions remain the same. If the cost of borrowing under the bond issue increases, either the tax rate might need to increase or the scope of the proposed bond package might need to be curtailed.
- 2. If the bond issue does not pass, to maintain operations, the District could meet increasing needs by increasing tuition and/or raising taxes without incurring debt
- 3. The District has been performing well and should continue to do so without the additional debt. There's no pressing need to incur debt to maintain operations.
- 4. Many feel property taxes are too high. If this item does not pass, the District could potentially reduce its tax rate giving relief to homeowners.
