Photo ID Requirement

People voting in person must present a form of photo ID or alternative approved by the state or else may only vote provisionally. For more information and exceptions see the Dallas County Elections Department website at DallasCountyVotes.org or call 214.819.6300.

Eligibility for Voting

You must be a citizen of the United State, registered to vote in the county of your residence 30 days prior to election day, and must be at least 18 years old on election day. You cannot vote if you have been declared by a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote or are a convicted felon who has not completed your sentence, probation and/or parole.

CITY OF GRAND PRAIRIE MAYOR AND COUNCIL ELECTION

The city of Grand Prairie is a Home Rule City and operates under a Council-Manager form of government. The City Council approves the budget and determines the tax rate. The council also focuses on the community's goals, major projects, and such long-term considerations as community growth, land use development, capital improvement plans, capital financing, and strategic planning as well as supervising the city manager's performance.

The Grand Prairie City Council is made of 6 single-district council members who each represent a specific district, 2 council members who represent the city "at large," and a Mayor who is also elected at large for a 9-member City Council. The Mayor and council members are elected for 3-years terms on a nonpartisan basis. If no candidate receives at least 50% of the vote, there will be a runoff election.

ECONOMIC DEVELOPMENT: What specific actions would you support to advance economic development?

INFRASTRUCTURE: What priority would you give to upgrading the city's infrastructure and how would you propose paying for needed upgrades?

ECONOMIC DEVELOPMENT: I would help businesses contribute to economic development in several ways including helping businesses create jobs for our residents, teens, re-entry and college graduates, encouraging entrepreneurship, minority business partnerships, enhancing fiscal sustainability by expanding and diversifying the tax base, and improving quality of life with new services and amenities. INFRASTRUCTURE: We are fortunate to have hired some great city staff. PUBLIC SAFETY: The city is fortunate to have a great public safety and be recognized as the 7th safest large city in Texas with a population 175,000 or more, 47% reduction in UCR Part I Crimes from 2010 to 2018, 19% reduction in UCR Parat I Crimes from 2017 to 2018. Some of our public safety improvements and projects includes but not limited to: Creation of a Certified Mental Health Coordinator position within GPPD, after the deadly shooting at IKEA that left a mental ill patient deceased. Increasing more mental health positions in GPPD.We can improve our relationships with LULAC and NAACP to continue to outreach in our city.

CHALLENGE/OPPORTUNITY: Grand Prairie is a predominately diverse city with a large and increasing minority population which is to our advantage. The City challenges is reaching out and communicating with all of our citizens. All of our families are not equipped with technology in their homes. GPISD has reported more than 75% percent of its students receiving free lunch coming from underpriviledge households. The language barriers and communication is a challenge and has room for improvement in our culturally diverse city. Our challenge will be to open up channels of communications involving social media, internet and technology.

ECONOMIC DEVELOPMENT: The DFW area is one of the fasts growing areas in the nation. Grand Prairie is smack dab in the middle of the DFW area. Growth is coming. We have been so under served in the retail/restaurant area. We've had to drive to other cities for years. Now we will have our own choices close by. I will continue aggressively pursuing additional retail and restaurant developments. In addition, we meet almost weekly with potential developers looking to build Hotels and other great developments in GP. We have a lot to offer. As Mayor I want them to know we are open for business.

INFRASTRUCTURE: We are an older first ring city and have an aging infrastructure. Since we aren't in DART, we've been able to use a quarter cent of the sales tax on the maintenance of our streets. in addition, we use a quarter cent to fund our parks department. It would be difficult to keep up if we didn't have available. We continually look at long range replacement/upgrade needs and set aside money every year to fund these capital improvements. The quarter cent sales tax we use for our Crime Control and Prevention District does not fund infrastructure. However, it helps relieve the burden that would place on the general fund.

AFFORDABLE HOUSING: We have a number of locations in our city already zoned for MF. I support land owner rights, but will make sure the new apartments meet our design standards. I would be hard pressed to add additional MF zoning unless it's part of an overall mixed use master plan.

PUBLIC SAFETY: Chief Steve Dye, tells me we just received notice that we've had a: • 47% crime decrease from 2010 through 2018 • 3,814 fewer crimes even though our population grew by 25,000 • 19% crime decrease from 2017 to 2018 • And are consistently a Top Ten Safest Large City in Texas (populations of 100,000 or more), as ranked by the FBI's Uniform Crime Reporting and Texas Department of Public Safety. • In fact, we just found out we are now the 7th safest city in Texas of the 34 cities with populations greater than 100,000! This doesn't happen by accident. Chief Dye is one of, if not the best Chiefs in the State.

CHALLENGE/OPPORTUNITY: The explosive growth, especially in the southern section of our city, has presented challenges. The council and staff have done a great job forecasting the growth planning for the future. Whether it's for water capacity, public safety issues or transportation planning. In addition, Grand Prairie, like many of our neighbors, is becoming more and more diverse. Fortunately our citizens have embraced this diversity and continue to work together for the good of the community. Going forward, as a majority minority community we will continue our efforts to embrace diversity.

ECONOMIC DEVELOPMENT: Each case will need to be reviewed and not assume of being an economic impact to our community, however each case should be carefully considered and beneficial for the businesses, consumers, and citizens of Grand Prairie. TEACHER SALARIES: Some districts are wealthy, GPISD is not. Approximately, 78% of our student population is economically disadvantaged. Rather than being in line with other school districts, we should enhance teachers' salaries as much as the budget allows.

FISCAL OVERSIGHT: The district recently received an unqualified audit. There were no significant discrepancies as noted by an independent audit firm. At least quarterly the Board should be briefed on the status of the budget. **PRIORITIES:** The top two issues that I see are school safety and rewarding good teachers. Our students should be taught in a safe and secure environment and be prepared for the unexpected. The school has monthly fire drills, and we should have routine safety drills. The school tragedies in this Country should prepare us for the 'what ifs." The school in conjunction with the police department should practice unannounced safety drills. We must keep safety in the forefront. Each profession has excellent employees and other employees may need a growth plan. We must find a means to financially reward excellent teachers.

OTHER ISSUES: The Board should be transparent and safeguards setup to prevent a single Board trustee from spending tax dollars without the majority of the Board's approval.

DALLAS COUNTY COMMUNITY COLLEGE DISTRICT SPECIAL BOND ELECTION

PROPOSITION A

Shall the Board of Trustees of Dallas County Community College District (the "District"), be authorized to issue and sell the bonds and notes of the District as authorized by law at the time of issuance thereof, in the aggregate principal amount of \$1,102,000,000, for the purpose of constructing, improving, renovating and equipping school buildings of the District and acquiring real property therefor; with said bonds or notes to be issued in one or more series or issues, to mature serially or otherwise not to exceed 40 years from their date and bear interest at such rate or rates, not to exceed the respective limits prescribed by law at the time of issuance, and to be sold at such price or prices, as the Board of Trustees in its discretion shall determine; and shall there be levied and pledged, assessed and collected annually Ad Valorem taxes on all taxable property in the District in an amount sufficient, within the limits prescribed by law, to pay the annual interest on said bonds and notes and the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with said bonds and notes; with said bonds and notes to be issued and said taxes to be levied, pledged, assessed, and collected under the Constitution and laws of the state of Texas, including the Texas Education Code.

Explanation

The Dallas County College District ("DCCCD" or the "District") operates the 7 community colleges in Dallas County. The District currently serves 80,000 credit students and 20,000 continuing education (non-credit) students. In the next 11 years, the District expects the number of credit students will increase by 12,000. The \$1.1 billion bond issue will be used to expand the District's resources to enhance the educational experience and meet the expanding student population.

The 7 Dallas County community colleges have served over 3 million people since their inception in 1965. One of the largest community college systems in Texas, these colleges offer over 300 associate degree and career technical certifications. These colleges have been an instrumental contributor to the vibrant economic success of Dallas County.

The general obligation bonds will be sold over 6 years and under current conditions, will not increase property taxes. The District's last bond issue was 15 years ago and will be fully repaid in the next few years. The District's past performance on its prior bond issues is part of what makes it a good credit risk for this issuance.

The money from the bond issue will be used for 3 distinct initiatives: (1) Expand industry aligned workforce programs (\$235 million) – to train student to work in industries with high demand for jobs in the near future (health, IT, construction, advanced manufacturing); (2) Expand student instructional programs (\$332 million) – to expand the programs which permit high school students to take college courses and enhance student learning through technology and instructional innovation; and (3) Build a new Education and Innovation Hub in downtown Dallas (\$535 million) – would completely redesign the El Centro College campus and include a new Business Training Center to facilitate innovation and technology adaption in coordination with businesses in North Texas.

Reasons to Vote For

- 1. Expands the resources of the Dallas County Community colleges to meet the growing student population.
- 2. Maintains the current property tax rate; no increase in property taxes under current conditions.
- 3. Increases the instructional innovation to enhance student learning with new instructional tools, technology and modern student learning space.
- 4. Provides a center for industry aligned education and training programs to enable students to meet the changing needs of the workforce in North Texas.

Reasons to Vote Against

- 1. There is no increase in the current tax rate only if current conditions remain the same. If the cost of borrowing under the bond issue increases, either the tax rate might need to increase or the scope of the proposed bond package might need to be curtailed.
- 2. If the bond issue does not pass, to maintain operations, the District could meet increasing needs by increasing tuition and/or raising taxes without incurring debt
- 3. The District has been performing well and should continue to do so without the additional debt. There's no pressing need to incur debt to maintain operations.
- 4. Many feel property taxes are too high. If this item does not pass, the District could potentially reduce its tax rate giving relief to homeowners.



Voters With Special Needs

Services Available to Voters with Special Needs in Texas

Accessible Voting Systems

- On September 1, 1999, Texas became the first state to require that all new voting systems be accessible to voters with disabilities and provide a practical and effective means for voters with disabilities to cast a secret ballot.
- In every federal election (and most nonfederal elections), each polling place will offer at least one type of accessible voting equipment or Direct Record Electronic ("DRE") device. This equipment allows voters with disabilities to vote directly on the system or assist them in marking the paper ballot. Depending on the type of system, voters with disabilities may use headphones or other assistive devices to help them vote independently and secretly.
- In certain nonfederal elections held in counties with a population of less than 20,000, accessible machines may not be available at every polling place. To determine if accessible machines will be available or to request an accommodation, contact the early voting clerk of the county or political subdivision holding the election at least 21 days before the election.

All Polling Places in Texas Must be Accessible

Polling places should support voters, not hinder them. When you go to the polls in Texas, you can expect:

- Your polling place will meet strict accessibility standards, including:
- A location on the ground floor that can be entered from the street or via an elevator with doors that open at least 36 inches
- Doors, entrances, and exits used to enter or leave the polling place that are at least 32 inches wide
- Any curb next to the main entrance to the polling place must have curb-cuts or temporary non-slip ramps
- Stairs necessary to enter or leave the polling place must have handrails on each side and a non-slip ramp.
- Removal of all barriers such as gravel, automatically closing gates, closed doors without lever-type handles, or any other barrier that impedes the path of the physically disabled to the voting station.
- Voting systems that are accessible to voters with physical disabilities and can accommodate no vision, low vision, no hearing, low hearing, limited manual dexterity, limited reach, limited strength, no mobility, low mobility, or any combination of the foregoing (except the combination of no hearing and no vision)
- Each polling place will offer at least one type of accessible voting equipment or Direct Record Electronic ("DRE") device. This equipment allows voters with disabilities to vote directly on the system or assist them in marking the paper ballot. Depending on the type of system, voters with disabilities may use headphones or other assistive devices to help them vote independently and secretly.

TIP FOR VOTER WITH DISABILITY: If you plan to go alone to vote curbside, it is wise to call ahead so election officials will expect you. Generally speaking, you may vote curbside during the early voting period (the 17th day before Election Day until the 4th day before Election Day) or on Election Day. For a May uniform election date or resulting runoff election, the early voting period is the 12th day before Election Day until the 4th day before Election Day.
