Photo ID Requirement

People voting in person must present a form of photo ID or alternative approved by the state or else may only vote provisionally. For more information and exceptions see DallasCountyVotes.org or call 214.819.6300.

Eligibility for Voting

You must be a citizen of the United State, registered to vote in the county of your residence 30 days prior to election day, and must be at least 18 years old on election day. You cannot vote if you have been declared by a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote or are a convicted felon who has not completed your sentence, probation and/or parole.

HIGHLAND PARK ISD TRUSTEE ELECTION

School trustees make all final decisions regarding school district priorities, policies, personnel, textbooks, expenditures, and growth management. Trustees adopt a budget which is necessary to maintain and operate the schools, levy taxes to support the budget, and submit bond issues to the citizens of the District to finance construction projects.

Elections are conducted annually in May. Trustees serve for a 3 year term but receive no compensation. While candidates run for specific places, they do not represent specific geographical areas. Whichever candidate receives the most votes wins. There are no runoff elections.

EXPERIENCE: I have been an educator for 25 years and have had experience building schools, developing programs, and been a part of the various school and college organizations such as the SACS accreditation, member of the Texas Teacher's Association, and contributed to discussions on the Texas Core Curriculum initiative. I am also a parent of an HPHS student and a member of this community. I work for the state and am passionate about learning. I will be an added value to HPISD School board bringing a fresh perspective to the issues that are important to HPISD through my career and experience.

RENOVATION VS NEW CONSTRUCTION: Upgrading our school facilities is always a good idea, especially since it helps provide more innovative and creative spaces for our children to learn and grow. In choosing a better method of upgrading school facilities. I think it should obvious that the best method would be to focus on what that would facilitate learning. Preserving some symbolically significant features to allude to HPISD's great, historical past and beginnings is certainly good for the morale of the community. Some parts of this redo requires rebuilding as salvaging the old does not allow for more modern spaces that are conducive to learning.

MIDDLE SCHOOL CONSTRUCTION: I would certainly like to see more rigorous scheduling of traffic interferences during high traffic hours and areas. This might be beneficial to the community, especially those who are directly affected by these construction sites. We should also have more permanent alternative routes published for the community, so we are not surprised every time the streets are blocked. Better oversight of environmental impact on the community closer to the construction sites should also be considered and implemented. I would certainly like to see better safety measures taken into consideration as well.

FISCAL OVERSIGHT: We need to find ways to fund new initiatives and programs that would improve student learning and better prepare our children with 21st-century skills. I would support encouraging and incentivizing instructional and administrative groups who are willing to explore innovative programs to compete with existing programs for funding. We should have a budgeting policy that is outcome-based, instead of categorical based--a budget that supports resource allocation to improving student achievement by establishing a preference for more high impact, innovative programs.

OTHER ISSUES: Providing our students with a broader and more competitive educational experience should be our priority. Our graduation rates in the district are fantastic. We need to be as competitive with the other up and coming public schools in North Texas. Some school districts in North Texas have used the District of Innovation plan to start Collegiate academies and other programs for their students. Some of their students are graduating with Associate Degrees before their high school graduation. I would like for all HPISD students to have equitable opportunities.

EXPERIENCE: I have served HPISD in dozens of leadership and volunteer roles, including 17 years of service on the Boards of Directors of the Education Foundation and Alumni Association, as a parent representative on multiple Teacher/Administrator/Parent working committees, and as HPHS Student Body President. A licensed Texas attorney since 1999, I have the experience and judgment to effectively collaborate with community members, strategically analyze issues, and implement innovative solutions. And, as a former HPHS classroom teacher, I understand the type of support teachers need to provide the best education for our children.

RENOVATION VS NEW CONSTRUCTION: As an HPISD Trustee, my primary goal for all projects, programs, and decisions will be to exercise fiscal conservatism and scrutinize all expenditures to eliminate wasteful spending and ensure that all money spent furthers HPISD's primary mission of providing excellent education for every student. The decision to build four new elementary schools and renovate three buildings was made before I entered the 2019 election for HPISD school board, but when making future decisions about potential construction, I will always weigh the costs against the long-term benefits to identify the best long-term solutions for HPISD.

MIDDLE SCHOOL CONSTRUCTION: The middle school is the most complicated campus to redevelop because it (1) must remain fully operational, (2) is landlocked, (3) lacks adequate thoroughfares and parking, and (4) sits in one of our community's most densely populated areas. Because there is no way to avoid all inconvenience with construction projects of this magnitude, HPISD must provide open and frequent communication so that area residents know what to expect and can plan for it. I would support the creation of a community committee to meet regularly to allow affected residents to communicate their complaints and share their recommendations.

FISCAL OVERSIGHT: As a result of the state recapturing local school property taxes for statewide redistribution, HPISD is forced to rely on millions of dollars of generous donations, raised by heroic volunteers, to balance its annual budget and pay its teachers. Facing dire funding challenges, School Board Trustees must exercise fiscal conservatism to maximize the educational benefits of each dollar spent by HPISD. I will scrutinize, in detail, the annual budgets proposed by the Superintendent, and I will oppose any proposed expenditures that do not further the district's primary goal of providing excellent education for every student.

OTHER ISSUES: HPISD struggles to hire and retain teachers who are offered higher-paying employment by other school districts near their homes and by private businesses. In order to better compete for the most excellent teachers in North Texas, HPISD leadership must prioritize financial responsibility above all other goals, monitor and influence our state legislators to ensure that they advocate for the financial needs of HPISD, and work toward greater transparency and cooperation among our community's fundraising groups, volunteers, and generous private donors to ensure that we all work together to optimize the benefit for HPISD.

DALLAS COUNTY COMMUNITY COLLEGE DISTRICT SPECIAL BOND ELECTION

PROPOSITION A

Shall the Board of Trustees of Dallas County Community College District (the "District"), be authorized to issue and sell the bonds and notes of the District as authorized by law at the time of issuance thereof, in the aggregate principal amount of \$1,102,000,000, for the purpose of constructing, improving, renovating and equipping school buildings of the District and acquiring real property therefor; with said bonds or notes to be issued in one or more series or issues, to mature serially or otherwise not to exceed 40 years from their date and bear interest at such rate or rates, not to exceed the respective limits prescribed by law at the time of issuance, and to be sold at such price or prices, as the Board of Trustees in its discretion shall determine; and shall there be levied and pledged, assessed and collected annually Ad Valorem taxes on all taxable property in the District in an amount sufficient, within the limits prescribed by law, to pay the annual interest on said bonds and notes and the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with said bonds and notes; with said bonds and notes to be issued and said taxes to be levied, pledged, assessed, and collected under the Constitution and laws of the state of Texas, including the Texas Education Code.

Explanation

The Dallas County College District ("DCCCD" or the "District") operates the 7 community colleges in Dallas County. The District currently serves 80,000 credit students and 20,000 continuing education (non-credit) students. In the next 11 years, the District expects the number of credit students will increase by 12,000. The \$1.1 billion bond issue will be used to expand the District's resources to enhance the educational experience and meet the expanding student population.

The 7 Dallas County community colleges have served over 3 million people since their inception in 1965. One of the largest community college systems in Texas, these colleges offer over 300 associate degree and career technical certifications. These colleges have been an instrumental contributor to the vibrant economic success of Dallas County.

The general obligation bonds will be sold over 6 years and under current conditions, will not increase property taxes. The District's last bond issue was 15 years ago and will be fully repaid in the next few years. The District's past performance on its prior bond issues is part of what makes it a good credit risk for this issuance.

The money from the bond issue will be used for 3 distinct initiatives: (1) Expand industry aligned workforce programs (\$235 million) – to train student to work in industries with high demand for jobs in the near future (health, IT, construction, advanced manufacturing); (2) Expand student instructional programs (\$332 million) – to expand the programs which permit high school students to take college courses and enhance student learning through technology and instructional innovation; and (3) Build a new Education and Innovation Hub in downtown Dallas (\$535 million) – would completely redesign the El Centro College campus and include a new Business Training Center to facilitate innovation and technology adaption in coordination with businesses in North Texas.

Reasons to Vote For

- 1. Expands the resources of the Dallas County Community colleges to meet the growing student population.
- 2. Maintains the current property tax rate; no increase in property taxes under current conditions.
- 3. Increases the instructional innovation to enhance student learning with new instructional tools, technology and modern student learning space.
- 4. Provides a center for industry aligned education and training programs to enable students to meet the changing needs of the workforce in North Texas.

Reasons to Vote Against

- 1. There is no increase in the current tax rate only if current conditions remain the same. If the cost of borrowing under the bond issue increases, either the tax rate might need to increase or the scope of the proposed bond package might need to be curtailed.
- 2. If the bond issue does not pass, to maintain operations, the District could meet increasing needs by increasing tuition and/or raising taxes without incurring debt
- 3. The District has been performing well and should continue to do so without the additional debt. There's no pressing need to incur debt to maintain operations.
- 4. Many feel property taxes are too high. If this item does not pass, the District could potentially reduce its tax rate giving relief to homeowners.
