#### **NOVEMBER ELECTION**

November's election is shaping up to be one of the most important of our lifetime based on the issues at stake. The schedule for Dallas County voters is as follows:

Friday, Oct 26 Last Day to Apply for a Ballot by Mail

Monday, Oct 22 Start of Early Voting Friday, Nov 2 Last Day of Early Voting

Tuesday, Nov 6 **Election Day** 

Find your most convenient early voting location at <a href="https://www.dallascountyvotes.org/upcoming-election-">www.dallascountyvotes.org/upcoming-election-</a> information/ or call 214.819.6300 or 214.688.4125.

In addition to Democratic and Republican candidates nominated in this spring's primaries, several Libertarian candidates will be on the ballot (County Judge, County Commissioner Pct 2) and three write-in candidates have been approved (US Congress District 5, Texas State Rep District 109, and District Judge 203<sup>rd</sup> Judicial District).

LWV Dallas's www.Vote411.org was loaded the first of October and is available. Spanish language translations of legislative candidate responses are provided. The printed Voters Guide is available in libraries, schools and other locations now.





#### ADVOCACY

Secure Voting In Dallas County - Dallas County's computerized registration and election systems should be up-to-date, efficient and secure. The equipment currently in use is aging so the county is looking to replace it in the near future. The need for secure election hardware. software and processes is highlighted by reports of election hacking attempts and the simple mischief of computer identity theft we all struggle with.

It is of supreme importance that the systems that make our democracy work not only be secure and accurate but that they facilitate the process for voters rather than bog it down.

We can help Dallas County by voicing our support for secure and efficient systems to elected officials and writing letters to the editor. There will not be any federal support for election systems coming to Dallas County as there was during the last major election system changeout, so local or state funds must be raised. It will be an expensive endeavor.

Let your officials know that you want them to do what's necessary. Now is the time to voice your opinion if you care about the quality of these systems going forward.

## Excerpt from 9/25/2018 Press Release

Most though not all LWV Dallas voter outreach activities this year have focused on new young voters. To prepare voters for the fall election, from mid August through late September LWV Dallas volunteers have:

- 1. Registered 1,300 voters, nearly all students, at 70 events,
- 2. Made presentations to students in 25 classrooms, and
- 3. Conducted 6 sessions for groups of educators on teaching young people about the political process and motivating them to participate. These activities are scheduled to continue through October 31.

In addition, for the remaining weeks before the election, LWV Dallas volunteers have:

- 1. Activated <a href="https://www.Vote411.org">www.Vote411.org</a>, a comprehensive online Voters Guide, during the first week of October.
- 2. Printed and distributed between 10,000 and 20,000 comprehensive paper Dallas County Voters Guides before the start of early voting in libraries, schools and neighborhoods around the county.
- 3. Cohosted public candidate forums with the North Dallas Chamber of Commerce: Details can be found on the LWVD website and facebook.

New this season is a series of lessons for classrooms called Be A Texas Voter. The series was co-produced by the LWV Texas and the Dallas County Community College District. It is all online (<a href="www.beatexasvoter.org">www.beatexasvoter.org</a>), free and designed to both educate and motivate young people. We are promoting this series to high school and community college teachers.

The LWV Dallas is riding the crest of enthusiasm generated by the November election but believes that true civic engagement requires not a seasonal effort but ongoing commitment to our form of participatory government. Consequently, our efforts to educate and inform will not cease after November 6 but will continue until every single eligible person is educated, registered and voting.



#### PROGRAM & EDUCATION

#### **LWVD UNIT MEETINGS**

In September we discussed Misinformation and Social Media. We enjoyed viewing one of the "Be A Texas Voter" videos and discussing the curriculum that has been developed for it. The "Be A Texas Voter" video series was created by our own Elizabeth Walley in partnership with the La Croy Center of the Dallas County Community College District.

We also viewed another video on how sophisticated video manipulation has become. Thanks to member, Katherine Homan, for sharing it!

Also, a chart by MediaBiasChart.com which shows many of the popular news organizations and websites on two spectrums was shared, one of partisan bias from "very liberal to very conservative" and another ranging from "original fact reporting" to "Contains Inaccurate/Fabricated Info". Also discussed were an article from the March 8, 2018, issue of The Atlantic titled "The Grim Conclusions of the Largest-Ever Study of Fake News" and

another article from the September 5, 2018, New York Times "Can You Spot the Deceptive Facebook Posts?". If you missed the September unit meeting you can find information about it on our website.

3rd Quarter Voter

In October we will discuss Property Taxes. This is a huge and highly contentious subject. The content isn't fully developed as of this writing, but one tool we will discuss is on the website TXSmartSchools.org. It is a powerful way to become informed on how your school district is doing in comparison to other similar school districts in Texas.

November units will review our position on the environment, get a recycling update, and review our position and some Facts and Issues on affordable housing and gentrification. (The Nov. 8 general meeting will be on affordable housing.) Typically, the unit meetings are on the second Wednesday and Thursday of the month. So, in November the unit meetings are on November 8th and 14th.

The NOVEMBER UNIT MEETINGS will be a Recycling/Environment Update and reviewing our position on Affordable Housing and Gentrification. Please note the dates of the November Unit Meetings.

In December the units will conduct the first step of Program Planning and celebrate the holidays. Program Planning is the greenest part of the grass-roots foundation for the League of Women Voters. This is when our members tell us what they want to learn more about. The issues are collated and presented at the annual meeting for member approval. There are many ways to address the issues. First, a committee compares the requested issues with our positions to see if they are adequate for advocacy and, if so, they become the content for the next year's September-May unit meetings and general programs. At times

our local positions are not adequate for advocacy on a specific issue and a study may be recommended. Sometimes the issue is related to state or national law; and, if so, the issue is sent to them for consideration.

This process is a primary way the League remains relevant and fulfills its vision of building participation in the democratic process; studying community issues in an unbiased manner; and enabling people to seek positive solutions to public policy issues through education and conflict management.

## PROGRAM & EDUCATION

#### **AUGUST 30, 2018, EDUCATION GENERAL PROGRAM REPORT**

The first general program for this year was titled "Does Current State and Local Funding Provide for a Quality Education?". Please go to our website to view videos of both the lunch and evening programs, a PowerPoint by Dr. Lori Taylor, handouts, links, and questions and answers our panelists graciously addressed after the events because we ran out of time to field all questions.

The education issue committee assembled a panel of experts who helped us understand multiple sides of the issue and some unintended consequences of the state funding formulas. Their hard work bore great fruit in this program. Please share the links for this with your friends.

View the material in relation to the LWV Texas position and ask your Texas elected officials to get back to historical levels of funding. Here is the funding portion of the position:

"The League of Women Voters of Texas supports a school finance system that would provide taxpayer equity and an equitable distribution of funds to ensure that all Texas school children receive a high quality education.

Specific measures that we support include:

- a sufficient level of state support to Texas public schools to ensure that all Texas school children receive a high quality education;
- a guaranteed tax base yield approach for part of the local enrichment, to
  mitigate spending disparities resulting from differences in wealth among
  school districts in Texas; however, the League believes some unequalized
  local enrichment should be allowed within a substantially equalized system;
- equalized state assistance to districts for essential capital outlays;
- taxpayer equity in the form of state equalization aid to local districts allotted in direct proportion to local tax effort;
- state established minimum local expenditure levels with joint state-local financing (known as the foundation school approach) that includes:
  - adequate salaries to attract and retain qualified teachers and/or teaching personnel;
  - adequate funding of the basic allotment, which provides for operations and programs for special categories of students, specifically vocational education, compensatory education, special education, kindergarten, and gifted and talented; and
  - maintenance of a weighted approach to distribution of state school finance money to meet individual student needs."

Eleanor Sutherland has been a member of the League of Women Voters of Dallas since 1966. During her 52 years with the League she has done it all and has no regrets. She moved to Dallas from Peoria, Illinois. Soon after, she attended a volunteer recruitment event where the League had a signup table. Eleanor thought joining would be a good way to meet friends in a new city. She joined and in fact cultivated long-time friendships that she treasures to this day.

Eleanor was President of the LWVD from 1975-77, she was an active member of the Awards Committee, and she also served as the League's office manager. More recently, she was the Editor of our VOTER Newsletter. She left her position on the Board as VOTER Editor one year ago at the ripe age of 97. During one of the Board meetings when the upcoming 100th birthday of the League in 2020 was being discussed, she promptly reminded us that it will be her 100th birthday also!

Eleanor attended the Women's Equality Day celebration in August where she was recognized as the oldest attendee and received a proclamation and a paperweight. Mayor Mike Rawlings could not believe she was born in 1920, the same year the 19<sup>th</sup> Amendment giving women the right to vote was passed!

When asked what she considers her best experience in the League, Eleanor said she vividly recalls Dottie Box standing up at Annual Meeting and saying that "we ought to study how our city of Dallas looks." This led to the study and recommendations on Urban Planning that still remain as local League positions, a task that she enjoyed very much.

Eleanor recalls fondly that she married her childhood friend. She has a devoted son, Derek.



I asked Eleanor how she would finish the sentence "I Wish the League Would ...".

In her inimitable humorous style she said, "Would've, could've, should've! Let's plan on the future, the past is gone, I've done it all with no regrets."

# In Memoriam ~ Dorothy (Dottie) Baldwin Box ~

November 17, 1924 - August 14, 2018

I had the distinct pleasure of meeting Dottie for an interview in March to learn about her life and her experiences with the Dallas League. Dottie Box joined the LWVD in 1950, making her a 68-year member of the League! She was born and raised in Dallas, but her love for the theater brought her to New York City where she worked as a drafting designer. She resided at the Bristol Hotel in the Rockefeller Center area described as "a happening place" in those days. She and a friend attended opening days fanfare for many Broadway plays (the actual performances were for the very elite), and they were able to meet many of the performers. But her love was in Dallas where she came back to marry her longtime friend.

Dorothy served as Chair of the Membership Committee and was a very active volunteer for one of the Units. She was credited with boosting attendance at meetings and membership in the League. Her creativity showed when she gathered enough green stamps to buy a coffee machine for the meetings. Dottie said that she believed in the power of a personal touch to keep members engaged. Dottie was always willing to lend a

helping hand in any way that was needed. At many meetings she was a one-person welcoming committee.

She received the President's Meritorious award from Katherine Homan in 2006 for her "devoted service to the LWVD that was above and beyond the norm, over a period of years." That is a very accurate description



of the person Dottie was in the League. Katherine said that Dottie was creative, had great initiative and a sparkling personality.

She was not a person to drop names, however, she mentioned to me that Sarah Weddington was a good friend who stayed with her while she was in Dallas doing research in preparation for the *Roe v. Wade* case.

Dottie had two sons and three grandchildren.

Barbara Turner, 83 years, died surrounded by her family, October 6, 2018 in Dallas. She was always willing to volunteer and lend a helping hand.

## ~ Women's Rights Activist, Virginia (Ginny) Whitehill ~ July 9, 1928 – September 15, 2018

Virginia Whitehill joined the League of Women Voters of Dallas (LWVD) soon after she and her late husband James moved from New York. She was a 55-year member of the League and an ardent supporter of the Equal Rights Amendment, a subject dear to the heart of her mother Myrtle Bales Bulkley. The LWVD established the Myrtle Bales Bulkley Award in 1989 to "recognize a member's many years of exceptional service to the LWVD and to the community." Virginia was given the award in 1998.

Virginia, "Ginny", was a tireless reproductive rights activist. After the 1973 landmark Roe vs. Wade decision she figured the war was won. She was at the Supreme Court when the oral arguments were presented ahead of the 7-2 ruling that secured the legal right to abortion. But, Whitehill quickly realized activism was like tending a garden, said close friend Gail Griswold of Dallas. Even though the Supreme Court's decision was a major victory for abortion rights, Whitehill learned she would have to keep fighting for them for the rest of her life.

"Ginny came from a line of strong women, and I think her mother also had a big personality and a lot of conviction. Whitehill considered birth control as vital to women as the right to vote, and she devoted hours volunteering with Planned Parenthood to help educate others", Griswold said.

"Whitehill was 'indefatigable' in her belief that if women didn't have freedom of choice in their reproduction, there could never be gender equality", said friend Cecilia Boone of Dallas.

"Whitehill was quick-witted and polished, 'a marvelous conversationalist,' who knew many people and delighted in connecting them with one another", Boone said. Whitehill was known to stuff her purse full of brochures for events and organizations around North Texas so she could share them with others and encourage them to get involved.

"Although I was star-struck by Ginny, she always found ways to make me feel like a shining star instead. That was her gift, reminding us the importance not of what she thought and did, but of what we thought and did", said Katherine Homan of Dallas.

"Ginny was a force of nature! When she saw a need, especially a need to help advance women. she



organized, recruited, inspired, and insisted until that need was met. That is her legacy to us: Commitment to good causes, energy and ongoing effort", said Becky Sykes of Dallas.

Virginia not only spoke about the injustices against women in her days, but she did something about it. She was a co-founder of the Dallas Women's Coalition, Women's Issues Network, Dallas Women's Foundation, Women's Southwest Federal Credit Union, Dallas Women's Political Caucus, Veteran Feminist of America (Dallas) and the Women's Equality Action League. She promoted women's issues and was a supporter of The Women's Museum: An Institute for the Future.

Whitehill was honored with such awards as Profiles in Leadership from Southern Methodist University Women's Symposium, Planned Parenthood's Champion of Choice Award, the Women's Council of Dallas County Distinguished Service Award and the Women Helping Women Maura Award of the Women's Center of Dallas. She was named a Mount Holyoke College Distinguished Alumna, and received the Texas Women of Courage Award from the Association of Women Journalists. She was named a Woman of the Century by the Texas Women's Chamber of Congress in 2000.

*Virginia Whitehill,* In Memoriam *continued...* In 2014, Whitehill was interviewed for a documentary about women's rights, *She's Beautiful When She's Angry,* about the birth of the women's liberation movement in the 1960's.

Virginia instilled the spirit of volunteerism in her two daughters. Patty Whitehill, who lives in Florida, described her mother as a "white-gloved feminist activist." She and Margaret Whitehill-Boynton of Georgia, stood by their mother's side in her final days. Brandi Andrade, who appeared as Susan B. Anthony at LWVD luncheons, said to Katherine Homan: "Ginny was such a marvelous woman--a boon to our city, and to me personally, as I know she was for countless others. So many good things happened in my life as a result of knowing her--including getting to know you. May we all grow up to be like Ginny."


