HIGHLIGHTS FROM 81ST ANNUAL MEETING MAY 4, 2019

Budget – Approved to maintain the membership dues at \$75 for an individual. Staff time was reduced to 20 hours per week in order to avoid withdrawals from reserves. Staff salary was the largest expense for the League.

Bylaws – Proposed bylaws amendments were approved with the exception of the Quorum which was changed to "Ten percent of the voting members present shall constitute a quorum at the annual meeting of the membership."

Pat Vaughan Legacy Fund – Approved the proposal to establish a dedicated fund for voter education, outreach and services in honor of Pat Vaughan, a Past President who passed away in January 2019.

Voter Outreach Report – Elizabeth Walley and her team had an outstanding year. Their accomplishments are listed on pages 37-42 of the Workbook.

Nominating Committee Report – The proposed slate of Board of Directors was approved as presented. The new President is Diane Tasian. Her team is listed on page 22 of the Workbook.

VOTING MATTERS

A signature accomplishment of the League of Women Voters (LWVUS) is the Voters Guide. The League increased its relevance by giving it a digital presence, VOTE411, in 2006. Using VOTE411.org you can view information for your ballot without wading through races or propositions you can't vote on. You will find candidate responses and Pro/Con statements on bonds and propositions on YOUR ballot, plus so much other information related to voting. And the League is continuing to develop the platform to serve as a digital YEO (Your Elected Official) – which is still in development.



Did you know that for the May 2019 elections LWV volunteers, under Dorie Cranshaw's leadership, covered 234 candidates in 103 races; or every race in every city in Dallas County using 2 Trail Bosses and 26 Wranglers for city races in Addison, Balch Springs, Farmers Branch, Hutchins, Richardson, Rowlett, Seagoville, and Wilmer; for city and ISD races in Cedar Hill, Dallas, De Soto, Duncanville, Garland, Grand Prairie, Irving, Lancaster, and Sunnyvale; and for Highland Park ISD.

We also covered the DCCCD bond issue with Pros; Cons; charter amendments; and propositions. Some of the questions and answers were in English and Spanish.

Thank you, Dorie! We hope to build on your success.

DEVELOMENT NEWS

As we approach the 100th anniversary of the League of Women Voters, we have so much to celebrate. More women than ever are running for office. Congress and state legislatures have more women representatives and senators. Our judicial branch at all levels has many women serving as judges.

We know we are doing something good when the young people registered by the League showed up to vote at twice the rate of their cohorts who registered without the League's help. We know we're Making Democracy Work when people say they couldn't vote without the *Voters Guide* or VOTE411.org.

So what's missing from this picture? There are many women who don't know the story of women's suffrage, don't know about the imprisonment of those suffragists who picketed the White House. They may think it doesn't matter if they don't vote. But you and I know it does matter. Every person has a voice, and it is heard in the vote. Even if you vote for the losing candidate, it matters because people notice who got the votes and where those votes came from.

The League runs on volunteer power, but we also need a paid staff person, office space, supplies and equipment in addition to funds to print the *Voters Guide* and have it translated ino Spanish in order to be able to serve the community. Our reputation depends, in part, on our competency; and to be competent, we have to have knowledgeable staff and reliable equipment. At this point in time, the League, as a three-tiered, federalized organization, cannot operate as an all-volunteer organization. It needs the continuity of paid staff to get the job done.

Women's perspective is needed in the political realm. Women pay attention to different things when they vote. They notice education and health care policies, policies that affect children such as child care and air quality. The League needs to be a strong, vibrant organization in order to encourage women to vote and run for office.

Over the next few months and years, you will likely receive a number of solicitations to celebrate the 100th anniversary of women's right to vote. The League of Women Voters is the only organization that worked on women's suffrage 100 years ago and is still in existence because we still have a job to do. As Archibald MacLeish said, "Democracy is never a thing done. Democracy is always something a nation must be doing."

As we look ahead to the next 100 years, let us keep in mind that we as a nation must still be doing Democracy. And the League is the most trusted nonpartisan source of policy positions and unadulterated information on the candidates. Please plan your philanthropic giving to include the League so we can be here the next 100 years.

50-YEAR MEMBER SPOTLIGHT

LONG-TIME MEMBERS SPOTLIGHT: Barbara Weinstein



Barbara Weinstein has been a member for 55 years volunteering in a record five Leagues! She started in Syracuse in 1964, then Minnesota, Philadelphia, Fairfax, and Dallas. She recalls driving a small trailer that was used to go around registering voters. When attending the National Convention in DC, she and other Leaguers realized that some of the ladies were busy lobbying on the Hill and did not have a chance to eat. Commandeering what may have been the "original food truck" in those days, they brought food to the busy Leaguers. Barbara's experience in five Leagues brings a unique perspective to the way the Leagues worked. is grateful to the Leagues who provided a forum for discussing pertinent issues affecting their communities and giving their members a voice.

She and her husband arrived in Dallas in 1982. She immediately sought the Dallas League. As with all the other Leagues she volunteered with she was eager to provide her expertise about Voter Services, issue studies and fundraising. Barbara served as President of the Dallas League from 1991 to 1993. She said she is most proud about working with women. She said the League provided them with experiences not available to them then and now and were encouraged to speak up. And she did speak up!

After stepping down as President, she served on the State Board for 11 years. Her high point came from working with LWV Texas on passing a Constitutional Amendment in 2007: Proposition 11, a Public Record of Votes. It took two Legislative Sessions to pass. The ballot proposal read: "The constitutional amendment to require that a record vote be taken by a house of the legislature on final passage of any bill, other than certain local bills, of a resolution proposing or ratifying constitutional amendment, or of any other non-ceremonial resolution, and to provide for public access on the Internet to those recorded votes." Citizens could now go to the Internet to see how their elected official voted. Barbara said that it was a thrill to see their work on a statewide ballot passed.

More recently, Barbara and Bessie Weed (now deceased) saw a need for women to gather regularly to hear and discuss issues in the North Dallas area. They formed the Far North Dallas Unit, which to this day remains the largest, most active Unit in the League. This year, three of its members were appointed to the Dallas League Board of Directors.

Barbara and her husband, whom she met while attending Michigan State, have been married for 66 blissful years. They have a daughter, two sons and five grandchildren.

"Barbara was the consummate example of a valued state board member. When I went on the State Board and served on the Development and Marketing committee, the common wisdom was that we had to meet with Barbara to learn the best way to do things. Even when I became the Vice President over this committee, Barbara was a valued advisor."

Annie Jones is so passionate about disability rights, she chained herself to a Greyhound bus

Annie Jones just wanted a nice dinner at the Spaghetti Warehouse. But she wasn't about to relegate herself to the back entrance, where the restaurant's only wheelchair ramp was located. Instead, she and her friends sat outside the downtown eatery in their wheelchairs in front of folding tables, complete with a candle in the center. After their nondisabled friends went inside and ordered takeout, they ate their pasta outside in front of onlookers and police officers.

The protest worked. A few weeks later, the Spaghetti Warehouse installed a wheelchair ramp at the front entrance thanks to supporters like Jones who fight for greater access for people with disabilities.

Jones, an 84-year-old resident at Juliette Fowler Communities, has been a fierce advocate for the disabled community since arriving in Dallas in 1971. As a doctorate student at the University of North Texas, she had hoped to become a professor. But those plans were dashed when she was hit in the back by a basketball while walking her dog. The impact shattered her back and reinjured her spinal cord. She was in a wheelchair at 36 years old and would never work again.

She led her first demonstration in 1988 to protest the lack of accessibility on public transportation. After negotiations for greater access on Greyhound buses failed, Jones and other ADAPT members chained themselves to the front of the vehicles. They weren't up there long before police came to remove them. Jones and her friends refused to hand over the key, so officers cut the thick, heavy chains with a saw. Authorities encountered another challenge when their van broke down. They had to transport the protesters to the county jail in, ironically, a DART bus. Jones spent 10 hours in jail and was given a \$120 fine for public disturbance.

"I wish I could be sorry, but I'm not. I hope you don't evict me," Jones told Juliette Fowler administrators after her arrest.

She didn't get evicted, and she didn't let the arrest end her advocacy. Next, Jones pushed for more curb cutouts on city sidewalks and helped start DART's Paratransit Service. The service specifically serves the elderly and riders with disabilities who are unable to use fixed-route buses and trains.

Her work caught the attention of My Ride Dallas, a program that helps people with disabilities understand their transportation options. In 2013, the organization named its most prestigious award in her honor. The Annie Jones Driver Excellence Award celebrates drivers who go above and beyond to make riders feel safe, comfortable and valued.

It was embarrassing, however, that nothing in the published bio or comments at the annual meeting indicated any work on behalf of the Dallas League. Lest members think that their honors go to people who work on behalf of other Leagues only, there's much more to the story. Working on behalf of the state League has taken so much time and energy that there wasn't much left over in recent years to participate in my home League's activities, therefore much of what there is to share is old news. But here it is:

I was the LWVD treasurer for six years, and unit leader of the Evening Unit for two. Elizabeth Walley and I worked together on securing a grant from the Dallas Women's Foundation to try to increase election participation of Hispanic voters, and then held classes in how voting works. I introduced LWVD to the Communities Foundation's Giving Tuesday, which continues to bring in more money under its current stewardship. Supervising money collection at SBA and chairing the Budget Committee were two of the easier jobs. Other projects included chairing the Local Arrangements Committee for the LWVUS convention that was held here in Dallas, as well as a region-wide forum on whether water should be treated as a commodity. Each of these projects was a marvelous opportunity to meet community leaders and make connections with other organizations.

Best of all, though, was working with my fellow Leaguers. I am awed to be among you. You are such hard-working, committed volunteers, and such accomplished people, willing to further worthy projects with your efforts. Thank you all for your help, your support and your commitment to our community.
