### Regional Measure 3 on June Ballot

RM3 on the June ballot increases the tolls on the seven state-owned bridges in the Bay Area by up to \$1 in January 2019, \$1 in 2012, and \$1 in 2025. Drivers who cross two bridges during commute hours will get a 50% discount on the toll increase on the second bridge. The Golden Gate Bridge is not state-owned, so is not affected by RM3. The revenue will be used for transportation improvements in the nine-county Bay Area. About 69% of the \$4.5 billion spending plan will go to transit improvements and 31% to highway projects.

Sonoma County residents are expected to pay about 2% of the increased tolls. Items that benefit Sonoma County in the spending plan include \$40 million toward extending **SMART** Healdsburg, \$120 million to widen Highway 101 between Petaluma Blvd. South and Novato, \$100 million to begin environmental and design studies for Highway 37 widening, and \$100 million for North Bay transit access improvements. There are also many projects in neighboring counties that will benefit Sonoma County Residents. Therefore, the LWVSC can also support RM3.

#### **Does My Vote Make Any Difference?**

Do you ever feel your vote really doesn't matter? A lot of our citizens appear to be skipping voting. Only about 60% of registered voters in California voted in the last election.

Each vote does matter!

Below are some examples of decisions that changed history and were determined by just one vote:

- 1800: 1 VOTE made Thomas Jefferson president instead of Aaron Burr
- 1850: 1 VOTE admitted California and Oregon into the United States
- 1868: 1 VOTE saved President Andrew Johnson from Impeachment
- 1876: 1 VOTE made Rutherford B. Hayes a United States President and 1 VOTE elected the Indiana Electoral College member who voted for Hayes
- 1910: 1 VOTE decided the Congressional election in New York.

- 1920: 1 VOTE in the Tennessee legislature ratified the 19<sup>th</sup> amendment and gave women the right to vote.
- 1941: 1 VOTE kept the military draft operational just weeks before Pearl Harbor

## **Busy Times for Voter Service**

A core value of the League of Women Voters is an informed electorate. That's why we feel so strongly about providing forums on the candidates, as well as ballot measures. The sheriff's race was important this year because it is the first time since in 25 years that we have the opportunity to vote for the office. In the past, the sheriff has retired early and the person who has taken his place, got the job. We held two forums - both in the unincorporated areas - Graton and Sonoma since the sheriff plays a huge role in the security of those areas of the county.

We also held a forum for the position of Clerk, Recorder, Assessor, Registrar of Voters as the League feels this position is crucial to ensuring honest and fair elections. With the political pressure from the White House about illegal voting, this position is vital in Sonoma County.

Finally, on May 16th, the League will present the Pros and Cons forum which looks at the positive and negative aspects of each of the ballot measures. We also discuss who is backing each measure and how it is financed. This event will be held at the Rincon Valley Library from 7-8 pm. There are five state measures, four local measures and one regional measure on transportation.

## Students Use League's Homeless/Affordable Housing Report

On Thurs., April 19th the students at Northwest Prep Charter School did a community presentation on Homelessness in Sonoma County where they answered their driving question: "Who are the homeless, how did they get there, and how can we help those in Sonoma County?" This presentation was the culmination of a semester long project, and began with a rapid fire 15 minute student presentation of facts about homelessness. After a brief presentation by Becky Margiotta, former director of the 100,000 Homes Campaign, on how they housed 100,000 low income people in New York, the students and audience moved out to the courtyard to see the various information booths set up by the students where they shared preliminary ideas on how to prevent homelessness. Our local League's report on Homelessness/Affordable Housing was a resource document used by many of the students in developing their presentations. # Member Profile Donna Roper Voter Service Chair



Donna Roper, the busy Chair of the League's Voter Services Committee, has had at the center of her professional and volunteer life education and service to others. Her involvement in social justice issues began In high school. After leaving the Boston area, where she grew up with three sisters, she traveled to San Francisco to continue her education in psychology at San Francisco State University. With a degree in hand, she began a career with the YMCA that lasted 25 years. While at the Y, She earned a master's degree in education that led to her setting up childcare centers and other educational programs in San Francisco.

Continuing her ability to select wonderful parts of the west to work and live, Donna transferred to the YMCA of Honolulu. After four years, In 2002, she returned to the mainland and settled in Sonoma County,

where she lives in a weekend home she had purchased years before.

In Sonoma County she began working at the Volunteer Center', Camp Okizu, a camp for children with cancer, and finally the River to Coast Children's Services (RCCS). Donna continues to work part time for the RCCS, a social service organization, which provides services for young families, importantly including subsidized child care for low income children.

Donna calls herself a professional volunteer. Currently, she is in the local Rotary Club, President of the Board for Stewards of the Coast and Redwoods, and works as the de facto librarian at the Guerneville school. Her focus has been on the west county where she believes there are a lot of needs and not enough resources.

When not volunteering and serving others, Donna loves to travel. Each year she drives from California to Prince Edward Island, Canada, camping along the way and visiting friends. When at home she loves to garden and is in two book clubs.

Donna initially got involved with the League by helping to distribute voter registration cards in western Sonoma County and then becoming a moderator for some of the candidate forums. Now she is the League's Voter Services Chair, organizing candidate forums for the 2018 local elections. The League is fortunate to have someone in this position who is so committed to education, including the education of voters. We are also fortunate that Donna has an abundance of energy.

#### **Board Briefs**

From April 3, 2018

The meeting was called to order at 10:00 am with Rebecca Jones presiding. A quorum was established with seven Officers/Directors attending, three absent, and two non-board members present.

- ✓ Agenda and minutes of March 6 approved.
- ✓ Finances were reviewed. Budget inputs were requested for a committee meeting on April 18. Rebecca Jones and Gayle Peterson will attend the CA convention and be reimbursed to the extent agreed in the budget.
- ✓ Susan Novak provided a list of officer nominees for 2018-2019. Work will continue to complete nominations. Officers are voted in at the annual meeting.
- ✓ Rebecca will do an interview with Elaine Holtz on KBBF and highlight League events.
- ✓ Rebecca and Nancy Burrington met and reviewed our Positions and Policies and Minor changes were Procedures. reviewed, approved and changes to Positions will be presented to the membership for approval at the annual meeting. Discussion on whether roster updates should be sent to all members revealed the fact that the number of members clicking through to view The Voter is shockingly low. Suggestions for how to get feedback on The Voter will be taken up when there is more time. Copies of the updated Positions and Policies will be posted to the website.
- ✓ Rebecca expressed concern about the tone of the messaging supplied in the instructions for *Schools and Communities First* petitions as being strident and partisan. After discussion it was agreed that she would draft a resolution to be sent to the CA Presidents "chatroom" expressing our concerns

- ✓ Donna Roper reported on the planned forums for the June primary. Classroom visits for registering and preregistering students have been arranged for SRJC, Rancho Cotati HS and Casa Grande HS. Nancy B, Judy Levy and Julee Fullenwider will continue as contacts to the Sheriff's Forum we are cosponsoring with the CAC of IOLERO. Marie Wardell is continuing to work on Voters Edge. Rebecca will send out a Mail Chimp reminding of all the upcoming forums.
- ✓ Annual meeting is set for June 2 at the Finley Center. Dissatisfaction was expressed about the League Luncheon. Other venues will be considered when time allows.
- ✓ Susan Rouder will pursue a meeting with Los Cien to explore how we can work together with them on issues
- ✓ Gene Zingarelli reported on a paper on the "Housing/Homeless Crisis" produced by Debbie McKay of the League and members of Santa Rosa Together and Homeless Action. It was approved that the group would work toward presenting the paper to the Board of Supervisors and the Santa Rosa City Council. Gene and Judy Levy will present voter registration information to 4 citizenship classes.
- ✓ Gayle Peterson requested a low-income membership and it was approved. She identified some immediate expenses for tabling and will submit ongoing expenses to the budget committee. Immediate expenses of \$500 were approved.
- ✓ Anita will be collecting and mailing petitions for the *Schools and Communities* petitions if they are brought to the office.

Meeting was adjourned at approximately 12:20.

## **Advocacy Notes**

As usual we discuss many topics of which I'll report on three:

- 1) SB10: This bill in the State Senate would address racial and economic disparities in the pretrial system and not hold people in jail only because they cannot afford bail. This bill is supported by the LWV California.
- 2) Citizenship classes: Two members are presenting at the classes in the County to emphasize the importance of registering and voting, since only 18% of Latino citizens voted in the last election.
- 3) Regional Measure 3: This will be on the June ballot for the nine bay area counties. It would increase the bridge tolls (not the Golden Gate Bridge) by \$1/yearr for three years. The benefits to Sonoma County travelers are funds for widening 101 here and in Marin County, extending the SMART train to Healdsburg and beginning funding for the improvement of Highway 37. This measure is supported by LWV Bay Area.

## **Facing Questions Around Facebook**

With all of the recent news surrounding Facebook's role in the 2016 elections and its handling of online users' data, you may wonder: Why even "go there" given concerns about privacy, the risk of data breaches and the realities of being manipulated and/or treated as a commodity by online advertisers? These are complex questions being discussed by many people in various venues these days.

Through creating Facebook <u>events</u> for the recent forums hosted by the local League, we have been able to reach additional participants by allowing individuals and community groups with Facebook pages, to "share" these events with others. You yourself can "like" an event, show that you are "interested" or "going" - And then share the events with your friends on your own page. As you share events and posts, you are increasing the reach of the League.

The League has a presence <u>locally</u>, <u>state-wide</u> and <u>nationally</u> on Facebook, all with separate pages that you can search and "like" to follow. You can even search Facebook for other local chapters' pages and follow their posts. It can be interesting to read and participate in comments around any given post.

A recent Washington Post column called "How Facebook Could Be A Force For Good" shared a study that suggested that "social messaging on Facebook can be used to increase voter turnout, which is certainly valuable, but they also imply that social messages on Facebook may be useful for encouraging valuable behaviors in general. For instance, it's reasonable to expect that similar messages could be used to promote smoking cessation, physical activity, reduced truancy and many other positive actions. By partnering with governments to disseminate public service messages in a social way, Facebook may have another opportunity to improve the world."

So there are many ways in which Facebook benefits us, but we still need to be cautious and mindful of its use. In a recent Facebook post, we shared a piece in which KQED provided tips on <u>"Protecting Your Privacy Beyond Facebook"</u> for what you can do to manage your online presence wisely.

### **Book Club Reads**

#### May 17: Moderated by Lee Lipinski

Ina Coolbrith, The Bittersweet Song of California's First Poet Laureate, Aleta George, 334 pages, 2015.

This book is a biography about a pioneer poet, Oakland's first public librarian and the most popular literary ambassador in the early American West. The book follows the struggles and triumphs of Coolbrith from her birth in 1841 as a niece of Joseph Smith to her death on the eve of the Great Depression as California's most beloved poet. Among her close friends were Bret Harte, Edwin Markham and Mark Twain.

#### June 21: Moderated by Ethel Schy

Sapiens: A Brief History of Humankind, Yuval Noah Harari, 443 pages, 2015.

Harari recounts how humans have developed from brutes to demigods in the course of their evolutionary history; a grand narrative, one would think, but he perceives it as a comic-tragedy, and details it with mordant humor. ""Sapiens" is a characteristic work of "Big History" a relatively new field of research that spans everything from the Big Bang to speculations about the future. Harari is a lucid, charming writer, capable of encapsulating difficult concepts and complex stories and spinning them into a masterful synthesis.

#### July 19: Moderated by Juanita Roland

Thank You for Being Late: An Optimist's Guide to Thriving in the Age of Accelerations, Thomas L. Friedman, 497 pages, 2016.

A work of contemporary history that serves as a field manual for how to write and think about this era of accelerations. It's also an argument for "being late"—for pausing to appreciate this amazing historical epoch we're passing through and to reflect on its possibilities and dangers. To amplify this point, Friedman revisits his Minnesota hometown in his moving concluding chapters; there, he explores how communities can create a "topsoil of trust" to anchor their increasingly diverse and digital populations.

#### **August 16: Moderated by Carrie Anabo**

Dark Money, Jane Mayer, 380 pages, 2016.

Jane Mayer shows in this meticulously reported history how a network of exceedingly wealthy people with extreme libertarian views bankrolled a systematic, step by step plan to fundamentally alter the American political system. The Koch brothers and some of the richest people on the planet formed a network whose core belief....that taxes are a form of tyranny; that government oversight of business is an assault on freedom...are sincerely held. But these beliefs also advance their personal and corporate interests.


