## Highlights of the LWVSC Annual Meeting of June 2, 2018

- ✓ Rebecca Jones Presided and shared activities and accomplishments from the year
- ✓ Terry Wall presented the financial report and the projected budget for 2018-2019. It was approved by vote to accept the proposed budget (for details see Annual Meeting Kit on website)
- ✓ Gene Zingarelli reported on the activities of the Advocacy Committee and those members who were following specific issues including Homelessness/Housing, Bail Reform, The Schools and Communities First Petition (Prop 13 reform), Immigration, Voter Registration, Citizenship Classes, Climate Issues, and Transportation.
- ✓ Anita Lytle confirmed that our contract with the County for distribution of Voter Registration Cards would potentially be renewed (\$5500 a year).
- ✓ Rebecca reported that Member Outreach was focusing on tabling events and voter registration efforts to reach young and Latino voters.
- ✓ Rebecca led a discussion on issues to be emphasized in our local program for 2018-19. Issues proposed were: Support of Making Democracy Work (Voting Rights, Improving Elections, Campaign Finance/Money in Politics, Redistricting), Affordable Housing/Homelessness, and Healthcare (including mental health). Discussion confirmed that housing and health care should be prioritized. The program as presented was approved by vote.

- ✓ A very informative talk was given by Sheriff Rob Giordano.

# 2018-2020 National League Convention

The 2018-2020 National League Convention was held in Chicago for four days at the end of June. Over 1700 members from 49 states attended. This was an impressive, dedicated and passionate group of activists.

The primary message that I took from the convention was that the national program "Making Democracy Work" is now, more than ever, a critical mission in the defense of so many of our rights as Americans. The focus areas of Voting Rights, Improving Elections, Money in Politics/Campaign Finance, and Redistricting are a solid guide for the work of every league in the country.

The guest speakers were an inspiration. For instance, Thomas Hicks who was appointed by President Obama to head the Election Assistance Commission spoke of the challenges in ensuring fair elections. Andy Kang with the Chicago Advancing Justice warned against possible botched or intentional election problems in the 2020 elections. Both emphasized the importance of poll workers showing their presence at the polls and observing the processes. Voting should be a positive experience without threat or intimidation. Virginia Case our new LWVUS CEO, told the story of her Puerto Rican mother who, as a citizen and registered voter for years was forced to go home and provide proof of her status before she could vote. Rosie Rios, a truly inspirational Latina woman, was the first woman US Treasurer under President Obama, worked on the Transition Team during the 2008 financial crisis. She is currently focusing on empowering women and girls through projects such as Teachers Righting History, a project to change curriculums and recognizing women in history. These and several other speakers, most of whom have immigrant parents, demonstrated the incredible accomplishments and dedication that comes from a diverse population.

The other major topic was the League Transformation Roadmap. You will be hearing more about this in the future but there are big changes coming to the League in the following areas: Advancing a clear strategic focus, building a more inclusive culture, building a healthier League network, and increasing capacity at all levels. Some of the specifics behind these categories include allowing members to join at all levels, meaning that members can join once and be a part of a country wide network. Related to this are plans for a consolidated League-wide database where membership information is centrally managed and local leagues can access and share and collaborate plans and information. There will be increased investment in paid staff to relieve local leagues from the many administrative burdens in our current structure. There will also be a strong commitment to improving our diversity, equity and inclusion within our membership. All of this is a long term strategic vision to improve the League and enhance its influence and reputation. We should begin to see the first steps in the next few months. ### SONOMA LWV INVITED TO HEAR PAUL GULLIXSON SPEAK AT SPRING LAKE VILLAGE

The Spring Lake Village Local Issues Planning group has announced that Paul Gullixson will be its July 16th Forum speaker. Mr Gullixson is the recently retired Editorial Director of the Press Democrat. The program will begin at 2:30. It will take place In the Montgomery Center Auditorium, 5555 Montgomery Drive, Santa Rosa. Please carpool because of limited parking.

The Sonoma LWV cooperates with SLV in the planning and presentation of these Forums.

Among the issues Mr. Gullixson will address are the influence and importance of the local press as it covers local elections as well as its obligation to cover issues fairly. How does the PD decide on editorial endorsements of both candidates and ballot measures? How does it select election-related letters to the editor? And, how does it decide on the timing and placement of major election-related articles?

Mr. Gullixson retired recently after 20 years with the Press Democrat, a recipient of the prestigious Pulitzer Prize for its outstanding coverage of the October 2017 Firestorm. He is now an Associate Vice President at Sonoma State University, responsible for Strategic Communication. As he answers our questions, he might share his feelings about leaving what has become one of the most highly respected local newspapers in the country.

## What Is the Voter Registration Outreach Committee (VRO)?

This is the very active group of 16 persons (see below) who distribute and maintain the supply of voter registration forms in boxes at 115 sites throughout Sonoma County. These sites include post offices, libraries, schools and other establishments. Before the Primary Election this year, we distributed about 3200 forms in the county.

We do this service as per our contract with the Registrar of Voters of Sonoma County. This contract provides a double benefit for our League: it supports our mission of encouraging voter registration and voting; secondly it pays a signifiant amount of money into our budget.

#### July 19: Moderated by Juanita Roland

Thank You for Being Late: An Optimist's Guide to Thriving in the Age of Accelerations, Thomas L. Friedman, 497 pages, 2016.

A work of contemporary history that serves as a field manual for how to write and think about this era of accelerations. It's also an argument for "being late"—for pausing to appreciate this amazing historical epoch we're passing through and to reflect on its possibilities and dangers. To amplify this point, Friedman revisits his Minnesota hometown in his moving concluding chapters; there, he explores how communities can create a "topsoil of trust" to anchor their increasingly diverse and digital populations.

#### August 16: Moderated by Carrie Anabo

Dark Money, Jane Mayer, 380 pages, 2016.

Jane Mayer shows in this meticulously reported history how a network of exceedingly wealthy people with extreme libertarian views bankrolled a systematic, step by step plan to fundamentally alter the American political system. The Koch brothers and some of the richest people on the planet formed a network whose core belief....that taxes are a form of tyranny; that government oversight of business is an assault on freedom...are sincerely held. But these beliefs also advance their personal and corporate interests.
