League Board Votes to Support Critical School Levy

At our September board meeting the Perrysburg League of Women Voters voted to support the Perrysburg Schools operational levy on the November 5 ballot.

Passage of this levy is critical to help the school district maintain its current level of service to the community's rapidly growing student population.

Since 2008, Perrysburg's school population has grown by 19% or 882 students. To visualize that growth, this is more students than are currently attending the junior high school.

Because we are a fast growing district, the number of students counted in the state funding formula is "capped," which has resulted in a loss of \$3.9 million in funding in just the past school year. The consequence of this cap is that state funding does not keep pace with student growth.

The school board is asking the community to approve an incremental levy, as has been done in the past. This levy will grow in increments for the next five years as our population grows. An incremental levy sets a dollar amount to be collected each year. As more people move into the district the amount each property owner has to pay lessens.

If the levy does not pass, the Ohio Department of Education will require Perrysburg Schools to immediately implement \$2.7 million of mid-year reductions. The schools would then have to make an additional \$5.9 million in reductions prior to the start of the 2020-2021 school year. Even if a levy is passed in 2020, no additional funds would be collected until 2021, so the district would still have to make cuts.

Perrysburg is known for its good schools. Our property values are high due in large part to our excellent schools. The LWVPA supports the efforts of the school district to pass this levy, because they believe it is necessary to maintain that high quality and to educate our growing number of students.

Please vote yes for Perrysburg Schools on November 5.

The LWV Natural Resource Committee is calling on local retailers, asking them to convert from plastic to paper. We ask that all of our members help us out. Here are examples of what you can say at the checkout:

I have my own bags. I am trying to save the planet.

I'll take paper, please. I'm worried about Earth.

Water (or soda) please, no straw.

May I have a paper take-home box? Or foil? And I don't need a bag at all.

Please tell the manager that it takes 1,000 to 10,000 years for plastic to biodegrade.

Making plastic bags puts CO2 into the air, contributing to g)obal warming.

Did you know China no longer takes our used pastic?

Our landfills are filled with plastic, which is leaching poison into our soil.

The U.S. is using 102 billion plastic bags every year.

Plastic bags break into tiny (micro) pieces of plastic. Micro plastics are in the air all over the planet. They rain down on our soil and our water. We breathe them in , we eat them, and we drink them.

Part 2 " 1960's"

FROM THE NEWSPAPER articles

May 3, 1960 – The Toledo Blade reported that the Annual Meeting of the Perrysburg LWV was held May 3, at the Carranor Club. Mrs. Joseph Else will continue as president as she is serving a two-year term. Included among the items was that the group voted to go on record as favoring the charter form over the statutory law form of government for the Village. It will be on the ballot in November.

October 4, 1961— The *Bowling Green Sentinel Tribune* reported that the Perrysburg LWV decided NOT to support the proposed 3-mill school operating levy scheduled for a vote on November 7. (The League felt the proposed teacher salary increase could be made in 1962-63 without the levy.) The League voted to take no stand for the other two November issues, the \$1,240,000 bond issue for a new high school and the new five-mill levy to equip the school. The district needs a new high school, but the group didn't indicate how soon. These decisions were reached after a three-month study of the Perrysburg School System by a committee of ten League members. *NOTE: THE LEVY DID NOT PASS ON NOV. 7.*

October 26,1961— the *Perrysburg Messenger Journal* reported that the LWV "Candidates Fair" will be held on November 2, at 8 p.m. at the Elm Street School. League President Mrs. John Zachman announced that all 27 candidates for local offices had been invited. The Perrysburg High School band will play, refreshments will be served. This will mark Perrysburg's first city government in its 145-year history since its growth two years ago from Village status.

October 31, 1963 — The *Perrysburg Messenger Journal* reported that at the League's Candidates Fair held on October 29, the League stated that they supported the two local school levies to meet the need of the expanding school situation, the school asked for a renewal of the present 4.6-mill levy and a 3% levy for operating expenses. Local candidates' offices will also be on the ballot.

September 30, 1964 — The *Toledo Blade* reported that the LWV Board welcomed members and guests with a song "Welcome Ladies," to the tune of "Hello Dolly." Their first meeting of the year was held on September 29, in the George B. Secor home on Rockledge Circle. A world's fair theme prevailed during the morning when the members presented a view of today's LWV via skits. A film, *Where were You?* was also shown.

Information about the League was given to the guests — the LWV has monthly meetings at the Carranor Club the fourth Tuesday of every month, except December, June, July, and August when there are none, plus the separate group study meetings. Officers this year are Mrs. Cherrington, president, and Mrs. Duston, first vice-president.

September 23, 1968 — The *Toledo Blade* reported that the League's all day membership meeting at the Toledo Country Club was spiced with a skit called "Have a Cup of Tea with Greenlee," a take-off on the TV *Laugh-In* program. Mrs. R.E. Greenlee Jr., president, took the part of the hippie, and she interviewed different board members in a living room conversation-type program which was interspersed with TV-like spoof commercials. There was a protest march to celebrate the upcoming national league's fiftieth anniversary.

January 30, 1969 — The *Toledo Blade* reported that on January 28, the Toledo and Perrysburg LWV joined together at the home of Mrs. George Secor in Perrysburg to kick-off the celebration of their fiftieth anniversary. Mrs. Secor is a granddaughter of the late Sarah Bissell, an active suffragette, and the first president of the Greater Toledo LWV. Mrs. Secor and her sister Sarah S. Bissell reminisced about childhood days when famous suffragettes visited their grandmother in Toledo. They repeated a story their father Frederick Bissell had told them about returning home one time a night earlier than he had been expected. He went to his room and began taking off his shoes, when a surprised woman popped her head up from the bed and indignantly demanded, "And who, pray tell, are you?" The surprised father told his daughters he believed it was Susan B. Anthony, but didn't tarry long enough to find out.

The theme of the day was "We've Come a Long Way, Ladies." Mrs. Ben Beazley (Pat) represented the past and dressed in an appropriate costume, and Mrs. Terry Emrick, dressed as a space- age girl, represented the future. A luncheon was held in the East South Boundary Street, home of the President of the Perrysburg League, Mrs. R.E. Greenlee, Jr.
