

April Topical Tuesday:

BG Professor Will Offer Instruction On How to Best Communicate With Our Public Officials

The League of Women Voters of the Perrysburg Area in conjunction with Way Library will welcome Dr. Niki Kalaf-Hughes, Associate Professor of Political Science at Bowling Green State University, on Tuesday, April 19, at 7 p.m. for a Topical Tuesday Program. She will discuss constituent communications with elected officials.

On Monday, April 25, at 7 p.m., Dr. Kalaf-Hughes will host a follow-up workshop on writing effective communications with elected officials. The workshop will be presented by Way Library, in cooperation with the Institute for Culture and Society, Bowling Green State University, and will be held at Way Library.

The United States Constitution gives citizens the right to petition elected officials, and research shows constituent communications to be key for aspects of a democracy considered normatively important, such as the accountability of elected officials and a legislator's policy focus. At the same time, evidence suggests a level of bias in government responses, implying not all constituent petitions receive comparable attention from elected officials.

This problem has been heightened during the pandemic, as state and local elected officials have received an unprecedented volume of communications from within and outside of their districts. Further, as communications between individuals and elected officials are often private, little is known about what communications say, what type of response they generate, and when and how they influence policy. What makes for an effective appeal? How can you influence policy? How can you write so elected officials will listen?

During the workshop, Dr. Kalaf-Hughes will share the results of research on when and how individuals communicate with their elected officials, and discuss what makes for an effective constituent appeal. Attendees will have the opportunity to brainstorm and draft letters to their own elected officials.

Registration is required for the workshop and seating is limited.

Board Letter



Dear League Members,

On February 21, the Natural Resource Committee of the League of Women Voters of the Perrysburg Area welcomed Bob Clark-Phelps, Ph.D., local coordinator of the Citizens Climate Lobby, Perrysburg, Ohio Chapter, to our meeting. Bob discussed how human emissions of greenhouse gases are changing the climate, resulting in trapping too much heat. How is this affecting us in Wood County? You may have noted that we often have downpours, a result of warmer air. Downpour intensity is up 42% in the Midwest. Downpours cause flooding. In 2019, 40% of farm fields in Wood County were not planted due to flooding.

To hold warming to a relatively safe level, we must cut carbon emissions 50% in 10 years. How can this be done? Dr. Clark-Phelps is promoting HR 2307. This act is also known as the Energy Innovation and Carbon Dividend Act. This ACT would place a fee on emissions from coal, oil, and gas. Ultimately the purpose of the act is to reduce emissions and spur growth in solar, wind, nuclear, electric vehicles, conservation, and carbon capture.

The LWVUS position on carbon emissions pricing (2018) is as follows: The League of Women Voters stands united with, and in support of, efforts to price carbon emissions, whether cap-and-trade, carbon tax/fee, or other viable pricing mechanisms. The League does not have a position on how the revenue generated is to be used. We do not espouse any single method of pricing carbon over another. We will evaluate all proposed methods based on their effectiveness to abate emissions and whether the method can be successfully implemented.

Human Resources and Social Policy

Education: Monitor current issues in education with continued support of to ensure effective academic programs for the Perrysburg School District (including Penta County) for an effective academic program. Support levies (both property and income tax) when shown to be needed to sustain current educational standards and/or to provide specific needed improvements or maintenance. Study Review and analyze bond levies to finance new buildings, additions to current buildings and/or purchase of existing buildings when designed for economy and flexibility in adapting to future space and program needs.

Parks, Recreation and Arts: Support the Perrysburg area recreation needs and their financing with continued support for a well-rounded program for parks and recreation by city, township and county.

Health and Welfare: Support effective services to meet the basic physical and mental health needs of Wood County residents with consideration of programs to meet future needs.

Youth Issues: Support youth services in Wood County to achieve maximum benefit of available funding to alleviate youth problems.

Human Trafficking: Support efforts to combat human forced labor and sex trafficking. Support creation and improvements of services to victims of human trafficking to facilitate their integration into the community. Support efforts of local and state agencies to aggressively enforce the trafficking laws and prosecute traffickers and offenders (consumers). Support training and education of the public, law enforcement, and service providers regarding human trafficking.

Aging in Place: Support efforts to allow residents to age in place in Perrysburg and Perrysburg Township.

Government

Public Transportation: Support and advocate for public transportation in the Perrysburg area with particular attention to the special needs of the physically and economically challenged. Continue to advocate for public transportation in the Perrysburg area.

Public Safety: Support public safety, including police and fire departments of Northern Wood County, the transportation of hazardous waste and safety in schools and other public areas.

Library Services: Support good library services with adequate funding.

Finances: Monitor the financial accountability in Perrysburg City local governments (city, township and county) with consideration of hiring, overtime, purchases, collective bargaining and budgeting.

Regional Planning: Support participation of City and Township in regional planning and regional projects.

Natural Resources

Climate Change: Support climate goals and policies that are consistent with the best available climate science and that will ensure a stable climate system for future generations.

Clean Water: Support public access to clean and safe water. This support would include, but not be limited to:

- a. Improved waste water transportation and treatment systems, economical system for sludge disposal and monitoring of water quality.
- b. Precautionary moratorium on all new Concentrated Animal Feeding Operations (CAFOs) that produce untreated animal waste that jeopardizes ground water quality.
- Monitoring of hydraulic fracturing (fracking) and outcomes that may endanger water access and quality.
- d. Protection of water quality in the local aquifer, the waters of Perrysburg Township, the City of Perrysburg, the Maumee River and Lake Erie.
- e. Support efforts to educate community and reduce use of plastics in League and City activities.

Transportation of Hazardous Materials: Support state signage and traffic patterns for all state and interstate highways, including access roads and rail transportation routes where hazardous materials are transported.

Recycling Waste: Support recycling in the Perrysburg area, including curbside recycling availability.

Land Use

Community Planning: Support of community planning (land use policies and procedures) to meet the changing needs of the Perrysburg area. Keeping currently abreast and monitoring planning, zoning, zoning appeals commissions in the City, Township and County, with emphasis on promoting orderly growth.

Historic Preservation: Support historic preservation which should be of benefit to the Perrysburg area and the City's historic zoning ordinance.
