LWVO Virtual Statehouse Day Provides Update on Ohio VVR

It was a first for the LWVO – a virtual Statehouse Day. With 250 league members in attendance, LWVO laid out issues we will be tackling over the next several months, including an update on VVR.

VVR (Voter Verification & Registration) is the new name for AVR -- Automatic Voter Verification. VVR is an Ohio-specific, legislative proposal that will update and modernize our voter registration system. Here's how it works:

- Every time an *eligible*, *unregistered citizen* interacts with a DMV office, they will automatically be registered to vote unless they take an action to decline.
- Every time a *registered voter* indicates he/she has moved (while doing business at the DMV) his/her voter registration address will be updated.
- The necessary data is electronically transferred to the Secretary of State (SOS).
- The SOS and local election officials will add the individual to the voter rolls or update the person's registration, unless he/she declines.

VVR is more accurate, efficient, secure, and cost effective than our current system. As of 2020, 22 states plus Washington, DC have adopted their version of VVR.

The 1993 National Voter Registration Act mandated voter registration opportunities at DMV's and other state agencies. It's time for Ohio to update and modernize our voter registration process. President's Letter

Hello League Members!

Recently, I was sitting at the stoplight at the diverging diamond interchange exiting 475 to route 25 south in Perrysburg. I looked up and saw the sign "Turn left on Red." The sign reminded me of the trepidation and uncertainty we felt three years ago when the diverging diamond was opening in Perrysburg. We were concerned with the unknown, especially driving on the wrong side of the road and making a left-hand turn on red.

2020 Stranahan Citizenship Award

St. Timothy's Clothesline, an outreach mission of St. Timothy's Episcopal Church in Perrysburg, is the recipient of the 2020 Virginia Secor Stranahan Citizenship Award sponsored by the League of Women Voters of the Perrysburg Area.

The Clothesline began in the spring of 2009 and offers free gently used men's, women's and children's clothing and accessories. Used seasonal clothing is collected in a covered area in back of the church. An on-site shop is open every Friday and coincides with the Perrysburg Christians United Food Pantry, and the Zoar Lutheran Church free monthly lunch. While shopping, guests are invited to share refreshments and conversation in a small café area. St. Tim's Mobile Clothesline also takes clothing and personal products to two sites in Toledo, partnering with the Islamic Center of Greater Toledo's monthly mobile food pantry.

The LWVPA Board is working with The Clothesline on how best to recognize their organization and celebrate their accomplishment as the LWVPA 2020 Stranahan Award recipient. Stay tuned for more information!
