President's Letter

Hello League Members!

Sometimes it takes more than just the facts — why providing

ongoing educational events is important

With the recent political conventions, plus daily Facebook scrolling, I find myself routinely needing to visit fact-checking sites such as Politifact, Factcheck.org and Snopes. Sometimes I am surprised by the answers I find ... something I was sure was true, may be partially correct or false, and other times I am happy to know I am correct.

Researchers at the University of Wisconsin-Madison, Department of Political Science, found that the effectiveness of fact checking "depends upon what we knew about an issue before encountering the fact check."¹

They surveyed 500 Americans and grouped them into 4 categories of "informedness":

- Informed people who know a fact and are confident they know it.
- Uninformed people who are aware they don't know something and will answer "I don't know".
- Ambiguously informed people who guess (sometimes correctly and sometimes incorrectly) but admit they are not sure.
- Misinformed people who are confident they know a fact, when they are actually mistaken.

The researchers gave participants a quiz of 25 facts that had been fact-checked through a group such as Politifact or Factcheck.org and asked them how sure they were of their answer — thus classifying the participant as one of the four groups above. They then showed the participants a fact-check on one of the issues from the quiz.

The results showed that those who were categorized as "informed" or "uninformed" before seeing the fact-check were most likely to the answer correctly when quizzed again. Even the ambiguously informed group — those who were guessing — showed improvement after seeing the fact-check. The misinformed group were "least helped by reading a fact-check."

At first, I was disheartened by these results. I thought, "If only the skeptical, misinformed group would just listen to the facts." Then I realized our opportunity is with the uninformed and the ambiguously informed. As the League we must continue to offer educational opportunities for our members and the community that challenge us to think. Let's think of creative ways to attract members and attendees who don't have all the answers or are unsure of the answers. Along the way, we may make progress with those who hold deeply to their facts.

Although the article has some limitations -- it was not published in a peer-reviewed journal and did not give the total number of participants in each group -- I think it can inspire valuable dialogue about our important role in providing factual, educational opportunities for our community.

I hope you take time to check what you hear and read every day!

League Meetings Will Be Virtual This Year



Did You Know?

Did you know that you can get absentee ballot request forms, change of address forms and/or register to vote forms at Way Library?

If you fill them out there, the library will even mail the forms to the Wood County Board of Elections for you.

2020 General Election FAQ

Q: May I drop off my Absentee Ballot Application at the office of the Wood County Board of Elections (WCBOE)?

Yes. There is a Drop-Box available 24/7 outside the main entrance to the Wood County Courthouse, 1 Courthouse Square, Bowling Green.

Q: Do I have to drop off my Absentee Ballot Application? May I mail it?

Yes -- but, mail it today! The mailing address is: WCBOE, 1 Courthouse Square, Bowling Green, OH 43402-2427

Q: For previous elections, I have done Early In-Person voting at the WCBOE's office. The space was small and the voting booths were very close together. Will it be the same this year?

No. Early In-Person voting booths will be set up in the Wood County Courthouse Atrium and hallway to allow for physical distancing. (Early In-Person voting starts Tuesday, 10/06/20, at 8:00 AM.)

- ✓ <u>Verify Your Registration</u>
- ✓ <u>Ballot Applications</u> mail it now if you want to Vote By Mail.
