# **LWVO Executive Director Jen Miller Will Present Program on Voter Rights**

Way Public Library is one of 25 libraries nationwide selected to participate in *Let's Talk About It (LTAI): Women's Suffrage*, a grant designed to spark conversations about American history and culture through an examination of the women's suffrage movement.

The League of Women Voters of the Perrysburg Area and Way Library will welcome Jen Miller, Executive Director of the League of Women Voters of Ohio for a presentation on voting rights on Tuesday, September 13, at 7 p.m. at the library, as part of the LTAI project.

LTAI: Women's Suffrage is a humanities discussion project from the American Library Association (ALA) supported by the National Endowment for the Humanities (NEH).

Jen Miller has over twenty years' experience working with diverse communities to promote social justice and civic action through positions with Columbus Recreation and Parks, Martin Luther Jr. King Arts Complex, the Ohio State University, and Global Gallery.

She earned her Master's in Arts Policy, Education and Administration, a program of the John Glenn School of Public Affairs at Ohio State. She holds bachelor's degrees in Vocal Music and History and Ethnic Studies from Capital University. Ms. Miller is a graduate of the US Department of Energy NREL Leadership Academy. She is a board member for the Ohio Debate Commission, the Ohio History Connection, and Kids Voting Ohio.

Media literacy empowers people to be critical thinkers, effective communicators and active citizens in today's world."

# Mis/Disinformation - Identify - Rectify

Source: LWVUS Women Power Democracy

### **Definitions**

**Misinformation:** inadvertently sharing false information without the intent to harm

**Disinformation:** intentionally **c**reating and sharing false information with the intent to harm.

Bottom Line: Both share information that is false.

## **Examples of Election Mis/Disinformation**

**Wrong Information** regarding Vote-by-Mail, Early Voting, and Election Day voting.

**False Voting Issues** like claims of fraud, double counting, ballot dumping, and machine errors.

**Attempts to Cast Doubt** on the security of the election process, especially Vote-By-Mail.

Untrue Claims About Results of an Election which casts doubt on a fundamental process of our democracy -- voters having their voices heard at the ballot box.

Casting Doubt on Election Audits which are a key part of our elections. (See Ohio's "Post-Election Audits Explained" 2-minute video from the Ohio Secretary of State's office

# **Identify Mis/Disinformation**

Research the Source: identify who is sharing the content.

Check the Date: confirm if it is a current event or a past event being re-circulated.

Cross-Check: check to see if reliable sources are reporting the same information.

Read Past the Headline: avoid falling for click-baits -- content and headlines taken out of context to make it seem more dramatic to get people to engage.

Pause & Question: if content triggers a visceral, emotional response from you, that's a red flag!

### **Stop Mis/Disinformation**

**Do Not Engage:** Avoid amplification. It might sound counter-intuitive, but do not provide the oxygen to false content by commenting, reacting, or sharing.

**Debunk Misinformation** -- with correct information. Counter mis/disinformation that is spreading rapidly: 1) name what is false; 2) name the motivations behind the misinformation; and 3) state the truth and link information with trusted sources. Never link the mis-disinformation content.

Avoid Cross-Pollination: avoid sharing from one social media platform to another.

**Report When Needed:** whenever you see mis/disinformation, flag it for removal from the social media network. Collaborate with LWV partners by also reporting it on <a href="www.ReportDisinfo.org">www.ReportDisinfo.org</a>.
