#### From the President Marilyn Perkins

It is hard to believe that it is almost April. While only three months have gone by in the calendar year, the League year is almost over. Leagues finish one year and start a new one on the same day –the day of the May Annual Meeting. ## **Public Banking Study**

Toyoko Tsukuda will be recommending a study of public banking at the League's Annual meeting on May 18, 2017. She will also present this topic at the State Convention, and the State League may, or may not, adopt it as an issue to study.

Unlike privately-owned banks, who are responsible to their shareholders, public banking is operated through institutions owned by the people through their representative governments. Seventeen states have proposed the establishment of a public bank to fund important projects in all areas of government, such as education, infrastructure and health care. To date, only North Dakota has a public bank. In North Dakota, the state deposits its revenues in the Bank of North Dakota. This money is loaned at low interest rates to North Dakota residents, which ensures that a high proportion of state funds are being invested in the state's economy. The earnings on those loans are put back in the state treasury. This enables North Dakota to fund projects without incurring new debt. During the recent credit crisis, it was the only state to report a budget surplus every year since 2008. LWV Vermont adopted a study of public banking in 2013.

## Orientation for New-and Potential-Members Janet Nail

Mark **May 6<sup>th</sup>** on your calendar. The League will be having an orientation and brunch at Janet Nail's home for new and potential members. Details will be announced in the May Voter.

Topics will include how the League is structured, available resources offered by local, state, and national Leagues, and learning how to spearhead an official study or a simple information seminar.

After the orientation, LWVBF member Ellyn Murphy will present the Climate Change Toolkit the State League put together and answer questions on the impacts—and latest projections—of climate change. All members are welcome at either, or both, events.

#### Next Generation Public Disclosure Data Access Project Toyoko Tsukuda

Most PDC data is currently available to the public, but getting to it is not easy. The PDC (Public Disclosure Commission) would be well served to implement Open Data standards that would allow the public to download bulk data and do their own searches. Since October 2016, the PDC has been partnering with a LWVBF member and others from the community to develop a complete replacement for the data access system. The scope of the project includes a new interface for casual browsing, deep data access, and an Open Data interface for large data requests. Most importantly, these goals are being developed by the community.

Phase 1 of the Data Access Project was completed on Mar 7<sup>th</sup>, 2017. In 14 weeks, the team published 5 million records on the State of Washington's Open Data Portal. The data sets include the following: all campaign finance contributions, expenditures, debts, loans, and pledges; campaign finance registrations, reporting history, and filings; lobbyist employment registrations, compensation, and expenditures; and independent electioneering and communications. Each of the data sets is updated daily. The data catalog contains complete metadata for each dataset, making it easy to understand what is included.

The PDC will again be partnering with members of the community for Phase 2, Specific Search, and Phase 3, Fuzzy Search. Both projects will start in April.

## April Table Talk: Public Health

Carol Moser, the executive Director of Greater Columbia Accountable Community of Health, will be the guest speaker at our **April Table Talk on Thursday, April 6<sup>th</sup> at 5:30 pm in the Ben Franklin Transit Center** (Richland Wye/ 1000 Columbia Park Trail). She will be giving a general overview of the Greater Columbia ACH and what it does.

Carol Moser provided the following description about the organization:

"The Greater Columbia Accountable Community of Health (GCACH) is a collaboration of community leaders from a variety of sectors with a common interest in improving health. Accountable Communities of Health (ACHs) are an essential component of Washington's Health Innovation Plan, known as "Healthier Washington," which aims to transform the health system in the state to bring better health, better care and lower costs to Washington residents. Greater Columbia ACH includes 10 counties and the Yakama Nation."

## March Table Talk on Syrian Refugees

The LWVBF's March Table Talk on Syrian refugees featured guest speaker Amira al Salami, who works in the Richland office of World Relief, an organization that helps refugees start a new life in the U.S. From Iraq, Amira is a refugee herself. "No one really wants to leave their homeland," she said. "Nobody can understand it until they become refugees, which is something I personally do not wish for any person." Amira lived in Jordan for about 18 months before she was allowed to come to the U.S. For some, the wait is longer and includes living in refugee camps where food is rationed. Amira noted there's plenty of food the first ten days, enough for the next ten days, but by the last ten days food is so scarce, "nobody has enough energy to talk." A former English professor at a university in Iraq, Amira was surprised by her limited career options in the U.S. She turned down an offer to be a kindergarten aide, saying she could be more useful as a translator. Happy at her job for World Relief, she "feels blessed" to be in America. Amira ended her talk by introducing a newly arrived Syrian family. Her talk was well attended and open to the public.
