Sag Harbor Express Forum on February 22 Explores Progress Made in Affordable Housing in EH/SH Towns

Following up on its affordable housing forum last year on January 19 at the American Hotel, the Sag Harbor Express held a second session this year on February 22, titled “Affordable Housing: A Year Later,” with seven panelists—East Hampton Town Supervisor Peter Van Scoyoc, East Hampton Town Housing Authority executive director Catherine Casey; Sag Harbor Housing Trust board member Rob Calvert; Southampton Town Director of Housing and Community Development Diana Weir; State Assemblyman Fred W. Thiele Jr.; Next Gen Housing Collaborative founder and real estate agent Michael Daly; and Sag Harbor Partnership treasurer and attorney Susan Mead.

As its title implied, the session aimed to detail the progress that has been made over the past year. As reported by the panelists, East Hampton Town is purchasing four acres on Route 114 from Triune Baptist Church and is developing a 37-unit project at 531 Montauk Highway in Amagansett. Southampton Town passed legislation to allow more homeowners to add accessory apartments; will soon hold a housing lottery for 15 units

in Southampton Pointe; will build 66 affordable apartments in Tuckahoe and Speonk Commons; and is developing a 50-unit senior citizen community in Hampton Bays.

Assemblyman Thiele spoke of his just-introduced Assembly bill to raise funds for affordable housing with a .5% tax on property sales of \$400,000 and above, similar to the current Community Preservation Fund (CPF) tax on property sales to fund land and water preservation.

A problem to which the speakers all concurred was retaining current affordable housing, due to the ever-rising prices of homes. “As we are pushing forward with more units coming online, we are losing affordable properties at an alarming rate,” said Supervisor Van Scoyoc.

Plugging a call for YIMBY (Yes In My Back Yard) was Michael Daly, encouraging all to support the towns’ affordable housing initiatives. Attending the luncheon forum from the Hamptons League were Government Committee members Glorian Berk, Arlene Hinkemeyer, Judy Samuelson and co-chair Ann Sandford.

The South Fork Commuter Connection has launched!

On schedule, the first train left Speonk Monday morning, March 4, at 6:16 a.m. with stops and connections made smoothly all the way to Montauk. The SFCC is a series of new morning eastbound and afternoon westbound trains using connecting buses to deliver passengers to their places of employment. It is a cooperative project between the Long Island Rail Road and the towns of Southampton and East Hampton and has received state funding to provide the bus service for the “last mile” for the remainder of this year and in 2020. The fare for a round trip, including both train and bus transportation, is \$8.50.

The SFCC is a major addition to the South Fork’s transportation infrastructure. It gives employees, especially, an

option to get out of their cars, reduce their commute times, and even save money by leaving their vehicles at home avoiding the car and truck traffic of the “trade parade.” Officials have appealed to employers to allow employees some flexibility in their work schedules in order to take advantage of the new service. Reductions in carbon emissions and pollution for the community would be a side benefit. Behavior changes will be required to make the service a success and planners have pointed out that ridership will vary seasonally and according to the intensity of traffic. Special Events Plans May 30 Art-Centric Tour of Springs, East Hampton

Save the date of Thursday, May 30, when the Special Events committee has planned a tour of historic and arts centers in Springs, home to many artists, sculptors, writers and filmmakers in East Hampton, and once the center of America's abstract expressionist movement, with the studios of both Jackson Pollock and Willem de Kooning.

The day will begin at 11:30 a.m. with lunch at the new EHIT (East Hampton Indoor Tennis) entertainment center, The Clubhouse. Then it's off to the fabulous Leiber Collection at 446 Old Stone Highway, the museum built in 2005 to house Judith Leiber's famous handbags and Gerson's Leiber's beautiful paintings, amid the grounds that contain their home and sculpture garden. The current exhibit, titled "The Marriage of Two Minds Remembered," honors the memory of this couple who died in April 2018.

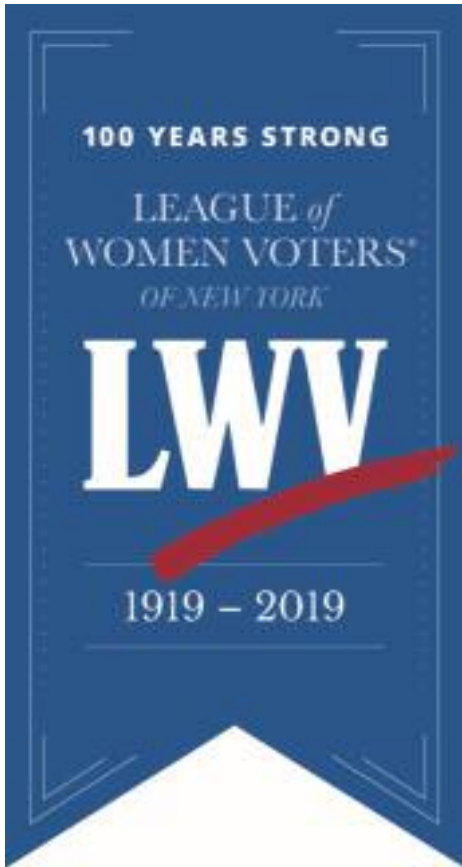
Next is a not-to-be missed guided tour by art historian and Pollock-Krasner House executive director Helen Harrison, of the famous Green River Cemetery, the final resting place of 47 artists including Jackson Pollock, Lee Krasner and Elaine de Kooning, and a talk by East Hampton's entertaining historian Hugh King, of the Springs Historic District.

Additional stops include a tour by Board member Zachary Cohen, of the Duck Creek Farm Historic Site and the John Little Barn on Squaw Rd, off Three Mile Harbor Rd., now used for free summer concerts, art exhibits and Pollock-Krasner House lectures.

The Springs tour may also possibly include a refreshment stop at the Maidstone Park Beach picnic shelter and a chance to meet a representative group of Springs artists, sculptors, writers and filmmakers. Information on cost, RSVPs, a tour schedule and map will be forthcoming.

LWV 100th Anniversary Dates to Remember As We Approach These Anniversaries

**November 19, 2019:
100th Anniversary of the League of Women Voters
of New York State.**

The NYS League of Women Voters was formed when, at the 51st convention of the New York State Woman Suffrage Party, the delegates resolved on November 19, 1919, to change their name to the New York State League of Women Voters. The first chair was Narcissa Cox Vanderlip.

**February 14, 2020:
100th Anniversary of the National League of
Women Voters.**

The National League of Women Voters was founded by Carrie Chapman Catt on February 14, 1920 during the convention of the National American Woman Suffrage Association, which took place in Chicago. The convention was held just six months before the 19th amendment to the U.S. Constitution was ratified in August, giving women the right to vote nationwide after a 72-year struggle. Maud Wood Park was elected the first president of the League.

Representatives from Brentwood, Harborfields, Hauppauge, Kings Park and Smithtown High School West learned from Legislators Colarco, Cilmi, Berland, Donnelly and Kennedy about their work. A Suffolk County Police lieutenant spoke about school safety and the students caucused and then held a mock Legislative meeting to debate and vote on a hypothetical resolution on whether armed police officers should be provided to all schools in the county. A similar program is planned in Riverhead on April 11 for students in eastern Suffolk.

LWVSC monthly column in TimesBeaconRecord newspapers on early voting funding advocacy

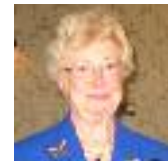
LWVSC and our local Leagues continued our civic advocacy for early voting funding by lobbying and using local media. March 14's six TBR editions featured our column titled *Making Democracy Work: Ensure Easier Voting in November*.

As the issue was on press, it appeared that our efforts in lobbying the NYS Senate and Assembly were effective- both houses of the NYS Legislature included early voting funding in their budget amendments. However since Governor Cuomo did not include the funding in his budget and subsequent executive amendments, it is left to negotiations among Governor Cuomo, acting Senate President Andrea Stewart-Cousins and Assembly Speaker Carl Heastie to hash out competing budget proposals and needs before the budget deadline of April 1.

Other News:

Our annual LWVSC meeting with the Suffolk County Board of Elections may be delayed this spring as a result of the funding details/delay and changes to the election calendar both for the single primary (to be held in June rather than September) and poll locations and hours of early voting in late October/early November. Electronic poll books are essential for the process to run smoothly.

LWVSC's 2019 Directory of Public Officials is scheduled to be off-press in late March.

Mary was a board member and Legislative Director of the League of Women Voters of Suffolk County for the past ten years. In 2012 she received LWVSC's prestigious Liberty Award in recognition of her work fostering more transparency in Suffolk County government. She was an expert in all things related to the county legislature, and served with dedication; observing, speaking, mentoring, teaching, reporting and sharing her passion for good, responsive, open government with elected officials and the public. As a member of LWV Huntington for many years, Mary was a board member, treasurer and chaired the nominating committee. LWVSC encourages more local League members to honor and continue Mary's passion by observing and reporting on the Suffolk County Legislature. A memorial service will be held at 10am St. John's Episcopal Church in Huntington on Monday April 22.

Two Councilmen Interviewed

On March 12th the Voter Services Committee of the LWVH sponsored a Public Information Meeting (PIM) at the Hamptons Library in Bridgehampton featuring David Lys and Tommy John Schiavoni, the two newest Town Councilmen from East Hampton and Southampton, respectively. Both panelists are new to elective politics but both have histories in governmental participation. They comprised a panel of two for an informal discussion of their positions at Town Hall.

Mr. Schiavoni, a native of Sag Harbor and a Pierson High School graduate, had been a long time Social Studies teacher at Center Moriches High School. Before being elected to the Town Council in 2017, he was on the Sag Harbor Board of Education and served as a member of the Southampton Zoning Board where he continues as liaison to the Town Council. He works with the Southampton Comptroller's Office, the Hampton Bays Water District, the Highway Department, transportation, public safety and the Arts and Cultural Council. He voiced a strong need to remain vigilant about our water quality, both fresh

and salt and agricultural preserves and easements. At the same time, he is concerned with the amount of traffic impacting our towns.

David Lys graduated from East Hampton High School and owns two businesses in East Hampton. He served as a member of the East Hampton Zoning Board and helped found CFar (Citizens for Access Rights), a grassroots organization to keep the ocean beaches accessible to local vehicle operators and helped fund and restore the Amagansett Life Saving Station on Atlantic Avenue, (which is close to being listed on the National Register of Historic Buildings).

He was appointed to the Town Board in 2017 to complete then Councilman Peter Van Scoyoc's term when he was elected Supervisor. He has since been elected in his own right to complete that term.

Both Councilmen have strong ties to the community and liaise to personally relevant Community Advisory Committees. Both remained concerned and focused on the need to provide affordable housing for current and future generations.
