LWV-WA 2024 WA State Legislative Success

Here is a list of most of the issue areas followed by the LWVWA Advocacy team, with an example of two bills that passed in each issue. Details on these bills and many more are on the LWVWA website https://lwvwa.org/current-issues-2024

Many thanks to all who participated by signing in pro, testifying, or sending comments to their legislators. Now is the time to thank them. The voting record is given below for the 8^{th} , 15^{th} , and 16^{th} legislative districts.

Elections

1241 Addressing Harassment of Election Workers - makes threats to workers a class C felony. The 8th, 15th and 16th legislative districts senators and representatives all voted yes.

5890 <u>Reducing ballot reject rates</u> through updates to ballot curing, canvassing, reporting, and outreach processes. Unanimous.

Education

2331 <u>Procedures required before books can be removed</u> - to protect materials from arbitrary censorship. Senator Torres - yes; Senators Boehnke & Dozier, and all representatives- no.

5462 <u>Dual and tribal language education to update inclusive materials</u>, including for LGBTQIA+ individuals. The 8th, 15th and16th legislative districts senators and representatives all voted no.

Housing and Homelessness

1892 <u>Workforce housing accelerator program</u>. To provide loans to organizations to develop housing for low-income households. Effective 06/06/2024. Unanimous.

1998 <u>Concerning co-living housing</u>. Allows shared housing where residents have their own bedroom but share living space. Effective 06/06/2024. House: unanimous; all our senators- yes.

Health Care

SB 5986 Protecting consumers from out-of-network health care service charges. Effective 06/06/2024. Unanimous.

2SHB 1929 <u>Supporting young adults following inpatient behavioral health treatment</u>. Provides transitional housing. Effective 06/06/2024. Unanimous.

Criminal Justice

HB 2099 Ensuring that people in state care and custody have valid IDs before discharged. Senators Dozier and Torres – Yes; Boehnke no. All 8th, 15th, 16th representatives no.

SB 6009 <u>Prohibiting the use of hog-tying</u> by law enforcement. Senate: unanimous; House: all voted yes except Representative Klicker.

Environment

HB 1012 <u>Creating an extreme weather response grant program</u>. Funds for communities with emergency management. but few resources. Effective 06/06/2024. Unanimous. Senators Boehnke and Representative Sandlin voted yes, the rest of our senators and representatives voted no.

HB 1368 <u>Zero Emissions School Buses</u>. For heathier air for children and reduced lifecycle operating costs. The 8th, 15th and 16th legislative districts senators and representatives all voted No.

Redistricting Reform Task Force ~ Leona Hassing

Finalized on Friday 03/25/2024 with a Court Order from Judge Lasnik, new maps are the remedy from the Soto Palmer v Hobbs decision. Despite a last-minute attempt by the Intervenor-Defendant's to put forth a simpler change, the Plaintiff's 3A map was adjusted for technical fixes and made law in Map 3B. 13 districts, (2,5,7,8,9,12,13,14,15,16,17,20,31), in 15 counties are affected. Most significant changes are to districts 14 and 15.

Over half a million people will change districts and 5 legislators are no longer in the district they represent. The Office of the Secretary of State has confirmed that these

lines will displace Senators Hawkins(12), Torres(15), King(14), Representatives Corry(14) and Mosbrucker(14). Senator Torres will finish her term.

The decision is being appealed to the 9th Circuit Court of Appeals for a stay. The election process will move forward with this map towards the 2024 election unless there is a ruling.

Eight members attended the MELD Pod 4 meeting with Lunell Haught, facilitator, Nancy Halverson, Board liaison and representatives from Bellingham/Whatcom, Clallam, Kitsap, Thurston, and Benton/Franklin counties.

The meeting started with members sharing their League's activities and the development of ideas. Individual members shared what is going well, and what they need from state league.

Topics included but were not limited to tabling, DEI activities, involvement of new members, "Coffee with League", observer corps, personal outreach, political forums, civics ed, retention of members and youth involvement.

The state board will be discussing how the League can moderate a forum on certain initiatives when LWVWA has a position "against" each of the Initiatives. Of the six state initiatives that gathered enough signatures to receive action, three were

passed during the legislative session and three will be on the November ballot. The league has experienced pushback on the topic, thus the reason to review the policy.

In preparation for Council, Nancy, board liaison, was seeking suggestions and ideas to incorporate into the MELD workshop. She received many worthy ideas to pursue.
