We have 92 members including 10 students, 11 second in household. Two new members joined in July.

#### **Education Fund:**

We have \$2,211.00 remaining in the Education fund. This is enough for next year's scholarships and with board approval, could become a continuing project. We also need a new project submitted to the LWVWA Education Fund for the \$10,000.00 donation that John Perkins would like to give us in Marilyn's honor. The new project required a statement and Board approval before submission.

### Suggested (draft project):

There were many donations in memory/honor of long time League member, Marilyn Perkins, who passed away in 2021. These funds are being held in the LWVWA Education Fund. Two scholarships to high school seniors were given by our League this year. Marilyn's husband John would like to donate \$10,000.00 for five years of scholarships. The scholarships will be given to high school graduates attending a college/technical school who have maintained a 3.5 GPA or better, who live in the greater Tri-Cities, and who present an essay stating what good citizenship means to them or their personal pathway to good citizenship.
