President's Message ~ Beverly Johnson-Torelli

2020 will undoubtedly go down in the history books as an unforgettable year. It has convinced even the most skeptical of us that everything really can change in the "blink of an eye." It has brought economic and educational distress, thrown us into isolation, and caused a host of other challenges. On the other hand, it has brought us some good changes that may remain even after COVID-19 has been brought under control. For example, it has dragged us into using the technology that we have now, even if we were reluctant previously. This has helped us stay in touch with family, friends, business colleagues and fellow volunteers, reducing isolation from what it might have been just a few years ago. It has also allowed employees of many types of organizations to work from home, with an added benefit of reducing the carbon footprint. In the meantime, it has helped children and students of all ages to engage in learning even during quarantine. For our organization, it has helped us continue doing business, even though we miss socializing in the traditional way. 2020 also marks the 100th anniversary of the passage of the 19th Amendment, affirming the right to vote for women. What better present for this signature year than to have the national voter turnout to be the largest in the last 120 years! In the Tri-Cities, the voter turnout was also high: 82.16% for Benton County and 78.29% for Franklin County. That said, every election season presents new challenges, and we must persevere to encourage everyone not only to register to vote but to take action on election day. Every vote truly does count!

Thanks to all of you who were able to join us for the Table Talk on November 12th. (So named because in normal times, we gather together around tables for a soup dinner.) Our League member, political scientist, and CBC Professor, Miriam Kerzner, did a wonderful job of facilitating the discussion on the election debrief. Please join us for the next Table Talk on December 17th at 6:00 p.m. The topic will be homelessness. Chariss Warner, Director of Ministries at the Tri-City Union Gospel Mission, will be our speaker. Her focus will be on homelessness of women and children in particular. Chariss has also written a book entitled: On a Mission, which can be ordered on Amazon. On October 31, 2020:

Checking is \$6,005.19 Savings is \$1,856.58 Total \$7,861.77

Income: \$675

We received \$525 in dues and \$150 in member contributions.

Expenses: \$987

The National, \$424 and State, \$252 Per Member Payments (PMP's) were made in October for the second quarter. The post office box payment of \$148 was also made. Judy Golberg set up a personal Zoom account for us to use and we reimbursed her \$162.79. Many thanks to Judy.

Of course, our potential activities are limited by pandemic restrictions and it is hard to know how long this may last. We may have to be more creative in our planning and how we carry out any work. LWVWA Civics Education Inventory helping leagues to be Civics educators ~ Lora Rathbone

As part of the BF LWV Civics Ed team, I represented our League on the Civics Education Committee established by the LWVWA State Board.

Our purpose was to create an inventory of adult civics education activities from all the Leagues in Washington state. We also want to encourage Leagues to use the text "The State We're In" as a resource.

The State Board considers civics education for adults to be critical work in our state; only recently a civics education course been required for high school graduation in Washington. We know that the basic structures and processes of government have not been taught consistently in schools for over 30 years. By creating an inventory of Civics Education activities, we can share ideas and resources with each other. These activities include a wide range of activities from voter education at voter registration events, to informing the public about issues, like during our Table Talks. Hopefully having this list of activities and resources will encourage Leagues to do more in this important role of educating the public to become active and informed citizens.

Our committee reached out to each League by giving a presentation on this project on Zoom. My presentation was to Kitsap county where they have an active Civic Education team and have produced several videos that we hope to use some day! A few members from our League joined in the discussion about how to proceed with civics education at this time. It was reassuring and inspiring to discuss this with another League. Martha, our new member, is a retired teacher from Hanford HS and gave us valuable insight. She advised us to wait to approach teachers because they are currently overwhelmed with the pandemic. But she has some great ideas for what we can do to reach students when the time is right.

Once we hear back from the Leagues around the state, the information will be organized, and hopefully made available to Leagues in time for our program planning meetings. I am excited about the possibilities of what our League can do in the future.

Membership, Engagement and Leadership Development (MELD) ~ Polly Parton

November 16th Zoom meeting

MELD calls provide a monthly interaction between Leagues to network, share ideas, accomplishments and best practices with guidance and mentorship from our coach Lynn Busacca. Our State Liaison Susan Fleming also shares State and National resources with us and gives state leaders summaries from the local Leagues. Benton-Franklin is currently in Pod #5 with members from Kitsap, Grays Harbor and Thurston Counties.

Our calls are 60 minutes, Lynn provides an agenda. Discussions are casual and productive. Some highlights of our last call are-

- "Braver Angels" is highly recommended watching (You Tube) promoting common ground to unite red and blue America.
- I noted Beverly Johnson-Torelli's interview on Election night (NWPB TV) was informative and positive recognition for the LWV.
- Some local leagues use different companies for their websites, but there are still costs and issues with on-going training.
- A presentation from a state leader on legislative "how to..." is available to local leagues. Our own Lora Rathbone has covered much the same materials and she continues to be a great source of information for our league.
- We discussed the DEI Diversity, Equity and Inclusion Policy. At first sight, I thought it was overly extensive, but it highlighted (to me) the many ways I might unconsciously disenfranchise others.
- A portion of our national league dues go to fights such as challenging the ballot drop box reduction in Texas (to one per county).

Richland City Council Meeting November 17, 2020 ~ Carol Larkin

COVID-19 Update, Cindy Reentz, City Manager

- Ms. Reentz described Richland as doing well, especially in comparison to the state, regarding cases, hospitalizations, and deaths. (Her report sounded much rosier than what is reported from the health district in the TCH).
- There are about 1300 utility accounts pending. The city is trying to inform people that there is still money to help with utilities.

Mayor and Council: Comments on Gov. Inslee's recent new restrictions

- Mayor Ryan Lukson read a letter strongly disagreeing with Gov. Inslee's recent restrictions. After comments by every council member, the letter was unanimously approved to be sent to Gov. Inslee.
- Major concerns, disagreements:
 - Since local health officials have said that the surge is coming from private gatherings where people aren't wearing masks and not from interactions at businesses, the new restrictions won't make that much difference.
 - The letter cited a study done by 3 counties which showed a very low rate of cases from indoor dining. (The state has said that the study painted a misleading picture and incomplete facts).
 - The business community has implemented safety protocols and made significant investments to provide a safe environment. These restrictions disregard their investments and efforts and will ruin many businesses.
 - There has been a lack of partnership and cooperation between the city and state. It seems the city's input was not considered. The city only learned of the restrictions a couple of hours before they were announced.
 - There should be more customization-not one size fits all.

- While most council members remained fairly civil in their strong disagreements, one council member went on a disrespectful tirade full of false or misleading information for a long time. (I turned off the sound until he finished because I couldn't stand it).

 - 17,000-Elijah Family Home Project Funding

 - 13,000-ARC
 - 199,000-City of Richland Public Works department-new ADA ramps
- Ordinance No.46-20, approving the 2021-2026 Capital Improvement Plan, Cathleen Koch, Admin. Services Director.
 - RE: Last council's comments and discussion on the animal control shelter to bring it up to the \$2 million commitment required by each city in order to proceed. She said this did not take away from other projects.
