To update members on plans to award \$1,000.00 scholarships to two students graduating from a public high school in Benton or Franklin Counties, the committee has 1) developed an online-application form; 2) called all school districts to create a list of contacts who oversee the scholarship applications for their students; 3) reviewed and updated the judges' scoring documentation; and 4) have the commitment of seven judges to complete the task.

The application will be available to students by January 31st with the deadline for submittal March 27th. Each application will be accompanied by an essay indicating what good citizenship means to the applicant, or their personal pathway to good citizenship in a democratic society.

These scholarships will be awarded at our May 18th Annual Meeting.

Tax Structure Work Group Update

The following is the follow up of the tax structure work group's presentation to our board in late 2021.

I hope you are doing well and enjoying the new year so far! Thank you, again, for getting involved in the <u>Tax Structure Work Group</u>'s efforts last year to gather feedback from community members and businesses about Washington State's taxes. I'm writing to share updates on the Tax Structure Work Group's recommendations and next steps.

As you know, the Tax Structure Work Group spent 2021 gathering feedback from taxpayers on tax type options. In 2022, the Work Group studied and refined tax proposals. Using the feedback from Washingtonians and analysis by the Department of Revenue, the Work Group decided on two policy recommendations to the Washington State Legislature:

- Replace Washington State's current business and occupation (B&O) tax with a margin tax.
- Replace the current 1% property tax limit factor with a limit factor tied to population growth and inflation for local governments.

On January 19, a bill regarding the margin tax (SB 5482) was introduced in the Washington State Senate. Information about this bill, including dates for public hearings, is available on the <u>legislature's website</u>.

You can find more information about the Work Group's recommendations and updates on related bills on the <u>Recommendations page of the Tax Structure</u> <u>Work Group website</u>. Also on this page (and attached to this email), is a visual one-pager that summarizes the Work Group's process and decisions between 2021 and now.

LWV Observers will participate in the Levy Election ~ Chuck Lo Presti

LWV Observers will observe ballot processes for the School Levy voting, as part of Benton County's Paid Observer Program. The Observer's Mission Statement is: "To provide an independent observation and maintain confidence in the accuracy and integrity of the election process." Only the two major political parties and the League of Women Voters are allowed to provide observers for this Washington State-sponsored Program.

Levies for five school districts are on the ballots, and our LWV chapter will provide five observers - Carla Chiotti, Kelly Doyle, Chris Grantham, Jane Sereda, and Chuck LoPresti - serving as official observers at the Voting Center for this election. These official observers are those who received the Voting Center's training in mid-January, which updated them on changes to the ballot processing procedures and provided them updated/rewritten manuals.

To provide a schedule of events, ballots are to be mailed out around Wednesday the 25th of January, ballot sorting begins the afternoon of Monday, January 30th, and final tabulations are performed the evening of Election Day, February 14th. Finally, Certification is scheduled for Friday, February 24th.

Briefly, ballot processes performed at the Voting Center include collecting the ballots from the Post Office, Drop Boxes, and the Voting Center. Then follow tasks such as sorting, signature verification, opening ballots, machine scanning, handling ballots with scanning problems, and finally tabulating ballots for the final vote counts. After the election, the paper ballots are archived for varying periods up to two years. The Benton County Auditor's website https://www.bentonauditor.com/Current-Election has a lot of information, including flowcharts and YouTube videos about elections and ballot

processing in Benton County.

The election observers are allowed to observe these processes as part of an effort to make ballot processing as transparent as possible while maintaining secret ballots and election integrity. These processes are carried out between 9:00am-12:00pm and 1:00pm-4:0 pm between January 30th and February 24th

We've found the election staff welcoming and eager to explain what they are working on, and we are always amazed to learn from them at how much meticulous work goes into running an election and processing ballots.

We are reminded that unofficial observing of election and ballot processes is open to anybody; that is, anyone is welcome to drop in during Voting Center working hours (9:00am – 4:00pm), and witness the action from a special area for drop-ins, not in the work spaces. Only the official trained observers (e.g., our five stalwarts listed above, one at a time) observe from within the workspaces ("cages"), while following special no contact/no interference rules, noting anything that seems noteworthy.

So if you would like to get a taste of election observing, come visit the Voting Center. It's a few blocks north of the Columbia Center Mall, at 2618 N Columbia Center Blvd, Richland. It's best to call them at (509) 736-2727, before showing up to make sure they are actually processing ballots that day.
