BOARD OFFICERS



President: Bill Johnson

Bill is a 25 year member of the League of Women Voters of North Pinellas and was treasurer in 2008. For 14 years he served as a Clearwater City Council member starting 2001-2007 and again from 2010 – 2014. He represented Clearwater on the Pinellas Suncoast Transit Authority (PSTA) where he is past chair of the board and

was previously the city's representative to the Tampa Bay Estuary Program. The Florida League of Cities (FLC) elected him to their Board of Directors. He is also a member and chair of the Citizens Advisory Committee of the Tampa Bay Regional Transit Authority (TBARTA).

In 1998 Bill was the founder and president of Citizens for a Better Clearwater which successfully petitioned the Clearwater City Commission to phase out billboard clutter on a portion of Gulf-to-Bay Boulevard in Clearwater. He is founder and chair of the Courtney Campbell Scenic Highway Advocacy Group which achieved designation as a Florida Scenic Byway resulting in the multi-use trail across the causeway today.

Prior to his retirement from Honeywell Inc. in Clearwater in 1999, Bill oversaw project management activities with the Department of Information Systems. During his 29 year career with the company he performed other duties including internal auditing and systems analysis.

1stVice President: Karen Owen

Karen has served the North Pinellas League for the past three years developing voter outreach events in diverse locations where unregistered voters might be found, including low-income neighborhood centers, alternative high schools, Habitat for Humanity events, back to school backpack events, bus depots, and at training programs for the Pinellas Ex-Offender Re-entry Coalition. She is the LWV North Pinellas lead on voting rights for returning citizens, and feels strongly that a previous incarceration or felony conviction should not preclude voting rights. Karen also organized the League's first Party at the Polls at a local polling place. Karen holds a PhD in Geographic Science. She manages several non-profit web sites and is Outreach Co-Chair for her church. She moved to Florida in 2015 and resides



in Safety Harbor with her husband. She has jumped feet first (wearing flip flops most of the time) into the nonprofit world where she is active in the LWV FL Poverty Action team working to reduce poverty and improve equity in Florida.

She hopes to build a collaborative team of League members interested in learning new software and other digital media. In post-Covid-19, she believes this will strengthen communication with our elected representatives and the community. 2nd Vice President: Kathryn (Kathy) Smith



Kathy moved to Florida via the United States Air Force from her birth state of Ohio. The Emerald Coast Region of Northwest Florida soon became home after she completed her military service. A move south to Palm Harbor made the Suncoast her new home, and she found time to join the North Pinellas League of Women Voters, where she is now the Membership Director. COMMITTEE UPDATES



The Education Action Group is taking a sabbatical from monthly meetings through the rest of this year as we focus our efforts on the crucial upcoming November election. During this unprecedented time, we will continue to monitor the important issues facing Florida's teachers and students and pass along any events or issues coming up.

One of the more important items that we will be advocating for is for voters to continue to support the one-half mil ad valorem tax referendum which will be back on the ballot this November for a 4 year renewal. Since 2004 voters have overwhelmingly supported this referendum with 80% of these funds supplementing Pinellas County teacher salaries (\$4,724 per teacher last year) and the other 20% going directly to classroom resources including visual arts, performing arts, reading and technology which helped make the transition to digital learning more manageable. A loss of these funds would be detrimental to Pinellas Counties teachers and students.

Other issues to keep an eye on in Education include plans for reopening Florida's schools, the fate of Florida's high stakes testing after testing was suspended this year, the impact on Florida's students after several months of "distance learning", and whether our legislators remain committed to the 500 million budgeted for teacher and support staff pay raises.

Looking forward to seeing everyone in person again and please let me know if there is an Education issue I should be sharing with the team.

Update on Florida's Returning Citizens - The Amendment 4 Roller Coaster

Amendment 4 to the Florida Constitution passed by nearly 66% of voters in 2018. It stated that persons who were convicted of a felony can now vote as long as they've completed the terms of their sentence and have not been convicted of murder or a sex crime. During the 6 month period following its passage, Leagues across Florida, including ours, worked diligently to conduct voter registration, outreach, and education in populations where unregistered voters might be found.

Then, in the Spring 2019 FL State legislative session, the legislature passed Senate Bill 7066, adding the requirement that all fines and fees, such as court costs, be paid first before former felons (returning citizens) would be eligible to register to vote. SB 7066 also expanded the definition of sex

crimes and added a long list of felony convictions that would preclude many from ever voting again. This bill became effective July 1st 2019, and it had a chilling effect on returning citizens. Many were scared to register to vote, unable to determine if their fees had been paid, and worried they would violate this new law at a time when they just wanted to get their lives back on track. In 2019 and early 2020, our League led numerous voter registrations and education sessions at High Point Family Neighborhood Center, the Pinellas Ex-Offender Re-Entry training classes, several Pinellas alternative high schools, Habitat for Humanity new homeowner sessions, and even at public bus terminals.

Our State League was very busy too. Cecile Scoon, LWV FL 1st VP spent countless hours working with the State Bar Association, the Florida Rights Restoration Coalition, Stetson Law School in St. Pete, and many other organizations to put together lawyer training to help attorneys understand how to research whether a returning citizen's fines, fees, and restitution (if owed) had been fully paid so they could register to vote. Enormous resources continue to be diverted trying to figure out how SB 7066 works in practice for hundreds of league members and pro bono attorneys and the over 700,000 FL citizens impacted by this bill, the majority of which are caucasian.

On May $23^{\rm rd}$ 2020 the 11th Circuit Court ruled that the requirement to repay fees and court costs per SB 7066 was unconstitutional, and that the state did not provide sufficient means to determine if a sentence had been completed. Court costs and fees disproportionately impact people of color, having the effect of a poll tax. In that ruling, the Judge stated the FL Governor, FL Div. of Elections, and Supervisors of Elections were enjoined from preventing anyone from registering to vote if the person has a present inability to pay. If the amount of what is said to be owed cannot be determined after a diligent effort, that would be the basis for a returning citizen to be able to register and then vote. The Governor's office requested a full-court review set for August, and this effectively puts the 11th Circuit's decision stating parts of SB 7066 are unconstitutional - on hold. So essentially we are back to where we were at the beginning of the year, with SB 7066 standing as-is. We continue to hope for a positive outcome in August, and we hope the will of the Florida voters who passed Amendment 4 will be adhered to.

With COVID-19 in our midst, it is very difficult to disseminate information about voting rights to returning citizens, or to anyone who is not well-versed in voting laws in Florida.
