You Can Be An Advocate ~ Lora Rathbone

At the LWVWA Convention last week there was a session on Advocacy. Here is a brief summary:

Advocacy is speaking up for a cause. Lobbying is how we advocate at the legislature. What the League chooses to lobby for must be consistent with League positions which is key to the League's credibility.

One way to be an advocate is to respond to the action alerts that are sent weekly in the LWVWA legislative newsletter during the legislative session. You can sign in "pro" on a bill or sign an issue chair's pre-written letter or provide testimony. And there are many more opportunities to help:

- Communication: draft social media content, write letters to the editor, prepare a one-page summary of a bill for legislators to review
- Research: analyze bills; see what other leagues are doing
- Advocacy: Draft legislation and amendments, meet with legislators, draft testimony
- Outreach: Coordinate and recruit volunteers

Many league members worked hard to keep us informed on bills the league supported in the 2021 legislative session. They continue to advocate for League issues during the interim. This is when a lot of work is done and legislators have the time to give to constituents.

Washington State Redistricting Commission ~ Leona Hassing

Every 10 years, a bipartisan Washington State Redistricting Commission (WSRC) is established for the purpose of redrawing legislative and congressional district boundaries.

The WSRC consists of four voting members-two Democrats and two Republicans picked by the leaders of the Democratic and Republican caucuses in the state House and Senate. A fifth, nonvoting chairperson is then picked by the voting members.

The Commission must draw the district lines in conformity with strict, nonpartisan rules designed to create districts of relatively equal population that will provide fair representation for all Washingtonians.

The U.S. Census Bureau announced appropriation numbers on April 26, 2021. US population is 331M and Washington state 7.71M. Washington retains its 10 representatives to the U.S. House of Representatives. WA legislative districts will be 157K people and congressional districts will be 771K people.

The WSRC began holding public outreach meetings on May 22, which have now been completed. A second round is scheduled for the last week of July 2021. Deadline for completed maps is November 15, 2021. At least three of four members must agree to the maps. The Legislature can make only minor changes to the commission maps and the governor has no role.

Under state law, districts must be made as equal in population as possible and are not supposed to be gerrymandered for partisan advantage or discriminate against any group. They are also supposed to avoid splitting up cities and other political subdivisions.
