### **Budget Committee:**

The Proposed FY2022-2023 Budget was approved at the Annual Meeting in May and will be implemented next fiscal year beginning July 1<sup>st</sup>. It should be noted that our President, Beverley Johnson-Torelli, contributed \$701.00 in "in kind" donations for renting the room at Applebee's; the broadcast/Zoom equipment and labor, and the scholarship recipients' families' dinners. It is important to turn in 'in kind' receipts so that these costs can be included in the next fiscal year budget.

Receipts from the State Council need to be turned in and the recipient check cashed before June 30<sup>th</sup> in order to keep the cost in this fiscal year where it was budgeted. Our league will pay for ½ of a hotel room for the nights of the convention/council and the registration fee.

Beverly Johnson-Torelli, Diane Molleson, and myself went to Umpqua bank in north Richland and had signatures updated. They are backup signatories for checks and other transactions.

The **Nonprofit Corporation Annual Report** was filed with the Secretary of State along with a \$20.00 fee. It was not available via online express as it was in past years.

**Education Fund**: We have \$2,211.00 remaining in the Education fund which is enough for next year's scholarships which may be able to be a continuing project from this year (needs board approval). We also need a new project for the \$10,000.00 donation that John Perkins would like to give us in Marilyn's honor, and it needs to be approved by the board.

Suggested (draft project): Marilyn Perkins, who passed away in 2021 has received many donations in her memory/honor to our League's Education Fund held by the

Washington State League. Two scholarships to high school seniors were given by our League this year. Marilyn's husband, John, would like to donate \$10,000.00 for five years of scholarships. The scholarships will be given to high school graduates and college/technical school students who have maintained a 3.5 grade point or better, who live in the Tri-Cities and who present an essay stating what good citizenship means to them or their personal pathway to good citizenship. The project will then be approved by our Board. We can't handle the money through the state education fund without having an approved "project".

# LWVUS Convention, June 23rd-26th, Denver ~ Judy Golberg

This year's convention was a hybrid convention with more than 800 voting delegates, with at least 200 observers via Zoom. It was the first time in four years many of us have seen people we know in person. I agree it was more satisfying than a virtual gathering. I did wear my mask, as did many others. I doubt that I would have attended had it not been for my commitment to report as co-chair of the national nominating committee.

The pre-convention workshops were held virtually. There was so much information shared prior to attending that it gave delegates the opportunity to get their questions answered—practical process questions, budget, bylaws, program and much more. There were also workshops and caucuses held during convention on dozens of different topics.

The Budget was passed. There will not be a change in the PMP (per member payment). Big changes coming though! The Bylaws Amendment proposed by the Transformation Roadmap Committee passed. This will give the committee the ability to put energy into figuring out all the details how to change the dues' structure. The goal is to have anyone wishing to join the League, from any computer, league meeting, at the local level, state or national by simply clicking on a "Join" button. The member's information will be shared with the appropriate league, state and national with the dues' income shared among the three. This should eliminate most of the work local leagues' treasurers or membership chairs must do now. The actual details still need to be worked out. Hard to do without the bylaws and budget changes. Those were approved after much discussion. Now the work can really get underway!

- Emergency Resolution from Washington State on the topic of abortion rights passed
- Age limit for membership did not pass. It will remain at 16.
- Voted to retain all proposed national programs

- Concurrence approved with New York's health care proposal
- Concurrence approved as amended on the popular vote
- Concurrence approved on the criminal justice proposal
- Failed to concur with Colorado's election security issue. (Considered to be covered now)
- Concurrence approved with Connecticut's' digital equity proposal
- Proposed study on digital democracy failed
- ERA to be added to Program passed
- Resolution made regarding immigration passed
- Resolution regarding climate emergency passed
- Resolution regarding Douglass Commonwealth statehood (WA DC) passed
- Resolution from Wyoming regarding missing and murdered native Americans

The Slate of Officers, Board, Nominating Committee Chair and Committee members were elected as proposed.

# Report from Council 2022 ~ Miriam Kerzner

Francis Benjamin launched Council with a presentation on the results of the LWVWA internal survey. While unscientific because respondents were self-selected, the primary strength of the League they identified was highlighted throughout the weekend: (future) voter education.

Voter education begins in the schools. Beth Pellicciotti and her Spokane team explained that teachers found the League more useful when we first asked how we could be of service and then provided those specific resources and assistance rather than developing set programs which might or might not fit in with the teachers' plans.

Just as we excel as a resource for schools, so too do we provide important services for adults. Mary Coltrane took us through the logic of the new "Be a Voter" campaign and reinforced the importance of the Vote 411/Voter Pamphlet project.

Adult education extends to broader issues as well and our role in state advocacy. Susan Fleming drew our attention to upcoming issues in education, elections, voting, redistricting, criminal justice and police accountability. The Consensus Process Team is developing a position about the last. Dee Ann Kline's presentation on the decline of local news brought home the multitude of ways in which this trend not only

impacts voter knowledge and government accountability, but even the refusal of banks to underwrite bonds because that accountability is lacking. The League is sometimes able to step into that reporting role as it has with the Shorelines Study which reviewed the Shoreline Management Act of 1971, another issue on which we are currently developing a League position.

The internal survey not only pointed to these strengths but highlighted our difficulties with recruitment and retention. Some of this may have to do with the increasing incivility discussed by Nicholas Lovrich in his presentation on polarization. It may have to do with a weakness in our DEI efforts, a topic addressed obliquely by Vicki Lowe when she spoke about working with tribal communities in the context of health care. It may also be related to the way in which we socialize people into the League when they express an interest, a topic addressed by the Seattle-King County League when they shared their training guide for the "Getting Engaged" orientation and potentially our failure to take advantage of research about how all people learn best as Linda Benson and her team encouraged us to do.

# Hanford Advisory Board Vacancy ~Susie Q Leckband

The LWV of Washington State has had a seat on the Hanford Advisory Board for more than 25 years, primary and alternate. I have resigned from the alternate position as of June 30, 2022. If you are interested in being appointed to the Board as the alternate LWV representative, please notify Lunell Haught at the state league office at <a href="President@lwvwa.org">President@lwvwa.org</a>. The state LWV President is the authorized person to put names forward to the US Department of Energy for consideration. Typically, the term is for 2 years with term limits of 3 total terms. The Board has 5 subcommittees where the bulk of the work is done. The Board passes advice and recommendations via a consensus process after becoming as educated as possible on each issue in the workplan. Full Board meetings are 4 or 5 times a year with sub committees meeting a bit more often. Meetings may be virtual, hybrid or in person depending on circumstances. Currently the primary member for the League is Jan Cantrell who lives in Bellingham. Hopefully, someone from the local LWVBF is interested in Hanford cleanup and has the time and interest in this volunteer position.
