Warm greetings! February was the League's birthday month, and we celebrated with a lunch at CG Public House on February 16. Andy Miller, Benton County's retired Prosecuting Attorney was Guest speaker. He shared many stories about the cases he tried over his 36 years as Washington State's longest serving prosecutor. He covered the changes he observed in the criminal justice system, in particular the development of mental health and veterans' courts. He strongly believes in the value of therapeutic courts and second chances, but also feels there must be accountability for the sake of the victims and their families.

The presidential primary is on March 12. Unlike other elections, you must select a political party affiliation on the ballot envelope. (Your party affiliation will be removed from your voter record 60 days after the election.) For your vote to count, you can vote for only one candidate, and the candidate you mark on the ballot must match the political party you selected on the return envelope. Advocacy Report on the Washington Legislative Session

The 2024 legislative session will end March 7. Check the LWV- WA website <u>here</u> to see which bills passed. You may also attend a Legislative Wrap up on March 11 (see ACT on Zoom).

Only about 15% of the bills introduced will pass this session. The only Democracy bill that we were following that is likely to pass is HB 1241, Addressing Harassment of Election Workers. This bill makes threats to election workers a class C felony regardless of how the threat is delivered. It also allows for those election workers who are harassed to apply to the Address Confidentiality Program to protect their home addresses. More good news is that HB 2247 Addressing behavioral health provider shortages, is likely to pass, as is HB1052 which would create a financial incentive to nonprofit organizations that provide affordable housing.

New Legislative Maps Update

The <u>Soto Palmer v Hobbs lawsuit</u> that declared a Yakima Valley legislative district discriminatory towards Latino voters has forced the drawing of new legislative districts in central Washington. After a hearing on Friday, February 9, remedial map 3A, (5 remedial maps were submitted), is the leading candidate for the new legislative map. This map changes 13 districts: 2,5,7,8,9,12,13,14,15,16,17,20,31 - with the most significant changes to 14 and 15. The Office of the Secretary of State has confirmed that these lines will displace Sen. Hawkins(12), Sen. Torres(15), Sen. King(14), Rep. Corry(14) and Rep. Mosbrucker(14). The State has deferred to the courts to draw the maps. The remedial maps do comply with redistricting principles and the top metrics are the same or better than the enacted maps. The final map, drawn with assistance of a court appointed special master, <u>Karin Mac Donald</u>, is due on **March 25, 2024**.

Judge Robert Steven Lasnik appointed Karin Mac Donald, a redistricting expert from California, as special master to assist the court in evaluating the proposed maps. Mac Donald, director of the Election Administration Research Center at University of California, Berkeley, was the principal consultant to the California Citizens Redistricting Commission in 2011 and 2021. Judge Robert Stephen Lasnik serves as a senior United States district judge of the United States District Court for the Western District of Washington.

If changes close to 3A are enacted, LD14 will be a district where Latino voters have a very good chance to elect the candidates of their choice, and a new map will be disruptive to thousands of voters who will be changed to new districts.
