Treasurer's Report~ Shirley Sonnichsen

We received a \$500 check from HAPO and \$182.50 from the Indivisible local chapter. They were liquidating their assets and wanted to donate to a non-partisan organization.

Expenses: \$5,469

The national PMP for \$424 and the State PMP for \$251.75 were paid. Checks were written to the winners and second-place winners in the essay contest for a total of \$4,730. A \$47.70 check was also written to Christine Grantham for the gold coins. The Treasurer spent \$63 on stamps and copies for the dues letter.

Membership and dues: The dues letter went out in August and there were no dues returned in August. We have 4 new members who joined in September: Kathy Blaisdell, Cait Guyette, and Carol Larkin and Fred Parton is a second-in-household. We have 67 members per the September Membership list and 4 of those are students. Also, Hannah Kuhn sent a generous check for the LWV-WA Ed Fund which I put through to the LWV-WA for the TRY.

Volunteers: There were 8 volunteer sheets returned and 3 were officers or board members who already have jobs. The main responses were Voter Service and Civics Ed with a couple Observer Corps.

Election Information~ Marilyn Perkins

This is a unique election year, to say the least. I've learned a lot about other state's voting procedures, and it has made me more grateful to live in Washington state. Ballots will be mailed on their normal time, which is by Oct. 16th this year. We should receive them by the next Monday at the latest. If other family members, friends or neighbors receive a ballot, and you don't, contact the elections department in your county.

Each county will also mail the Voter's Guide the middle of October, but it is available online if you go to the Secretary of State's website. Online or mail registration or change of address, must be made 8 days prior to the election which is Monday, Oct. 26th. I would not recommend waiting that long unless absolutely necessary. After that you must go to each county's election office. In Franklin County it is still in the County Courthouse on 4th Ave. In Benton County they have opened a special election location in Columbia Center North in the old Chuck E. Cheese location. They will give you a ballot and you can vote right then or return ballot on time.

This is definitely the year to take your ballot to a drop box, and you can use any of the ones in the state and they will get it to the correct county. If possible, please return your ballot to a drop box that is in your home county by 8 p.m. on election day and save election officials the extra work. It will also save the government the cost of postage and you won't have to worry about it being postmarked on time. If you can get in by Monday, the 2nd at the latest, it might give them time to process and have it ready to be counted on Election Night.

All the attention this election has received and the information about registering and voting that is being shared has made me realize how uninformed so many are about voting and its importance to their lives.

I do have extra registration forms and if you would like some to share, let me know and I will get them to you.
