#### Beth Pellicciotti's Civics Education Presentation ~ Diane Molleson

On September 19 at the LWVBF's wine social, members were treated to an enlightening presentation by LWVWA's Civics Education Chair, Beth Pellicciotti. Beth began by providing a definition of civics education, showing how it focuses on learning how government works, understanding the responsibilities we have to our communities, and inspiring us to be informed citizens. She drew on many examples of local leagues activities to highlight how we're all putting civics education in action in our mission of "empowering voters and defending democracy".

The second part of her talk focused on the League's textbook and teaching guide, *The State We're In.* In 1983, the national League asked all the state Leagues to create a book on their state's history. Unbeknownst to many, the LWVWA has continually been publishing civics textbooks for the past 40 years! Most recently, with the encouragement of the Snohomish League, they have translated their textbooks into Spanish and are reaching out to school districts that have dual-lingual and multi-lingual language programs.

Beth noted that there are 40,000 students now in dual language programs in the state (the majority of these programs are in English and Spanish) and 120,000 students whose first language is not English. She encouraged us to display the textbook when we do tabling and to let teachers know that they are able to request the League's textbook as a supplementary resource for students both at the elementary or middle to high school level. Many already use the textbook to teach Washington State History.

### Benton County Auditors Monitor Program ~ Charles Lo Presti

The Benton County Auditors' paid election monitor program is continuing. This is a call for our veteran observers, and new observers to consider working the forthcoming General election.

The Observers Mission Statement is to provide independent observation of election processes with the aim of maintaining confidence in the accuracy and integrity of the election process. Only the two major political parties and the League of Women Voters are allowed to provide observers for this Washington State-sponsored paid observer program.

All participants in the paid program, both veterans and new people, are asked to take the mandatory training at the Benton County Auditor's Elections Office (Voting Center), 2618 N. Columbia Center Blvd, Richland, WA, since some of the Voting Center's procedures may be updated. This training will be held **Friday October 13 from 2:00pm to 4:00** pm at the Voting Center and will cover the elections processes and observing guidelines.

The updated schedule as compiled from the Election Manager and the Benton County Auditor's website at this point is:

Thursday, October 5	Official Logic and Accuracy Test at 11:00am
Friday, October 13	Mandatory training for all election observers at 2:00pm
Wednesday, October 18	Ballots Mailed, official election processes observing begin
Tuesday, November 7	Election Day
Monday, November 27	Pre-Certification at 9:00am
Tuesday, November 28	Certification at 9:00am

Active observing happens between October 23 and November 24 at the Voting Center. Shift times are expected to be 9:00am to 12:00pm and 1:00pm to 4:00pm (with a lunch break).

The election processes include scanning and sorting ballots, verifying signatures, and tabulating votes. We've found the election staff welcoming and eager to explain what they are working on, and we remain amazed to learn how much organizing and meticulous work goes into running an election and processing ballots. Only the officially trained observers observe election processes from within the workspaces, following special no contact/no interference rules, noting anything that seems noteworthy. Although this is an off-year election and the races are mostly local, we expect a higher turnout than the Primary election therefore more busy shifts, so observers are definitely needed.

Again, we are recruiting both veteran and new League members as observers, and <u>this time we have Kelly Doyle as our new Elections Coordinator, to broaden and</u> <u>deepen our bench.</u> Charles LoPresti is taking a break. # LWVBF's "Get Out the Vote" video: The Backstory ~ Christine Grantham

In preparation for the LWVWA's 2023 State Convention, I printed famous quotes as tabletop decorations. This line by Abraham Lincoln stood out. "Nations do not die from invasion; they die from internal rottenness."

My worst fear is that we may lose our democracy due to disinformation, lack of confidence in our electoral process and voter apathy. To encourage participation in what is still considered our most precious right as Americans, "The Vote," I wanted to make a video directed at young people before the 2024 primary.

I wanted an effective "GET OUT THE VOTE" tool to encourage voters to turn out and vote. We would produce two 30-second videos, one in English and one in Spanish.

In the summer of 2022, I looked at short clips and videos mostly by professional entertainers promoting voting. There were some that could possibly work, but there are always trademark and licensing restrictions. I would need just the right combination of actors for a play or video and/or background music. The whole project seemed overwhelming.

Then in the Fall of 2022 the LWVBF was asked to participate in the Pasco School District <u>All Staff Welcome Back Expo</u>. At the close of the event, I happened to hear some snappy music and spotted Pasco High School's Dance Team— the dance team of my dreams! Their performance was impeccable, the choreography outstanding and each member unbelievably talented. They fit the bill right down to my wish for a multi-cultural group representing the America of the future. I found the coach and asked if they had ever done any performances like one to encourage voting. The coach was all in and so was the team. It was a GO!

The team selected the slogan <u>"YOUR VOTE, YOUR VOICE, YOUR FUTURE"</u> and had the slogan printed on their red, white, and blue tee-shirts. The Dance Team coach, Rebecca Schwan, has been with the Pasco School District for 24 years and is an outstanding choreographer. She has coached semiprofessional dance and cheer teams and was inducted into the Washington State Hall of Fame for Dance and Cheer in 2015. Most importantly, she has a unique connection with her team. Together they create incredible routines. So now I could begin the project.

The next piece of the puzzle was to find a videographer. Most of the professionals I interviewed were out of my price range, but I happened to find Tyler West who had just moved to the area. He understood the frustration of voter apathy and was eager to be part of the project.

There was another bonus that came as a total surprise. At the suggestion of the dance coach, I talked to The Pasco School District Community Outreach Supervisor, Gracie-Valle Chimal. Gracie was familiar with the League's work and immediately offered to assist in any way. She understood the importance and urgency of a community project to stimulate interest and turnout prior to the 2024 election. Gracie has worked in radio and broadcasting, has public affairs experience, and also speaks fluent Spanish.

She and I hit it off immediately and I know my project would never have come to fruition without her professional guidance, suggestions, and advice. She critiqued our practices and proved to be a master of what to cut to keep us within our 30 second limit. Ultimately, she knew the importance of protecting the League's name and the integrity of our project.

The GOTV video was finally finished in June 2023. It was completed with the help of a \$1,500.00 grant from the State League's Education Fund, which paid the cost of the videographer. Here is the link in English and Spanish so you can watch it:

If there are no forests, Leagues can advocate with the Dept. of Natural Resources for statewide policy to protect mature forests in Washington. Kate is working on a toolkit to help other counties do what they are doing in Snohomish County to lobby their county council. # Redistricting Reform Campaign (RRC) Task Force $\sim$ Leona Hassing

The WA State Redistricting commission is a bipartisan commission of 5 members; 2 Democrats and 2 Republicans and a non-partisan chair which convenes every 10 years to redistrict the state's legislative / congressional districts after the census figures has been compiled.

The commission started the redistricting process early in the spring of 2021. Alison McCaffree, as League Census and Redistricting Chair, led a campaign during the Redistricting process to train volunteers to testify and to develop ideas for alternative maps. The process lasted several months with a deadline of November 30, 2021.

The actions of the final days of the commission were unfortunate. It was chaotic, the midnight deadline came, and maps were submitted. Note that the Tri-City area now has 4 Legislative Districts; 8, 9, 15 and 16, and there were similar incidents, statewide.

LWVWA formed the Redistricting Reform Campaign (RRC) Task Force, with Alison McCaffree as chair. The charge was to investigate reforming the existing redistricting commission so 10 years hence, the commission would become a people focused commission.

The major obstacle, though, was that it would take a constitutional amendment to change the WA State Redistricting commission. This would not be an easy task.

The Redistricting Reform Campaign (RRC) Task Force will investigate options, study examples from other states and develop a redistricting commission plan that could pass as a constitutional amendment.

Breaking news...

A lawsuit was filed, Soto Palmer VS Hobbs.

The federal courts ordered that Washington redraw Legislative District 15, in Central WA including parts of the City of Yakima and Pasco.

The decision in Soto-Palmer v. Hobbs is a decisive win for Latino voters in the Yakima area who do not have equal opportunity to elect candidates of their choice. This decision bolsters the LWVWA's position that Washington's bipartisan commission needs major reforms. WA Legislative Leadership is letting the courts draw the new maps. Their quote in the Seattle times article said it was "the most expedient and nonpolitical way to move forward." The governor's office and the Latino Democratic Caucus agree; however the Senate Republican leader is against the move. The new maps could affect districts west of the Cascades or create some expansive eastern WA districts.

At this point, the RRC Task Force is developing a plan of work as to revising the WA State Redistricting Commission. Statewide, League members are being asked to contribute time and effort to the RRC task force. Partnerships with like-minded groups will be added to the committee as time goes on. The RRC Task Force will also follow the progress of the Soyo-Palmer v. Hobbs lawsuit.

# MELD (Membership, Engagement and Leadership Development) $\sim$ Leona Hassing

In Washington state, the League of Women Voters has had a long-standing Membership Engagement and Leadership Development (MELD) program. This program is a conduit for communication among all levels of the League, local, state, and national. MELD meetings are where local Leagues can share their successes and challenges and receive information about programs and resources from state, national, and local Leagues. MELD meetings allow League members to stay connected to programs and resources that benefit local Leagues.

The local League members from across the state who are in a MELD meeting, along with a facilitator and a Board representative, are called a pod. The four pod facilitators manage each group, meeting virtually via Zoom once a month with representatives from four or five local Leagues and the state Board. The Board member provides updates, answer questions, listens to members' concerns and thoughts, and then takes the comments and suggestions back to the Board.

MELD POD #4 started the year with some changes. Lynn Busacca, who has been the POD facilitator for 7 years, left and will go to be a member of another POD but not the facilitator. The new facilitator is Lunell Haught, previous state president and last year the board rep for POD #4. The board representative is Susan Baird-Joshi.

POD #4 consists of the following leagues: Clallam Co. LWV, Grey's Harbor LWV, Kitsap Co. LWV, Lewis Co. UAL, Thurston Co. LWV and Benton-Franklin, LWV.

An agenda and Zoom link are sent prior to each meeting. Meetings start with sharing something about each committee member and what is going well or could be improved within your League and then discussion on the identified topic. Susan Baird-Joshi, state board representative, led Fix Democracy First Happy Hour a lengthy discussion on State League, starting with the difference between the C4 and C3 accounts. An additional issues position, called Journalism and Democracy was created. Deanne Finken as the chair. The idea came from the newspaper study which League completed earlier. Susan talked about the action workshop and the short legislative session this year.
