Blanco County Commissioner Precinct 1: term of office - 4 years

The Blanco County Commissioners Court conducts the general business of the county and consists of the county judge who is elected at-large and four commissioners who are elected by geographical precinct. Each commissioner is typically responsible for building and maintaining county roads and bridges with the precinct.

Duties: adopts the county budget and the county tax rate; approves all budgeted purchases of the county; sets all salaries and benefits for county employees; authorizes all county contracts; provides and maintains all county buildings and facilities; and fills vacancies in elective and appointed county offices.

1. What experience and knowledge qualifies you to serve as a Blanco County Commissioner for Precinct 1?

I bring experienced, effective, and principled leadership to the Commissioners Court. I am an advocate for our County's citizens and bring a progressive voice to the Commissioners Court.

Weir: I would like to continue working on staying ahead of the curve with the rapid growth, water availability, upgrading our roads and bridges and assuring our new and lifelong residents a quality product when purchasing a lot or tract of land. I will help Blanco County residents maintain a safe and affordable quality of life just starting a new family homestead or starting a new life of retirement in the beautiful Texas Hill Country.

3. What are the citizens who live in Blanco County Precinct 1 telling you about county problems?

Lewis: Citizens are concerned for the health of the Blanco River, the number of new wells drilled with increased growth in our county, and the demand that places on our aquifer. The Blanco River is a valuable resource and a jewel of the Hill Country and needs to be protected and maintained so that resource is available to our future generations. Additionally, citizens are concerned with the issue of eminent domain and personal property rights. Finally, citizens are concerned about our roads and low water crossings condition and our ability to plan for maintenance and growth.

Weir: My friends and constituents are concerned about water availability and quality. They are concerned about urban sprawl. They want good, effective law enforcement along with good schools. They want to make sure that the County can maintain and improve our infrastructure meaning roads and bridges, broadband, emergency services, and business.
