Notes from Myrtle Point, by Jackie Clary

Last month's **LWVOR** Communications Café presentation was "Are We in a Constitutional Crisis?" The speaker was Betsy Massie, an OLLI instructor (Osher Lifelong Learning Institute, Ashland) on the Constitution.

Massie talked about the Constitution in relation to the judiciary, emoluments, and the military. With the judiciary, she spent time explaining the shadow docket. which is supposed to be used in an emergency to enable decisions to be made quickly with little or no explanations needed. The current Supreme Court has used the shadow docket multiple times this year and Massie feels the media is not reporting it as they should.

Emoluments are addressed in the Constitution and we have heard a lot on this topic this year. The last part of her talk was about the military and how Congress is supposed to decide how the military is to used, which seems contrary to what we are witnessing these days.

If Massie offers her OLLI class on the Constitution again, I plan to sign up. It is offered as a Zoom class. You can also see her on an Ashland TED talk about the Constitution titled "Use It or Lose it."

- → On November 19, LWVCC hosted a major program at the Egyptian Theatre, "Toward a Deeper Understanding of the PCIP, Part 2."
- → Well over 100 people turned out on a rainy night to learn about how the global supply chain works and its implications for the Pacific Coast Intermodal Port.
- → After a brief summary of the project's elements by League member Jan Hodder, two experts spoke about (1) global shipping and the economics of international commerce (Steve Hughes), and (2) the U.S. rail system (Bill Burgel).
- → Both speakers connected their information to the PCIP plans, highlighting concerns with the PCIP's business plan.


Their presentations were followed by an extensive Q&A period in which they were joined by a third expert, Bob Morrow.

Be a Smart Citizen: Think before You Ink

Right now there are 56 proposed ballot measures and 1 referendum that have been filed with the Oregon Secretary of State for the November 2026 ballot! That number will decline sharply, but we can all expect to be accosted wherever we go by people collecting signatures. **LWVUS** encourages its members to be mindful about what to sign.

Here's some of its advice:

- Ask to see the signature gatherer's ID. Paid gatherers must carry a photo ID issued by the Secretary of State; often they know nothing about the petitions they're circulating.
- ② <u>Do you support the proposal</u>? Don't sign a petition "just to get it on the ballot"; only sign petitions for measures you support.
- <u>Does it belong in the Oregon constitution?</u> Constitutional amendments can be difficult and expensive to amend after the fact. In general, tax and funding provisions do not belong in the constitution.
- Is it an unfunded mandate? Oregonians have a way of voting for measures that require the government to do things that might in theory be desirable, but lack the funding and regulatory structure to be properly implemented.
- Is the initiative language clear? Some proposals aren't well written. They may require lengthy court battles to resolve potential issues.
- Is it too complex? If a measure will affect multiple areas of government, it may be difficult to implement and have unintended consequences.
- Look up who's behind the initiative. You can search for the chief petitioners on the Secretary of State's web page, here. Are they from out of state? What's their agenda?





League Defeats Administration in Court

- In March 2025, President Trump issued an executive order that would have required people to show a passport or similar document when trying to register to vote.
- Half of all Americans do not have a passport.
- **LWVUS**, along with other groups, sued on the grounds that a president is not entitled to change election laws—only Congress and state Legislatures can do that.
- The case was titled League of Women Voters Education Fund v. Trump.
- In April Judge Colleen Kollar-Kotelly issued a preliminary injunction barring implementation of the order, and on October 31 she made that injunction permanent.

Carnegie Corporation \$1 Million Grant to LWVUS




The Carnegie Corporation of New York has awarded LWVUS's 501(c)(3) arm a grant of \$1 million to expand youth civic education and engagement programs nationwide.

Jeanette Senecal, the head of civic learning and impact at LWVUS, said, "We want every young person to see themselves as active members of our democracy who have the power to shape the future."

Programs that will benefit include civics education in middle schools, high schools, community colleges, and vocational schools; Spanish-language voter outreach; partnerships with youth-serving organizations; voter registration efforts; and publicity for **Vote411.org**.
