This year has seen many changes, but some things stay the same for the League.

Work on the 2020 Census and preparations for the November elections head into high gear as we enter the second half of the League's 100th anniversary year. Post-Census redistricting may be delayed because of COVID-induced delays in the release of Census tallies. (Candidates may have to campaign without clear information about which district they might be running in.) In a departure from the past, League's efforts to make democracy work for our community will likely be through virtual (online)

presentations. Pros-and-cons, candidate forums, ballot measure discussions—as well as our Board meetings—will likely all be online. Join us virtually at the important events that help shape our communities and our democracy! Watch our *Voter* newsletter for details.

The cuts in state funding caused by COVID shutdowns (\$54 billion deficit projected) highlight the importance of Schools and Communities First (SCF), a November ballot initiative the League has worked hard to support. SCF will bring billions to communities in our state facing devastating cuts to essential workers, local services (first responders, public hospitals) and schools. While protecting homeowners and renters, small businesses and agriculture from changes, SCF targets the 6% of commercial and industrial properties that have not been paying their fair share of taxes. It closes corporate loopholes benefiting those at the very top while supporting deserving front-line workers.

What will remain the same will be League's focus on voting rights, campaign finance reforms, diversity, equity and inclusion.

Voter's Edge will continue to put your ballot in the palm of your hand and will, as well, provide candidate and vote center information. Our mission to register, educate and empower voters and defend democracy continues.

As our year of presidency winds down, we express heartfelt appreciation for the League team (Board, off-Board and sustaining members) that has worked so hard to address this year's challenges. We hope that the coming months will give us all an opportunity to view in person the excellent LWV 100th Anniversary history panels created by member Gail Nishimura. We fervently hope and will work proactively for a fall election that is safe, accessible and fair.

Board Bytes - May 6, 2020

Discussed

- Eleanor Yick offered to continue to host meetings using her Zoom account while other software and the benefits of purchase are explored. SC County Council may purchase a Zoom account for all five Leagues.
- Details such as delegates were discussed for the LWVUS Convention being conducted using Zoom. Our League will also apply for an award on the 100 Year Exhibition display.
- Details for conducting the June 2020 Annual Meeting were explored such as how to vote in a Zoom meeting. It was decided not to have a speaker this year.



Reports/Announcements:

- Two years of web site fees were paid along with the domain name due to LWVC delays. Liability insurance was also paid. Our League received SC County grant award for the 100-Year Exhibit Gail Nishimura assembled.
- To increase enumerators for the Census 2020, Leagues have been asked to volunteer five to seven members for phone banks.
- Candidate Forums and Pro & Cons will be conducted using Zoom and recorded for availability to the public. People who can do hand signs for the deaf or hard of hearing are needed. LWVC will produce a *Voter's Guide* for the elections.
- The *Bay Area Monitor* needs financial help due to donors dwindling due to the pandemic. More emails from LWVBA on this will follow for future discussion.

Approved:

- The annual budget, to be presented at the 2020 Annual Meeting, was voted approval unanimously. Appreciation was given to the Picrauxs for all the work they have done on the budget.
- There are more questions about Voter's Edge financial spending. All agreed we need to learn more about Vote411 possibly at Convention. The Board unanimously approved a \$500 contribution for this year.

Natural Resources - League Promotes Environmental Health

Do you think that mercury should be allowed to foul our air? Neither does the League of Women Voters of the United States (LWVUS). In fact, in 2011 the League launched the “Clean Air Promise Campaign”—about the dangers of harmful pollutants like “mercury and other air toxics that created a growing threat to the health of our children and seniors.” Yet the past few years have seen elimination of the legal justification for restricting mercury emissions from power plants. Another 99 other efforts to revoke or roll back environmental protections have proceeded during those years, according to a New York Times analysis (search term: “100 environmental rules reversed”).

Clean water? “Yes” said LWVUS, whose activists helped pass the landmark Clean Water Act (CWA) in the early 1970s, and then worked to strengthen it through the 1990s. Yet, pollution protections for certain tributaries and wetlands regulated under the CWA have been scaled back. A rule that prevented coal companies from dumping mining debris into local streams has been revoked. A rule that required groundwater protections (regarding certain uranium mines’ operations) has been withdrawn. Opening up 1,500 acres outside the Grand Canyon to nuclear production has been proposed.

Energy and fuel efficiency standards, greenhouse gas restrictions, and water efficiency standards have been weakened or eliminated. Flood standards have been revoked that formerly required the government to account for sea level rise and other climate change effects.

The League continues to promote forward-looking policies that protect our natural resources. League policies at state and federal levels envision high standards for protection in such areas as climate change, oil/gas exploration and development, air quality, energy, and water use. Voter's Edge Update

Voter's Edge is a voter resource site and an integral educational program for the League of Women Voters. The website is used by voters to research the legislative priorities of their local, state, and federal candidates. With the primary election behind us, it is obvious that Voter's Edge was a much-used tool for voters when researching their options.

Here is what I learned while working with candidates to get their information onto the Voter's Edge site for the primaries.

- Most candidates no longer maintain telephone numbers for their campaigns. Much of our outreach to candidates was done directly to their social media accounts and email. Most candidates needed four to ten invitations to place their info on Voter's Edge. In other

words, consistent contact and nudging was required.

- The incumbents seemed to be the least likely to put their updated info on the site. Their info used was from past elections.
- We need to use every member of the League who has contact with a candidate to make sure they know about Voter's Edge and encourage them to participate.

How can you help Voter's Edge get ready for the November 3 election? The work for the November elections will begin mid-July. There should be several online training sessions. If you would like to learn the web-based software used to put content on Voter's Edge, please send me an email. Also, if you know of candidates who are running for office in November, please let them know about Voter's Edge.

ACTION – In March, Congress worked to add \$400 million in aid to states to address necessary policies to safeguard our elections during the COVID-19 public health crisis. The November election is quickly approaching, and it is imperative Congress provides the necessary funding to transform our election system to respond to this crisis, and ensure voting remains fair, accessible, and safe.

City & Town Council Observers

Reports on Council meetings are from participation in meetings being conducted by teleconferencing due to the coronavirus.

Los Gatos: Town Council began using the Zoom platform for meetings. Each council member now appears on screen from their home. Staff members are available audibly. Residents may participate in the Zoom meetings by registering prior to the meeting via email with their requests to participate. Residents are then sent reply emails with instructions on how to join the meeting when their agenda items of interest are being discussed. Alternatively, residents may participate audibly, via phone rather than video.

Saratoga: May 6 – The Council passed a referendum to make the month of May 2020 the National Heritage Preservation Month. This will be designated with points of interest markers to be placed at Caledonia Paste Board Mill, Ohlone

Indians, Wildwood Park, Saloons, and the Saratoga Paper Mill at Big Basin Street.

The Council noted the completion of the Prospect Road Improvements Project and approved the contract for the Mt. Eden Annual Repair Project.

May 21 – The Council declared May 2020 as National Foster Care Month as California has 20,000 children placed with resource foster care parents who provide appropriate homes and care.

The Mayor opened the floor to public comments and opinions on whether to postpone today's hearing on the Mountain Winery Annexation Project. The public requested the issue be discussed after the pandemic limitations end to have in-person comments rather than in a Zoom meeting. Due to the controversial nature of the Mt. Winery Annexation, this meeting was extended and continued until 2:30 A.M.

The Council decided, however, to explain and comment officially on the facts, as well as the pros and cons, of the annexation based on the *California Open Space Advisory Planning Commission Recommendations*, determined to be mostly non-beneficial for the City of Saratoga.

At their conclusion, Council Members reached a consensus to vote on the Annexation with the result that it did not pass. The Annexation issue failed with three no and two yes votes.

Healthcare? Major Presidential Candidates

Joe Biden proposes protecting and building on the *Affordable Care Act* instead of switching to a Medicare for All system.

Biden's campaign website says about the *Affordable Care Act*: "Because of Obamacare, over 100 million people no longer have to worry that an insurance company will deny coverage or charge higher premiums just because they have a pre-existing condition – whether cancer or diabetes or heart disease or a mental health challenge. Insurance companies can no longer set annual or lifetime limits on coverage. Roughly 20 million additional Americans obtained the peace of mind that comes with health insurance. Young people who are in transition from school to a job have the option to stay covered by their parents' plan until age 26. But, every day over the past nine years, the *Affordable Care Act* has been under relentless attack. As president, Biden

will protect the *Affordable Care Act* from these continued attacks. He opposes every effort to get rid of this historic law—including efforts by Republicans, and efforts by Democrats. Instead of starting from scratch and getting rid of private insurance, he has a plan to build on the *Affordable Care Act* by giving Americans more choice, reducing health care costs, and making our health care system less complex to navigate." Biden also wrote on a Medium web post that he would lower the Medicare eligibility age to 60.

Donald Trump's campaign website says that during his first term, Trump has worked on "providing Americans the healthcare they need" and "improving access to affordable, quality healthcare."

The website says: "The Department of Agriculture provided more than \$1 billion in fiscal year 2017 to be

used to improve access to health care services for 2.5 million people in rural communities. President Trump mobilized his entire Administration to address drug addiction and opioid abuse by directing the declaration of a Nationwide Public Health Emergency. President Trump signed an Executive order to reform the United States healthcare system to take the first steps to expand choices and alternatives to Obamacare plans and increase competition to bring down costs for consumers. Under President Trump, The FDA has approved the most number of generic drugs in history in order to increase competition in the marketplace and lower the cost of prescription drugs for all Americans."

Leagues around the country have seen a rise in voter purge litigation over the past few years. State and local Leagues have joined litigation in response to actions filed by third-party think tanks seeking to force voter roll purges. Leagues have also initiated lawsuits to ensure that voter list maintenance practices are done reasonably and in compliance with the *National Voter Registration Act*. The NVRA requires list maintenance be undertaken with due care and respect for the right to vote. LWVC – All-mail Ballots in California

The coming election is the first one in which all registered California voters will receive Vote-by-Mail ballots without asking for one. This is a change for about half of all California voters.

Other changes are anticipated such as the nature and location of in-person vote centers or polling places, perhaps changes to voter registration deadlines or type of ballots given to the voter who registers on election day. As we know, running elections is complex.

Inaccurate information is floating around in national media. This leads to a significant need for League and other groups that educate voters to give them the knowledge and confidence to participate in this election.

As the California Legislature, the Governor and Secretary of State finalize the plans for the election, materials will be developed for Leagues to use.
