VOTING BASICS

TO VOTE IN MICHIGAN, YOU MUST BE

- U.S. citizen, at least 18 years old on Election Day
- Resident of Michigan and your city for 30 days
- Not currently serving a sentence in jail or prison
- Registered to vote (you may register to vote up to and including Election Day)

YOU CAN REGISTER

- In person at your clerk's office, online at www.michigan.gov/vote, by mail, or at any Michigan Secretary of State office.
- You **must** register in person at your local clerk's office beginning two weeks before and up to 8 pm on Election Day.

IF YOU MOVE

- *Within the city:* Notify the city clerk
- *To a different city:* Re-register there

VOTING BEFORE ELECTION DAY

- No-excuse absentee ballots are available 45 days before an election. You may also choose to be placed on a permanent absentee voting list.
- If voting absentee, **sign** the envelope and ensure that your ballot is received in your city clerk's office by 8 pm on Election Day.
- Recent constitutional amendments will soon allow more ways to vote absentee and early voting. Contact your city clerk for information.
