We must keep what works and tweak what doesn't and create a master plan for a thriving responsible fiscal ability and functioning infrastructure.

We need to create a master plan for the next 1, 3, 5, and 10 years to ensure that in 2031 our town is providing all the adequate services, including in schools during a heat wave.

3. Multigenerational interactions

I have lived in a four generational family almost my whole life. Family, history, and connections among the generations is one of the most important things we can do to have a better present and future.

I am a family woman, a devoted wife to A.J. for 20 years, a mother to David (12) and Eve (10) studying at Epstein Hillel School and Leia (5) attending pre-school at the NSJCC. I am also a dedicated daughter to my parents and a hard-working member of my community. I believe that multigenerational connections are what makes a community thrive and are a fundamental fabric of our society.

If there is one thing, we learned from this past year is that the most important thing in life are connections with our loved ones. The first day a grandchild hugged their grandparent after COVID-19 restrictions, will forever be treasured by millions of people. I will promote cooperation and expansion of services for the elderly and the young and enhance multigenerational interactions.

4. Promoting and securing our town's unique history.

- i. Police need to be strong and equipped with the best possible people and equipment to protect the community and themselves against violence.
- ii. Community has the right to feel safe with their protectors.
- iii. Police, community, and health care workers work together to find best practices to address the various mental, health and safety issues of the community.

7. Honest leadership promoting cooperation.

I am known in Marblehead as someone who is not afraid to say her opinions and debate the other side with facts and respect. We must communicate with each other our communities will suffer.

From experience I know that only through cooperation things get done. As a board member I will cooperate with the offices of the town, the local businesses, and the residents to ensure that Marblehead keeps its uniqueness and continues to grow and thrive into the future.
