



# Voting Safely and Securely in the November 2020 Election

## Richland and Lexington Counties

**All South Carolina registered voters are eligible to vote absentee in the November 3, 2020, election. Registered voters have three ways to vote.**

### 1. Early In-Person Absentee Voting

Beginning October 5, you can complete an application for voting absentee and cast your vote in one stop at 2020 Hampton Street in Columbia (Richland County residents) or at 605 W. Main Street in Lexington (Lexington County residents). You also have the choice of voting at one of several satellite locations. Be sure to bring a photo ID and wear a mask.

### 2. Absentee Voting by Mail

This is a four-step process. To ensure your ballot is received by the deadline, begin today!

**Step 1** Download and print an absentee ballot application online at [scvotes.gov](https://scvotes.gov). Or, you can call Richland County (803-576-2240) or Lexington County (803-785-8361) to request an application. The application will be mailed to you.

**Step 2** Complete and sign the application and mail it to your county voter registration & elections office as soon as possible. You may also hand-deliver it to 2020 Hampton Street in Columbia or 605 W. Main Street in Lexington or to one of the satellite locations. Applications for absentee ballots must be received before October 24 if submitted by mail or by October 30 if delivered by an authorized representative\* of the voter.

**Step 3** Absentee ballots will be mailed approximately 30 days before the election.

**Step 4** When you receive your ballot, complete it, and sign the voter's oath on the second envelope. To make sure your ballot is counted get a witness signature. Return your ballot as soon as possible to your county voter registration & elections office by mail or in person. In Richland County mail-in ballots can also be delivered in person to one of the satellite locations through November 2. Absentee ballots must be received at the county voter registration & elections office by 7:00 p.m. on November 3. Do not take your absentee ballot to your precinct.

You can check the status of your absentee ballot application or your ballot at [scvotes.gov](https://scvotes.gov). Click on "Check Absentee Ballot."

### 3. Voting at Your Precinct on November 3

Visit [VOTE411.org](https://VOTE411.org) or [scvotes.gov](https://scvotes.gov) to find your polling location. Be sure to bring a photo ID and wear a mask. If you can, avoid busy times before and after work and during lunch hours.

### **\*Authorized Representative/Authorized Returnee**

A voter who is unable to go to the polls because of illness or disability can authorize another registered voter to request an application for an absentee ballot, return the application, and/or return the voter's absentee by mail ballot. Visit [scvotes.gov](http://scvotes.gov) or call your county voter registration & elections office for more information.

### **Voters with Disabilities**

Any voter who is unable to enter a polling location or stand in line because of age or a physical handicap can vote in their car in the closest available parking space.
