Greetings and Best Wishes for the New Year!

The 2020 elections saw the greatest voter participation in more than century, and the League worked hard all year to make our democracy work. The Delaware County Bureau of Elections processed over 330,000 ballots, a record voter turnout rate of 77.6%! The League's nonpartisan election site VOTE411 helped more than 6 million users find the information they needed to cast their ballots.

Thank you to all our dedicated League members, friends and the Delaware County Election Administration who worked tirelessly to expand and protect voting rights under the most challenging of circumstances. You can view the Delaware County election results <u>here</u>.

This upswing in voter engagement is also reflected by our recent partnerships with local community non-profits in Delaware County. This year we have been sharing our programs with the memberships of three non-profits: Swarthmore Senior Citizen's Association, NAACP Media Branch and Media Fellowship House. NAACP Media Branch is also serving on the Civic Education Committee and working on its programing from the inception. We are thrilled to collaborate and extend our reach in Delaware County.

We are presenting compelling programs for January and February 2021 that address many important issues in Delaware County: deprivatization of the county prison, how to run for public office, and the latest on redistricting in Pennsylvania.

The County Jail Oversight Board (CJOB) and Delaware County Council has agreed to deprivatize George W. Hill Correctional Facility and the county is moving to put the transition process in motion. Join our Hot Topic Discussion on Thursday, Jan. 14, at noon, with Delaware County Councilman Kevin Madden, and Brian Corson, a member of the County Jail Oversight Board, to discuss this transition and other potential reforms at George Hill. ## Redistricting Pennsylvania After the 2020 Census

Fair Districts PA Chair Carol Kuniholm, a state LWV board member, will discuss "Redistricting in 2021: What's Happening Now?" at a Zoom virtual Hot Topics event Friday, Feb. 5 at noon.

Fair Districts PA and its affiliated organizations, including LWV, lost the fight to amend the Pennsylvania Constitution to establish a nonpartisan commission to redistrict congressional and state election districts in time for the 2020 census.

The congressional districts drawn by the Pennsylvania Supreme Court for the 2018

and 2020 elections have now expired and the task of redrawing the lines for the 18 districts goes back to the Republican-controlled state Legislature. Democratic Governor Tom Wolf has to sign off on new districts as well. In addition, the census results are expected to cause the loss of a congressional district Two bills introduced in the 2019-2020 legislative session to establish a nonpartisan commission by statute have not received votes in either Pennsylvania house, and will

have to be reintroduced.

At the same time, the Legislature is halfway through the process of amending the state Constitution to establish judicial districts to elect Superior, Commonwealth and Supreme Court judges. If the Legislature approves the proposed constitutional amendment for a second time in the upcoming session, it will be put up for a public referendum as early as this year. LWVPA oppos-

es the amendment as being another opportunity

for gerrymandering by the minority party. Currently the judges are elected statewide.

## The County Health Department is Almost Here

Delaware County Council Vice Chair Dr. Monica Taylor told us on a Zoom Hot Topics event in December that despite the pandemic, the county plans to have a public health department with 50 to 60 employees up and running by the beginning of 2022.

This is an objective the League of Women Voters has advocated for and supported for at least 12 years.

Dr. Taylor presented an extensive plan, which the county is implementing, to put a health department in place that serves all the residents of the county in the areas of mental health, maternal and infant health, children's health, treatment for drug and alcohol abuse and COVID-19 vaccination and testing. This ambitious program builds on the small Delco Intercommunity Health Coordination Initiative currently in place and the work that the Chester County Health De-

partment has done in monitoring and reporting on Delco's COVID-19 epidemic in the absence of a functioning county department.

The first steps to establishing a county health department are to apply for state approval and seed money for the new department, which is in progress, and to implement a strategy to obtain public-private grants, Dr. Taylor said.

The Health Department Working Group is coordinating with municipal health departments, and with hospitals, schools and other existing health care infrastructure, she explained.

The group will seek public support over the coming months with the aim of engaging the public in the planning process, she said.

The Delaware County LWV is participating in the planning process with the Working Group.

### Look at What We Did! - LWV's 2020 Election Achievements

Take a moment and celebrate the achievements of our local LWV Leagues in our 100th year and during the most difficult presidential election in anyone's memory:

- Early in 2020, the County League and LWV-CDC recruited 50 volunteers to demonstrate the new voting machines at libraries and senior centers. That process had barely started when it was shut down by the pandemic.
- Our Voter Services Committee Marita Green, Kathleen Peterson, Kathy Knight and Marilyn Gilroy — organized the writing and posting of 1,000 postcards to addresses with no voter registrations to urge recipients to register.
- They registered voters or worked with college officials to register students at Cheyney University, Delaware County Community College, Neuman University and Penn State Brandywine.
- The committee also worked with county prison officials to register eligible detainees and help them obtain mail-in ballots.
- LWV also supported the Delco Youth Education Alliance, founded by a new student LWV member, Kayla Cocci, who organized voter registration drives at high schools and a church. Kayla also organized the Media Women's March in October.
- Marita, Joanna Nealon, Kathy Youngman and Anne Mosakowski organized and carried out four Zoom candidates' forums. Those forums were put on YouTube and viewed hundreds of times before the election.
- Some members courageously worked at the polls or

counted ballots, exposing themselves to COVID-19, during both the postponed primary election and the Nov. 3 general election.

- The County League's primary election voter survey generated more than a dozen recommendations for the general election, most of which were adopted by the county election board. It is doing another survey for the general election.
- Our website volunteers, Anne, Mosakowski, Cathy Youngman and Olivia Thorne, created a new website for the LWV of Delaware County website and kept our two sites up to the minute with important election information and news.
- Our sister League, Radnor LWV, produced ninety 15second election information spots that were posted on Facebook and Instagram.
- League members attended all Delco Election Board meetings in-person or on Zoom to let them know the public was watching as they made crucial election decisions.
- Finally, thanks to our tech-savvy members, the local Leagues did not miss a beat, carrying on with a full set of events despite pandemic restrictions.

Everyone involved in all of these efforts deserves a heartfelt round of applause!
