The Hot Topic What's Up in PA: Dynamics Driving PA Legislation in 2024 will be presented on Friday, Jan. 26, at Noon on Zoom. Our presenters are PA Representative Carol Kazeem (159th House District) and PA Senator Amanda Cappelletti (17th Senate District). Both legislators will share their committee work and upcoming legislation.

Representative Kazeem represents Delaware County consisting of the City of Chester and the townships of Lower Chichester and Upper Chichester and the boroughs of Eddystone, Marcus Hook, Parkside and Trainer. Carol is a resident of Chester. She graduated from Ridley High School in 2010.

She then went on to Keiser University for paralegal training and Anthem College for medical coding. She

worked in healthcare for over 10 years as a caregiver, medical coder, and behavioral and mental health specialist. Before she was elected to the State House in 2021, she served as a traumainformed outreach worker and violence interrupter in the city of Chester. She serves on the following committees:

- Subcommittee on Career and Technical Education
- Environmental Resources & Energy
- Local Government
- Subcommittee on Boroughs

Senator Cappelletti represents Radnor Township in Delaware County and most of Montgomery County. Amanda is an attorney with a Master's in Public Health. She has worked in Harrisburg to advance progressive policy. She worked as a Fellow for the ACLU of Pennsylvania, in the governor's office and at the Department of Human Services as an advocate for children. She also

served as director of policy for Planned Parenthood advocating for reproductive health. In 2017, Sen. Cappelletti was elected to East Norriton's Board of Supervisors and was elected to the Senate in 2019. A life-long resident of Pennsylvania, she grew up in Boyertown and graduated from Boyertown Area Senior High. She attended

### County LWV Creates Environmental Clearinghouse

Thanks to CDC President Anne Mosakowski, who wrote the grant application, the Delaware County League of Women Voters has received a grant from the state League, PALWV, to create an environmental clearinghouse for all county environmental groups and the public to use.

The site will keep the public informed of developments affecting the City of Chester and Delaware County, such as a proposed LNG export terminal in Chester, a proposed hydrogen hub that manufactures high volumes of hydrogen fuel, proposed for South Philadelphia, the County Sustainability Commission's master plan, and the county's upcoming 10-year "Zero waste" solid waste plan.

It is also intended for organizations it to use to recruit volunteers, to join forces with environmental allies, to publicize their issues and events and to inform one another.

In addition, Delaware County residents will be able to use the site to find out who their municipal officials are and what their municipalities do about trash collection, recycling, single-use plastic bags, composting, shredding and electronic recycling days.

The LWV of Delaware County, the umbrella organization for the county's two local leagues, received the grant from PALWV as part of the state League's efforts to "Reimagine

sustainability" and promote environmentalism around the state. Since receiving the grant, members of the LWVDC Environment Committee have been working feverishly with two website developers to create the site.

The workhorses on the site development have been LWVDC President Olivia Thorne, site developers Jim Furst and Sophie Greer, Environment Committee Chair Carol Butler and Committee Members David Director, John Shaw, Jodine Mayberry and Debbie Bergen.

Debbie will be the chief webmaster of the site to start. We are hoping to obtain additional grant money to operate and improve the site later. Other members of the committee who have contributed their insights and ideas to the site include Cynthia Jetter,

Linda Carpenter and Roberta Winters.

#### Civic Education Project and New Voters Guide on Tap

The programs will be presented Saturday March 2 and Wednesday March 6. Broomall Manor Life Enrichment Director Sonia Sherrod reached out to the League, saying the residents would like to learn more about elections, the voting process and local government.

Copies of the handbook will be printed for the Broomall attendees, thanks to a grant from the Delaware County League of Women Voters (our two local Leagues' umbrella organization) and a small grant from LWVCDC.

If this program is successful, we may be able to offer it to other residential communities and schools as well.
