2020 Primary Results, a Horror Story for November?

According to a report we received from County Councilwoman Christine Reuther who is the council liaison with the Election Bureau:

It took two full weeks after Election day, June 2, to count all of the 126,853 ballots cast by mail or at polling places.

Of the 55,630 mail-in ballots cast, 76 percent were cast by Democrats and 23 percent by Republicans. Of the 71,223 ballots cast at polling places, 73 percent of Republicans voted in person and 46 percent of Democrats did so.

By June 14, 12 days after the election, the Delaware County Election Bureau had only just completed counting the in-person and mail-in ballots and had not begun to count the 7,700 provisional ballots cast. That count took another week to 10 days but did not change the election outcomes.

Many of those provisional ballots may have been people who requested mail-in ballots but then decided to cast their votes in person. Those voters had to vote provisionally and leave it to the Election Bureau post-election to determine if they had also cast mail-in votes.

Of the 90,000 mail-in or absentee ballots requested, only 55,630 were voted. That is, only 62 percent were cast so more than 1 in 3 were not cast.

The 35,000 plus mail-in ballots not cast were considered "spoilage." They were either ballots not received by voters, ballots received but not returned and ballots returned too late to be counted.

These results were for a rather low-participation primary election in which the two nominees for president were a foregone conclusion.

The Nov. 3 General Election is going to be a whopper. As of Aug. 10, there are 407,285 registered voters in Delaware County, 199,066 Democrats, 155,857 Republicans and 52,000 unaffiliated or other. Presumably most or all of them will want to vote in November.

With all of the controversy about the Post Office, many of those who signed up for mail-in ballots for the general election may be regretting that choice and planning to go to the polls after all. If they do, their ballots will be cast provisionally and may not be counted for weeks after the election.

Delaware County is trying to cope by purchasing 50 drop boxes to be distributed around the county where people can drop off their ballots and bypass the Postal Service.

The county also plans to re-establish regular polling places and it has purchased a high-speed sorter to sort the mail-in ballots by precinct. It is also moving the Election Bureau to the Wharf in Chester where workers will have more room to send and count ballots.

The Election Bureau needs poll workers and ballot counting volunteers of both parties. If you feel comfortable despite the COVID crisis, please volunteer. The Census — Still Happening, Still Important

Delaware County has only had an overall 63 percent self-reported response to the 2020 Census and now door knockers will be going door to door to try to collect the remaining 38 percent of responses. The bad news is the door-knocking program will end a full month early, on Sept. 30., this time.

The worst census responses are in Upper Darby, Yeadon, and Chester, just the areas that the U.S. government needs data from the most, but the low response rate will affect us all throughout the county in terms of congressional representation, education,

health care funding and anti-poverty measures.

Chester's response rate was 44 percent in comparison to wealthy Rose Valley's 87 percent response rate.

Welcome census takers if they come knocking. Census takers will be wearing masks and valid government ID badges with their photographs and a U.S. Department of Commerce watermark.

People can still self-respond at <u>2020census.gov</u> or by calling 844-330-2020. If you Haven't yet done so, please respond. It only takes a couple of minutes but will benefit you and your neighbors for the next 10 years.

We're as Busy as Can Be

Despite the coronavirus crisis, LWV-CDC members have been very busy preparing for the upcoming election, attending the online national LWV convention and developing local initiatives.

- The committee is also working with a Ridley High School student who is arranging to register ageeligible students in the parking lots of local high schools.

Here are three candidates' forums the committee has lined up so far. Ballots go out starting in mid-September and people will be marking their choices and sending them back so if you are in any of these districts, you may want to watch the forums first.

- Wednesday Sept. 16 at 7 p.m.: 17th Senate District challengers Democrat Amanda Cappelletti and Republican Ellen Fisher. This is an open seat.
- Thursday Sept. 17, 7 p.m.: 165th Legislative District incumbent Democrat Jennifer O'Mara and Republican challenger Robert Smythe Jr.
- Sunday Oct. 4, 3 p.m.: 166th Legislative District incumbent Democrat Greg Vitali and Republican challenger Christine Boyle.
