**KATHLEEN BAKER - SECRETARY**



Artist, educator and activist, Kathleen Baker retired as a National Board Certified Teacher – Music/Early and Middle Childhood – from Arlington and Alexandria, VA Public Schools in 2011. Her early work in researching, writing and performing education programs on women in American history led to founding the professional company, Opera Americana, which worked to acclaim from 1986 for ten years. As a classroom teacher, her creative multidisciplinary approach inspired student-created operas on science, mathematics and social studies, recognized by National Board Certification in Early and Middle Childhood Music. The Alexandria Arts Alliance and Alexandria’s Sister City program with Caen, France, thrive today since their founding with Kathleen’s leadership. She was named a Living Legend of Alexandria in 2015.

In Delaware, she has served as her condominium association President and continues to Chair the Advocacy Team. Active with the Southern Delaware Alliance for Racial Justice and the League of Women Voters of Delaware, Kathleen leads the Book Club for Browseabout Books in Rehoboth Beach.

**LINDA BARNETT- 2ND VICE PRESIDENT**



Linda joined the LWVNCC in the summer of 2015. She has become an active member of the Advocacy Corps, focusing primarily on legislative proposals dealing with education and social policy. Linda is also active in the American Association of University Women. Her term as President of the AAUW Wilmington Branch ends June 30, after which she will take the post of Financial Officer for the Branch. Linda has lived in Delaware since 1978, working for the Delaware Department of Health and Social Services as a planner for over 35 years. She and her husband made a variety of locales home prior to settling in Delaware – including Gainesville, Florida; Los Angeles; Flagstaff, Arizona; and Omaha, Nebraska (moves prompted by her husband’s career as a Sociologist and then Professor of Law). She is now a member of the Lobby Corp.

## **SUE CLAIRE HARPER - CO-PRESIDENT**



Sue Claire Harper joined the Board of the LWVSC soon after moving to Rehoboth in 2011, serving on a variety of committees including Voter Services, Common Core Initiatives and the Observer Corps. In November 2014, she became chair of the Land Use Committee whose focus was to invite knowledgeable speakers to participate in public educational forums wherein Sussex County residents could learn about the myriad components involved in the drafting of the 2018 Comprehensive Plan. A key aspect of these 16 forums was to educate and encourage residents on how they could share their views with their appointed and elected officials so that the final draft of the Comp Plan reflected their vision as to what is desirable for Sussex County's future. With Governor Carney's signing of the 2018 Comprehensive Plan on March 19, 2019, Sue Claire stepped down as chair of the Land Use Committee, as it had fulfilled its charter.

Prior to her retirement, Sue Claire was a registered nurse, certified in rehabilitation and case management. For 40 years, she lived and raised her family in Madison, NJ where she was active in multiple community organizations. When her children entered school, she became active with the Madison parent-teacher organizations, including stints as both vice-president and president. In addition, Sue Claire helped found a non-profit adult daycare center for dependent adults, serving as its first executive director.

In her leisure time Sue Claire derives immense pleasure traveling abroad in the company of her teenage grandsons, attending Osher classes, working in her garden and maintaining her 20 year yoga practice. She also volunteers at All Saints Thrift Shop and serves as a volunteer driver for ITN of Southern Delaware.

## **KYRA HOFFNER - DIRECTOR**



Kyra Hoffner, a member of LWVDE Advocacy Corps since June of 2018, is committed to social justice change through advocacy. For the League Day 2019, she coordinated the visits of LWV members to elected officials and staff in a successful initiative to introduce the League's general membership to lobbying at Legislative Hall.

Kyra serves as the volunteer Coordinator for the Delaware Cannabis Advocacy Network, holding over 60 informational meetings per year since 2016 throughout Delaware. 
## ELLEN WASFI - DIRECTOR

A native New Yorker, Ellen Wasfi received her B.A. from Barnard College with a joint major in sociology and history, and her M.A. in International Relations from The Johns Hopkins School of Advanced International Studies. She was a Fulbright exchange scholar in Merida, Venezuela, and worked as a research consultant for the US Senate Foreign Relations Committee and the US Senate-House Joint Economic Committee where she authored two studies on the US aid program in Latin America.

Ellen has served on the state board for the last four years. She has been a board member of the League of Women Voters of Kent County for 32 years and served as its president for over 15 years. She has moderated the League's Candidate Night debates and initiated the Dover League's monitoring of Resident Advisory Council Elections at sites of both the Delaware and Dover Housing Authorities. She chairs the League of Women Voters of Kent County International Relations Committee, moderates its Great Decisions discussion program on global issues, and has taught courses on foreign policy to Dover public school teachers under the Capital School District's in-service program. In 1992-95, she was appointed to the State of Delaware Social Studies Curriculum Frameworks Commission which revised and updated the State's elementary and secondary school social studies program.

She has served on the Capital School District's Diversity Committee and has been a facilitator and administrator for YWCA Study Circles on Racism and Race Relations in Kent County. She was on the organizing committee of SURJ (Stand Up for What's Right and Just), the statewide effort to reform Delaware's criminal justice system. She has been awarded the Central Delaware NAACP Community Service Award, the DEMCO (Delaware Multicultural and Civic Organization) Shofar Award for public service, and in 2010, LWVDE honored her with its Flame of Democracy Award. In 2002, she was appointed by the Dover City Council to the Dover Human Relations Commission where she currently serves as Commissioner.

## JOHN HARDIN "JACK" YOUNG - DIRECTOR



Jack is a resident of Rehoboth Beach. **Under Social Policy:** Support for methods of financing public education that will promote equal opportunity for quality education and improve both the local districts' and state's budgeting while maintaining a (high) level of local control.

## **Under Health Care**

### **End of Life Options**

Support for state laws that grant the option for a terminally ill person to request medical assistance from a relevant, licensed physician to end one's life and that such legislation should include safeguards against abuse for the dying and/or medical personnel.

**Position adopted by concurrence with LWV Utah position at April, 2019 state board meeting.**

**Continuing Study:** A study of the financing and delivery of health care in Delaware (with emphasis on following the work of the Delaware Health Care Commission and its related committees and the activities of the Delaware Center for Health Innovation).

The LWVDE also acts under the LWVUS health care position: "Promote a health care system for the United States that provides access to a basic level of care for all U.S. residents and controls health care costs."

### **Proposed recommended new study item: Alternative Election Methodologies**

**Proposed:** LWVDE take up a broad overview study of alternative election methodologies, with a goal of selecting for further study any of those methodologies that appear to have promise to improve the democratic process in Delaware. Such alternative election methodologies include Ranked-Choice Voting (RCV; also known as Instant Runoff Voting, or IRV), approval voting, and proportional voting (multi-representative districts).

## **Proposed Amendments to Bylaws:**

### **Article V Board of Directors**

#### **Section 5. Regular meetings**

There shall be at least 6 (4) regular meetings of the Board of Directors annually to include meetings convened in March and April in preparation for the scheduled Council or Convention.

#### **Section 9. Electronic Voting**

Delete current e. (Board members who do not have access to electronic mail must be polled by telephone or in person with background information having been supplied.)

Current f. would become e.

- Improving our election system to allow all citizen voices to be heard!
- The National Popular Vote Compact: Basing the Electoral College on the popular vote.
- Securing Clean Water and sound infrastructure.
- Clean Energy supplied through Renewable Portfolio Standards (RPS) and Green Power.

**ADVOCACY UPDATES - will take place at the Convention**

**LEAGUE OF WOMEN VOTERS OF DELAWARE, INC  
A SUMMARY OF CURRENT STATE PROGRAM 2017- 2019**

**STATE GOVERNMENT**

**Delaware General Assembly** - Support of measures to promote a more effective and responsive legislative branch of state government, including strengthening the committee system and use of the budgetary process to review and evaluate state programs.

**Ethics** - Support of ethics legislation in the areas of campaign finance, conflict of interest, financial disclosure and lobbying disclosure.

**Delaware State Constitution** - Support of a Constitution for the State of Delaware which would be confined to broad principles and would promote more efficient and responsive government.

**Public/Private Partnerships** - Support the use of public/private partnerships by governments in Delaware if a project can be better undertaken with public/private cooperation. Public input, careful controls and adequate safeguards need to be part of these partnerships.

**Reapportionment/Redistricting** - Support for an open unbiased process for reapportionment and redistricting with opportunities for public participation.

**SOCIAL POLICY**

**Justice System - Continuing Study: *A re-evaluation of Delaware's criminal justice system and the impact of the current policies and practices on society. (Action will continue to be taken under LWVDE current position***

*(Adopted at convention June 2017)*

*The study is worded intentionally broad so that the study committee can start where its sees the most effective effort and timeliness.*

Support for the adoption of consistent policies which, within budgetary constraints, will permit the disposition of offenders in the best interests of society, the victim(s), and the offenders and their families.

We oppose mandatory sentencing.

We support the expansion of drug courts and mental health courts for all nonviolent offenders and the appropriate science based health and mental health treatment of all offenders.

**Family Court, Related State Programs for Children, Domestic Violence** - Support of uniformity in operation of the Family Court system; automatic expungement of certain juvenile records; state provided diagnostic services, care, education and treatment to age 21 for youths and young adults who have mental or physical illness or who are developmentally delayed or are substance abusers or abused/neglected; strong educational programs on the rights of victims of family violence.

**Before and After School Child Care** - Support for state government involvement in encouraging, establishing and/or supporting child care programs.

**Financing Public Education** - Support for methods of financing public education that will promote equal opportunity for quality education and improve both the local districts' and state's budgeting while maintaining a high level of local control.

**Education - Continuing Study: *A study of the public education system in Delaware with special focus on financing, charter schools, and transparency and accountability to citizens.*** *(Adopted at convention June 2017)*

**Gun Control** - Protect the health and safety of citizens through limiting the accessibility and regulating the ownership of handguns and semiautomatic weapons. Support regulation of firearms for consumer safety. (LWVUS position applies)

**Health Care: New Study: *A study of the financing and delivery of health care in Delaware with emphasis on following the work of the Delaware Health Care Commission and its related committees and the activities of the Delaware Center for Health Innovation.*** *(Adopted at convention June 2017)*

LWVDE also acts under the LWVUS health care position: "Promote a health care system for the United States that provides access to a basic level of care for all U.S. residents and controls health care costs."

**Needle Exchange Programs** - Support for comprehensive needle exchange programs, which also offer education and referrals to appropriate services, as part of a public health effort to reduce the spread of infectious diseases such as HIV/AIDS and Hepatitis C.

**Public School Libraries** - Support policies and funding for public school library media centers that promote their central role in providing equal opportunity for all children to achieve educational excellence.

## **ENERGY/CLIMATE CHANGE**

**Renewable Energy Portfolio** – Support for an increase in the percentage of renewable energy sources in Delaware's Renewable Energy Portfolio Standard (RPS) provided that they: have minimum environmental impact; use the best current technology as measured by reliability, proven effectiveness, and being state-of-the-art; have long range cost effectiveness including all net costs such as health and environmental costs, state and federal subsidies, and price stability. Support of measures ensuring that total electricity sales in Delaware be required to meet the RPS.

**Support aggressive increases, by increments, of the percentage goals of renewable energy resources of electricity sold in Delaware beyond the goal of 25% renewable energy resources by 2025, with increased goals for 2035 and 2050. (Updated 6/2017)**

**Transmission and Distribution** – Support for maximizing the development and delivery of renewable energy to Delaware when designing and developing new transmission plans for the region. In addition to delivering reliable, adequate electric service to Delaware, the key factors to be considered in making a decision on any transmission plan/transmission enhancements are: Degree of environmental impact; Degree of utilization of the transmission for renewable resource power vs. fossil- fuel generated power; True cost, including all cost- externalities; Safety and security of the grid.

**Energy/Climate Change** – Support for an aggressive and comprehensive energy use/climate change plan for Delaware. Some key points that should be included:

Accelerate bringing new green businesses, jobs and industries to Delaware, and investigate emerging energy technologies. Set targets and a timetable for reducing Delaware's total greenhouse gas emissions. Plan for extensive adaptation measures at all levels of government for climate change impacts that cannot be avoided---especially sea level rise.

**Support increasing the currently recommended 2030 goal for reducing Delaware's emissions of all greenhouse gases from 30% to a larger percentage, e.g., 40-45%, relative to 2008. A longer-term goal should be set and be significantly higher, e.g. 80% by 2050, relative to 2008. (Updated 6/2017)**

Support public education and outreach; expand renewable energy and climate change in Delaware curriculum standards. As Delaware calculates energy costs, full life cycle analyses\* with all externalities\*\* must be included. Social and economic justice must be considered in implementing energy and climate change policy.

**The Regional Greenhouse Gas Initiative (RGGI)** involves pricing carbon dioxide (CO<sub>2</sub>) emissions from electricity generation in Delaware and eight other Mid-Atlantic and Northeastern states. It uses a system of cap and trade, and now has a decreasing emissions cap of 2.5% per year. The League supports decreasing the RGGI cap by 5% per year, starting 2021 through 2030. (6/2017)

**The Transportation and Climate Initiative (TCI)** is similar to RGGI in that it is a regional effort to reduce carbon emissions from the transportation sector. The League supports Delaware having an increasing price on carbon emissions from transportation fuels - especially on a regional basis - provided that some of that revenue is used to ease the burden on low-income families, such as offering gas stamps, or returning part or all of the revenue as a rebate to adult residents on a per capita basis; to promote walkable/bikeable communities; to be used for refurbishing transportation infrastructure; to stimulate research and innovation; to encourage vehicle energy efficiency; to provide additional electrical charging stations for hybrid and all-electric vehicles; to develop economic opportunities and create jobs. (6/2017)

## **NATURAL RESOURCES**

Support of policies that protect air and water quality, and reduce solid waste.

**COASTAL ZONE** - Support for Coastal Zone planning which considers the best possible outcome for people, the land, and the coastal environment.

**CRITICAL LAND AREAS** - Support for preservation and/or protection of certain critical areas (ecologically fragile estuaries and coastal areas, farmland, flood plain, aquifers, and natural areas); erosion and sedimentation controls; and coordination among all levels of government in decisions involving major facilities.

**FARMLAND** - Support of a farmland preservation program.

**LAND USE/TRANSPORTATION** - Support of the regulation of growth and optimum use of land through comprehensive planning policy. Monitoring of land use policies and procedures and their relationship to human needs, population trends, transportation planning, and ecological and socioeconomic factors. Encouragement of continuing cooperation among governmental agencies.

Support of a balanced, intermodal transportation system interconnected with land use and based on interagency and inter-jurisdictional coordination.

Support reducing transportation-generated greenhouse gas emissions by wiser land use planning and by enhancing public transit options.

Some key points that should be included:

Direct development towards growth zones, except for environmentally sensitive areas within those growth zones; assure availability of infrastructure, services and walkability before developing. - Build compact, or dense, development within established development areas in which pedestrians can safely and conveniently access services; reduce vehicle miles

traveled (VMT). - Modify Delaware's paratransit fee schedule to establish separate classifications for ADA\* and non-ADA\*\* service. - Reform the system to establish fairer pricing for non-ADA paratransit use. - Tighten eligibility requirements for all paratransit use in situations where the state has discretion. Establish a dedicated funding stream for public transit; explore a variety of funding sources.
