Leadership/Membership Development – presenter: Deborah McMillan, LWVUS board member

Deborah Macmillan, the national coach working with the local Leagues in the League of Women Voters of Delaware's Membership and Leadership Development program, looks forward to meeting Delaware Leaguers in person at Delaware's state convention. In addition to her work at the national, state, and local levels in the MLD program, she is also president of her own local LWV of East Windsor-Hightstown in central New Jersey and a member of the LWVNJ Committee on Immigration. In the past she served as state president for LWVNJ and as a member of the LWVUS study committee on immigration. She is retired from a career in academics and survey/market research. She particularly appreciates the chance to broaden her knowledge of Delaware and its Leagues as her prior knowledge was restricted to passing

through on Interstate 95 and US 13, conducting research for DuPont in Wilmington, and canoeing and birding in Delaware's state parks and wildlife refuges.

# Learn How to Read and Understand a Financial Report – presenter : Cheryl Carncross of Brandywine Accounting

Cheryl A. Carncross CPA MST – is currently the senor tax accountant at Brandywine Accounting LLC. Cheryl holds a B.S. in Accounting from the State University of New York at Buffalo. She also holds a M.S. in Taxation from Widener University. Cheryl has several years experience in both the private sector and public accounting. Keynote Speaker: Ed Kee, Delaware Secretary of Agriculture. He has been given the premise of the LWVUS study and questions that will update our agriculture policy positions adopted in 1988. Local Leagues will be invited to participate in this important League study later in 2013.

Delaware Secretary of Agriculture Ed Kee has spent his entire career in Delaware agriculture and has headed the Department of Agriculture since 2009. He worked as an extension agent for the University of Delaware from 1978 to 2008, and worked for Hanover Foods until being appointed

Secretary by Gov. Jack Markell.

Secretary Kee is a nationally and internationally recognized expert on vegetable science, with more than 30 articles in scholarly journals. He is the author of two books - "Delaware Farming," which includes a collection of historic photographs of First State agriculture, and "Saving Our Harvest: The History of the Mid-Atlantic Canning and Freezing Industry."

He is has been the recipient of the Ratledge Award for Outstanding Public Service from the University of Delaware; the Secretary's Award for Distinguished Service to Agriculture from former Secretary of Agriculture Michael Scuse; and the Edward H. Ralph Medal of Achievement from the Delmarva Poultry Industry.

A sixth-generation Delawarean, Secretary Kee is a 1969 graduate of William Penn High School. He holds a bachelor's of science, a master's degree in agriculture, and a master's degree in liberal studies from the University of Delaware. He lives on a farm near Lincoln with his wife, Debbie.

For the last eight years Janet has been the Board member and treasurer for the Attention Deficit Disorder Association (ADDA) and in this capacity she represented ADDA in a partnership with DCJ which conducts a pilot program for the diagnosis and treatment of ADHD in inmates into Delaware correctional facilities and expands ADHD treatment capacity in the Delaware community. Her major area of interest in retirement is health and justice public policy as it impacts the chronically ill.

She also cochaired the LWVDE Membership Recruitment Initiative and is now a Shur Fellow/National Coach for Kentucky and Oklahoma in the LWVUS Membership/Leadership Development program.

In Washington, DC, Sandy served on the DC Habitat for Humanity Board, chaired its Development Committee, and was Board Secretary. Sandy was a registered lobbyist in Washington during her career with the National Association of Counties, the California Department of Transportation, Amtrak, the Association for Commuter Transportation (ACT) and others. As Executive Director of ACT, she lobbied for six years to secure an amendment to the federal Tax Code to allow employers to provide tax-free transit passes, as well as carpool and vanpool benefits. That law is now used widely throughout the nation, including Delaware, to secure private/employer subsidies for commuting benefits.

Lester recently retired as the State Operations Manager for the USDA Natural Resources Conservation Service in Delaware where he was responsible for managing and directing all NRCS field operational functions involved in developing and implementing a comprehensive conservation program for Delaware. The state board recommends the readoption of the current program listed in the Convention book.

The state board recommends:

A study of the public education system in Delaware with special focus on financing; charter schools; and transparency and accountability to citizens.

# **PROPOSED AMENDMENTS TO THE LWVDE Bylaws**

**NOTE-** the 2011 language is in non bolded type and proposed changes are **bolded** and *italicized*. Eliminated areas are in strike through.

#### Article IV Officers

**SECTION 5. THE TREASURER**. The Treasurer, or her/his duly appointed assistant, shall collect and receive all moneys due. The Treasurer shall be custodian of these moneys, shall deposit them in a bank or banks designated by the Board of Directors and shall disburse the same only upon order of the Board of Directors. If the office of treasurer is vacated, the LWVDE Board President shall assume the functions and responsibilities of that office until the President is able to appoint a new treasurer.

In the situation where a financial professional is employed by the LWVDE to perform the bookkeeping functions of the LWVDE, the Treasurer shall approve all invoices and service contracts for payment in addition to his/her responsibilities which include oversight for the timely payment of vendors, PMPs, other invoices; oversight of timely invoicing for shared expense and timely applications, registrations, and submissions for state registrations and the IRS. The Treasurer shall report to the Board at the time the applications, registrations and other financial legal documents are submitted. Copies of the applications, registrations, and copies of the receipt shall be placed in the LWVDE file and retained for the appropriate period of time according to the LWVDE Policies and Procedures.

The Treasurer shall present periodic statements to the Board at its regular meetings, and an annual report to the Convention. The books of the Treasurer shall be audited biannually at the end of each term **and may be subject to an internal audit anytime on request of the LWVDE Finance Committee approved by the LWVDE Board.** 

#### **Article VIII Financial Administration**

SECTION 1. FISCAL YEAR. The fiscal year of the League of Women Voters of Delaware shall be July 1 to June 30.

**SECTION 2. BUDGET**. The Board shall submit to the Convention for adoption a budget for the ensuing two years. A copy of the budget shall be sent to each local League President within one week following the regularly scheduled April State Board Meeting in that year.

**SECTION 3. BUDGET COMMITTEE** *FINANCE COMMITTEE* The budget shall be prepared by a committee which shall be appointed for that purpose at least four months in advance of the Convention by the Finance Committee which shall be appointed after the LWVDE Convention by the LWVDE President with approval of the LWVDE Board. The Treasurer shall be an ex-officio member of the Budget Finance Committee but shall not be eligible to serve as chairman.

In addition to developing the LWVDE budget, the Finance Committee shall provide ongoing fiscal oversight of financial transactions, including recommendations, planning and oversight of audits and shall provide quarterly reports to the Board in regard to LWVDE fiscal affairs. The Financial Committee shall review all contracts which will require funding by LWVDE and evaluate proposals for all non-budgeted acquisitions, and report to the Board concerning the fiscal impact of the contract and acquisition.

#### LOCAL LEAGUE HIGHLIGHTS

#### Sussex Forums Address Fair Housing.

At the first of two recent public forums, Amy Walls, President of the Diamond State Land Trust and a member of LWVSC, discussed the background and outcome of the Diamond State Community Land Trust law suit and fair housing complaint that led to a recent settlement between Sussex County and the U.S. Department of Justice and voluntary compliance agreement with the US Department of Housing and Urban Development. A second LWVSC forum on the topic featured Nick Mirro, from the state Division of Human Relations, who gave a comprehensive and fact-filled presentation, comparing Delaware's law with that of the federal government. He also outlined the role of the Human Relations Division in implementing and enforcing the law as well as advising citizens on their rights vs. when they may not have a fair housing case. Last of Sussex Education Forums The last in the series of six "*Education in Sussex County*" forums that the Sussex League has sponsored was held in Georgetown on March 16<sup>th</sup>. It addressed inequities in school financing. The speakers were Nancy Feichtl, an educator with very wide experience in Sussex County school administration, retired Senator George Bunting, Rep. Timothy Dukes, both with a strong interest in education, and Kevin Carson, a highly experienced education consultant in Delaware.

Everyone agreed that the cause of the inequity among Sussex school districts is the way equalization funds are allocated. They are based on the property tax base in each district. This is a problem because there has not been a property reassessment since 1974, and land values in Sussex County have changed dramatically in that time-- as have the poverty levels. The equalization formula does not reflect this. Everyone agreed that this was the cause of the lack of equality in county school funding. Unfortunately, they also agreed that politicians would regard it as political suicide if they pressed for reassessment. This inequity problem was also a hot topic at League Day in Dover, and it is one aspect of a proposed state education study that will be considered at the LWVDE Convention on May 18.

2. Senate Bill 16 will require lost or stolen guns to be reported within 48 hours of discovery and will help reduce "straw purchases" that traffic guns to those who otherwise would not pass a background check. This is an important measure that will reduce "straw purchases," where guns are purchased on behalf of those who would not pass a background check and later claimed to be lost or stolen by the purchaser. We make it too easy for corrupt gun owners to traffic guns by claiming to police that they "lost" a gun when in reality they sold it to a criminal. For law enforcement officers investigating gun crimes, this ready-made excuse stops their crime investigation dead in its tracks. **Recent Delaware polling data shows** overwhelming support (86%) for this legislation.

3. HB 58 (limiting high-capacity magazines) This bill would prohibit the manufacture, sale, purchase, transfer or delivery of large-capacity magazines, which are defined as ammunition feeding devices with the capacity to accept more than 10 rounds.

HB 35 passes Senate. Thank you for your support and outreach! Supporters of sensible gun laws designed to reduce gun violence in Delaware achieved an important legislative victory this week.

House Bill 35, which will require background checks for almost all sales of guns in Delaware and help keep guns out of the wrong hands, passed the Delaware State Senate on Thursday, April 18, by a vote of 13-8. Please thank those senators who supported the bill. HB 35 now awaits signature by Governor Markell, which is expected.

Thank YOU for your support and outreach to legislators. Your phone calls and emails to legislators do make a difference! We have achieved an important victory in Delaware, but please don't give up the fight for common sense solutions to prevent gun violence.

#### ACTION ALERT!!!!!

On Wednesday, after hearing 2 hours of moving testimony, the House Judiciary Committee took no action on Senate Bill 19, the bill which would repeal the death penalty in Delaware.

Nearly 100 supporters of repeal gathered at legislative hall in support of SB 19, but the measure needs to be signed out of committee before it can be voted on by the Delaware House of Representatives. We need your help to ensure that happens. This bill deserves a chance to be heard.

We urge you to contact your Representative and **urge them to release SB 19 from committee to allow for a full floor debate**. A full text of the legislation can be found <u>here</u>.

**SB 48 would create an 11 member Independent Redistricting Commission.** The League supports this bill with reservations because it is a major initial step towards an improved process.
