REDISTRICTING

People Powered Fair Maps Redistricting Campaign

Interested in learning how to make maps? Volunteer with the LWVDE People Powered Fair Maps campaign to join with other volunteers and partners to learn how to use Dave's Redistricting App (DRA), free mapping software to make a map of legislative districts. The LWVDE Redistricting Committee has a

tutorial sponsored by LWVUS and led by Dave himself.

Volunteers are encouraged to draw maps to suggest to the Redistricting Committee and its partners as we join the LWVUS Fair Maps 50-state plus DC project aimed at eliminating Gerrymandering and supporting transparency and fair practices in the decennial redistricting using 2020 Census data.

While we wait for the updated 2020 data that is expected to become available around April 1, 2021, we will be practicing with 2018 data from the Census' American Community Survey. We plan to buy Maptitude, the software the legislature will be using. Practice maps from DRA can be imported into Maptitude when we get the Census data. The cost is half the normal \$10,000 price -- \$5,000 for non-profits; \$2500 is budgeted from our grant from LWVUS. The rest is projected to come from additional grants or contributions.

Currently, the Committee is conducting Zoom meetings with prospective partners aimed at building a broad and representative partnership that will help us identify communities of interest and advocate for fair maps when the legislature begins its work.

The LWVDE Committee is comprised of Denise Davis, our new Redistricting Coordinator, and Kyra Hoffner, Jack Young, Nancy Lopez, Maren Bertelsen, Letty Diswood, and Sandy Spence, Chair. Mitch Crane and Jack Young have developed a draft redistricting/transparency bill and we will seek sponsors to pre-file the bill in December.





ACTION NETWORK

With our current situation the League of Women Voters of Delaware is still hard at work. Our new normal has taken us away from in person lobbying of our elected officials. ADVOCACY CORPS PLANS VIRTUAL LEAGUE DAY 2021

In light of current circumstances, our **annual League Day** is being re-envisioned to take place in virtual form via Zoom.

No one wants to sit at the computer for hours at a time, and it is unhealthy to do so. Thus, we will be creating several short programs to be held at varying times. So actually, we will be hosting League DAYS, rather than the prior League DAY!

The specific issues we will address in these programs are being finalized, but as always, we will focus on key issues facing our state – hoping to stimulate viewers to address critical problems facing Delaware in new ways and to offer new approaches to solve them. We also plan to hold one session in which some of our new legislators can introduce themselves to the public.

The specific dates and times for these sessions have not yet been set, but our target is during March and April. As a deviation from prior practice, we will not be charging a registration fee to view these programs, although there will be some expenses. Thus, we will be suggesting that donations would be welcome to help cover costs. An opportunity to make a donation to the memory of someone or in someone's honor will be included. Organizations, as in the past, will be invited to serve as co-sponsors, to have their name and logo included in program materials and on the League website – for a contribution. This is a way to help cover costs and spread awareness of the event.

IN THE SPOTLIGHT: CANDIDATE FORUMS HELD DURING COVID RESTRICTIONS

LWVKC/DE held five Candidates Nights in October 2020, via Zoom. LWVKC sponsored the forums for State Senate, State Representative and Kent County Levy Court and Clerk of the Peace. LWVDE sponsored one debate for U.S. Senator and U.S. Representative and another for Governor, Lt. Governor and Insurance Commissioner. Organization cosponsors included AAUW, Dover Branch, NAACP Central Delaware Branch #2028, The Alumni Council of the National Pan-Hellenic Council and Restoring Central Dover. Some questions were submitted via e-mail and some were borrowed from the League's Vote 411 website. Dr. Phyllis Edamatsu and Carylin Brinkley were timekeepers for all five debates. Our technology experts, Dr. Mary Ann Coe and Chandra Owens managed the virtual forums from beginning to end.

The Phone Calling Committee comprised of Jean Bauer, Gwen Elliot, Mary Merritt, Gale White and Dr. Mary Kay Eggers began contacting the candidates in September when the Delaware Department of Elections published the list of candidates qualified to be on the ballot for the November general election. Invitations and debate guidelines were sent out via e-mail along with the Agreement to Participate, which the candidates had to sign and return. Beverly Jackson collated these responses. Joan and Fred Breukelman formatted all the documents and e-mailed them to the candidates – a Herculean task!

Some of the challenges encountered were:

1) Having to make multiple phone calls to candidates to get a firm commitment to participate in Candidates Night. This has been an ongoing issue even before the advent of "virtual" debates. (Continued on page 4 *Forum*)

- 2) Some candidates indicated they did not receive the invitations. One reason may have been that the e-mail addresses they supplied to the Department of Elections were not in current use. Another possibility could be that the documents were sent from the Breukelman's e-mail address and may have been deleted because the recipient did not recognize the sender. Several invitations had to be resent after follow-up phone calls. In the future, we should use an LWV return e-mail address.
- 3) We encountered a unique situation wherein a candidate for U.S. Senate made an appearance just prior to the start of the debate and then abruptly departed. She had previously submitted the signed Agreement to Participate. The League had no choice but to inform her lone opponent that he would not be able to proceed because of the "Empty Chair" rule. He was gracious in expressing his understanding of the League's policy. LWVDE did send him an explanatory letter apologizing for the inconvenience.
- 4) A decision had to be made on whether to livestream the debates. There was a concern about how to manage incoming questions and the chat room. The Committee decided to record the Candidates Nights for later viewing. In the future more training could be offered during the planning process so that League volunteers will feel at ease with the livestreaming technology.

The five virtual Candidates Nights for 2020 sponsored by LWVKC and LWVDE were successful overall, despite multiple challenges, and lessons were learned on how to plan for future debates. It was a concerted team effort that won praise from several candidates and enabled grassroots democracy to flourish in Delaware.

ELECTION COMMITTEE – HIGHLIGHTS

Election turnout in Delaware increased from 65% to 72% during the 2020 election, and we hope that efforts by the LWVDE Election Committee contributed to the increase. Members of the LWVDE Election and Voting Committee (Kim Wells, Alan Evantash, Patti Christopher, Karen Barker, Connie Jones, and Jill Itzkowitz) hosted 20 webinars to over 500 diverse participants. We reviewed how to vote during COVID with corporate groups like JPMORGAN, civic groups like AAUW and the rotary club, libraries, and senior centers. We discussed the importance of voting with students from Delaware Tech, University of Delaware, the GED program, and Wilmington Job Corps. We also sent several emails to our membership explaining the rules for voting this year. We also participated in the national voter registration day and voter registration activities during the Delaware Art Loop. Watch our YouTube video https://youtu.be/8MqSqHuwz2k.

We sent letters and emails to the Governor, members of the Legislature, and the media to ensure our 2020 elections were safe during COVID. This resulted in Delawareans being able to vote by absentee or by mail. The committee looks forward to working on passing a permanent vote by mail bill during the next legislative session. Dear Members and Friends,

With your help and involvement, we had a terrific $2020-100^{th}$ Anniversary of the founding of LWV and adoption of the 19^{th} Amendment! Thank you.

2021 is a once-in-a-decade year when the U.S. Bureau of the Census provides data from the 2020 Census for redistricting of our State House and Senate as well as county and many localities. We have received a grant from the LWVUS to fund Delaware's role in the national "People-Powered Fair Maps" project to address redistricting. But our League has developed an ambitious project which requires at least \$4,000 more to cover essential software to assure that this 2021 redistricting process is truly fair and representative.

Our Advocacy Corps has already been busy developing additional priorities for 2021 including such urgent issues as climate change, working with the Smart Justice Coalition and helping develop more productive solutions to the challenges related to policing, while keeping our communities safe.

Although, we keep a tight fist on our expenses, grants cover specific activities and do not pay for the basics required just to keep the organization operating – rent, telephone, computers, office equipment, insurance, and our new website: https://my.lwv.org/delaware.

As of June, 2019 the League of Women Voters of Delaware and the LWVDE Education Fund merged into a single 501c3 entity, so all donations are now tax deductible. And a provision of the 2020 tax bill allows up to \$300 in charitable donations even if you don't itemize. Checks or Pay Pal are happily accepted. Our donation page is attached.
