The League of Women Voters of Delaware is very disappointed with the recent Delaware Supreme Court ruling that made vote by mail and same day registration unconstitutional. To help you navigate voting now, this issue contains links and information regarding ways you can vote in November. This is an important election because all the seats in the General Assembly are up for re-election. Delaware's future is in your hands.

WAYS TO VOTE IN DELAWARE 2022

There are many new ways to vote in the primary and the general election this year. You can vote early, vote absentee, or go to the polls. Just open the links below to find out how.

- 1. <u>Early Voting</u>: Beginning in 2022, Delaware voters can vote ten days prior to Election Day. Launch the link to find early voting sites and dates <u>Early voting sites and dates</u>. Plan an event with family and friends to vote together and then go out and celebrate. See page two for details.
- 2. <u>Absentee Voting:</u> Delaware voters can vote absentee if they are sick or disabled, in the military, a college student, on vacation, incarcerated, or at work, including providing constant care at home for a child, spouse, or parent. Launch the link to find out how you can request an absentee ballot. <u>absentee voting</u>. You can also go to <u>ivote Delaware to request</u> an absentee ballot and check the status of your absentee ballot.
- **3.** <u>Vote at the polls:</u> Go to <u>ivote Delaware and enter your address to find your polling place. Your polling place might have changed due to redistricting and polling modifications made by the Department of Elections.</u>



LWVDE STATEMENT ON SUPREME COURT RULING FROM STATE MEMBER JACK YOUNG

DELAWARE SUPREME COURT DECLARES VOTE BY MAIL AND SAME DAY REGISTRATION UNCONSITUTIONAL.

The Delaware Supreme Court on December 7th decided that vote by mail and same-day registration laws passed by the General Assembly in June are unconstitutional. The decision is three pages long with a longer opinion to follow shortly. The decision prevents the Department of Elections from sending out ballots, which it intended to start on October 10th. For the vote by mail (VBM) law, the Court found that the legislation "impermissibly expands the categories of absentee voters identified" in the state constitution. Interestingly, while the Chancery Court ruled the VBM law unconstitutional, the Vice Chancellor upheld the same day registration legislation. The Supreme Court, however, also declared that law unconstitutional.

The Court held:

- 1. The Vote-by-Mail Statute impermissibly expands the categories of absentee voters identified in Article V, Section 4A of the Delaware Constitution. Therefore, the judgment of the Court of Chancery that the Vote-by-Mail Statute violates the Delaware Constitution should be affirmed.
- 2. The Same-Day Registration Statute conflicts with the provisions of Article V, Section 4 of the Delaware Constitution. Consequently, the judgment of the Court of Chancery that the Same-Day Registration Statute does not violate the Delaware Constitution should be reversed.

The Court's decision means that advocates of VBM and same day registration will return to the General Assembly to start the constitutional amendment process under De. Const. Art. XVI. The amendment process requires passage of the amendment by two-thirds vote of all members of each House in two successive sessions of the General Assembly.

The Delaware Supreme Court's decision also reinforces the role of both the legislature and the courts in the consideration of voting rights legislation. Here, the General Assembly passed the VBM and same day registration bills which led to the Delaware Supreme Court declaring the legislation unconstitutional under the Delaware Constitution. The fidelity to separation of powers principles is at the heart of a North Carolina case (*Moore* v. *Harper*) before the U.S. Supreme Court this term. In Moore, the petitioners are arguing that the legislature alone under the "independent state legislative theory" has the ability to determine certain voting rights matters (in *Moore* the case involves redistricting). The Supreme Court's decision in *Moore* will set the stage on how voting rights cases are decided in the future.

President's Message - Gwendolyn Miller



Thank you to everyone who made the 2022 National Convention a time of community, action, and inspiration. At the election, new Board members were seated. Meet three key LWVUS Board and Staff members who have assisted and supported our State and Local leagues on important matters: Dianna Wynn, Morgan Murray, and Caren Short.

Dianna Wynn, LWVUS Liaison

Earlier this week, I met with **Dianna Wynn** (she/her), the LWVUS Board member assigned to LWV Delaware, to serve as our liaison between LWVUS and LWVDE. Dianna's particular area of expertise is group dynamics. She has been tasked to help facilitate our State, and Local Leagues through challenges or problems should the need arise.

Dianna commits to the following:

- Sharing all relevant information, she learns from LWVUS Board calls.
- Sharing our concerns with the Board or the staff and following up with the relevant committee.
- Speaking at our Council, state convention, or State Board meetings; and
- Visiting Delaware State and Local leagues upon request.

Morgan Murray, Program Coordinator (she/her) is the Program Coordinator at LWVUS. She is responsible for administering grant programs and supporting State and Local Leagues across the county on the national redistricting campaign and other election-related initiatives.

She wants us to know that she'll be our point person on the national staff for any issues/concerns you have leading up to and including Election Day.

Morgan has requested that we contact her as a first step if we have any major concerns or news to share about how the election is going (good or bad) or if we need assistance responding to any issues urgently affecting voters.

The major concerns and issues to raise include the following:

- Last-minute changes (polling location changes or not opening on time, issues with mail-in ballots); messages we can help elevate nationally on social media or relay to the national press.
- Irregularities (turnout, problems, reports of broken machines, spreading of mis- and disinformation).
- Tension at the polls (presence of weapons, hostile individuals, protests).
- Any good news: photos or social posts that demonstrate a smooth-running election; and
- Any intent to file a lawsuit.

Caren Short (she/her/hers) is the Director of Legal and Research for the League of Women Voters of the United States. She manages a team of legal and technical experts working to oversee, innovate, and support the League's state and federal litigation dockets. (Continued on page 6 *President's Message*)

RECEPTION FOR ELECTED OFFICIALS

Monday, December 5, 2022 5:30 - 8:30 p.m. Ed Oliver Golf Club, 800 N. Dupont Road, Wilmington

Every other year (except for 2020) over the course of the past decade, three "good government" groups — Delaware Coalition for Open Government, Delaware Press Association, and the Leagues of Women Voters of Delaware and New Castle County — have joined together as the prime sponsors of the Elected Officials Reception, held on the first Monday in December after the biennial November elections. The event is open to the public.

All elected officials – state, county, municipal – are invited to attend the reception to meet the public and to give the members of the public an opportunity to meet their elected representatives and discuss ideas on numerous "quality of life" issues that are facing us all.

There will be food (cheese & crackers, fruit, and vegetable platters with dip, as well as a variety of other tasty hors d'oeuvres), beverages, and a cash bar. We also have a nominal entry fee of \$5 for all who attend, including those from co-sponsoring organizations – except the elected officials and the individuals who are co-sponsors. Look out for details to attend closer to the event.

New Data Based on Redistricting Data Reveals Where People in Delaware Prisons Resided before Incarceration.

The Prison Policy Initiative, along with Delaware advocates Kyra Hoffner and Jack Young of the League of Women Voters People Powered Redistricting Project, released a new report, Where people in prison come from: The geography of mass incarceration in Delaware, that provides an in-depth look at where people incarcerated in Delaware state prisons come from. The report also provides six detailed data tables that serve as a foundation for advocates, organizers, policymakers, data journalists, academics, and others to analyze how incarceration relates to other factors of community well-being.

The data and report are made possible by the <u>state's landmark 2010 law</u> that requires that people in state prisons be counted as residents of their hometown rather than in cells when state and local governments redistrict every ten years.

The report shows:


- All three counties and every state legislative district are missing a portion of their population to incarceration in state prison.
- Wilmington has the distinction of having both the highest number of city residents incarcerated as well as the highest incarceration rate of any city in the state.
- Mass incarceration is not just a problem impacting large cities. Many smaller towns are also hit hard. Laurel, for example, has an incarceration rate of 1,227 per 100,000 residents, while Blades has a rate of 924 per 100,000 residents.

Data tables included in the report provide residence information for people in Delaware state prisons at the time of the 2020 Census, offering the clearest look ever at which communities are most impacted by mass incarceration. They break down the number of people locked up by county, city, zip code, legislative district, and census tract.

The data show the cities with the highest incarceration rates are Wilmington (1,299 per 100,000 residents), Seaford (748 per 100,000 residents) and Dover (680 per 100,000 residents). For comparison, Newark has the lowest incarceration rate of any city, at 131 per 100,000 residents, nearly ten times lower than Wilmington and nearly three times lower than the state rate of 380 per 100,000 residents.

Incarceration in Delaware is not just confined to the most populous cities: people living all over the state are locked up at high rates

Wilmington, Dover, and Seaford are home to the most people in prison, but across the state, people living in small towns and communities outside of city boundaries are affected by the state's reliance on mass incarceration.

The report cites studies that show that incarceration rates correlate with a variety of negative outcomes, including higher rates of asthma, depression, lower standardized test scores, reduced life expectancy and more. The data included in this report gives researchers the tools they need to better understand how these correlations play out in Delaware.

Delaware is one of more than a dozen states and 200 local governments that have addressed the practice of "prison gerrymandering," which gives disproportional political clout to state and local districts that contain prisons at the expense of all of the other areas of the state. In total, roughly half the country now lives in a place that has taken action to address prison gerrymandering.

LWV of Delaware Board votes to sign onto amicus brief on case (Moore v. Harper)

LWVUS is finalizing an amicus brief on a case (*Moore v. Harper*), and they requested that all State Leagues "sign on" in support of that brief.

This case addresses whether voting issues involving election to federal offices come solely within the auspices of a state legislature or if a state's judicial system has standing to review laws passed by its state legislature. The petitioners are arguing that the legislature alone, under the "independent state legislative theory," has the authority to determine such voting rights matters (in *Moore* the case involves redistricting).

The LWVUS position will be against the "Independent State Legislature Theory."

The decision in this case is expected to be of great relevance to the work of the League as related to voting and elections, which are essentially our signature issues.
