Looking Forward to 2025: The League's Advocacy Agenda November 2024

While many serious issues face our state, one stands out – namely, the mushrooming growth of Delaware's elderly population. For this population, a key problem is obtaining health care which is timely and high quality. Clearly, of course, access to such health care affects all sectors of our state's population – not just the elderly.

What drives this problem is the insufficiency of **health care** providers. And this insufficiency intersects with two other major issues—namely, poor performance in our **public education** system, which is deficient in quality and equity, and a lack of **affordable housing**. Exploring the roots of these three intersecting areas and seeking solutions will be at the top of our advocacy agenda in 2025.

Given this priority, however, we will not ignore other looming areas of concern, starting with **voting rights**. In this arena, our focus will be safeguarding early voting, restoring voting rights after felony incarceration, and implementing voting by mail and same day voter registration.

Another key area is **climate change / energy policy**. Here our priority is to monitor Delaware's offshore wind procurement process and to work toward upgrading the state's solar readiness mandate for buildings.

Our state's **criminal justice system** continues to need serious reform. Our priorities are police transparency and accountability, elimination of fees that disproportionately burden the poor, probation reform to facilitate re-entry into the community, and prohibition of the death penalty by constitutional amendment.

In the overall category of **governmental issues**, we will focus on an office of Independent Inspector General and establishment of a method for redistricting that is independent of legislative influence.

Delaware's precious **natural resources** require ongoing vigilance. For this, we will focus on working to provide meaningful regulatory protection to the approximately 75,000 acres of Delaware freshwater wetlands so that they can continue to absorb storm water, filter pollutants, and provide wildlife and plant habitat.

It is important to note that the priorities listed above do not exclude other significant areas which will also receive vigilant advocacy. These areas include reproductive choice, medical aid in dying, wise land use, and prevention of gun violence.

The Focus for League Days 2025 Successful Delaware: Healthy, Housed, and Educated



League Day 2025 will address Delaware's interrelated shortages of healthcare workers, affordable housing, and quality childcare, as well as poor public education outcomes.

Access to affordable housing and childcare, quality education, and adequate healthcare are foundational for upward mobility and a healthy, economically stable population. When these elements are lacking, it becomes difficult for individuals and families to improve their circumstances and for the state to attract a quality workforce and improve the economic outlook for the state.

Addressing these problems requires a multi-pronged approach that involves investment in education, housing, and healthcare workforce development. Only by tackling all three issues simultaneously can Delaware hope to meet the needs of its residents effectively and equitably.

In 2025, League Day will comprise three ZOOM events and one in-person event, all of which will be open to the public. Each ZOOM event will focus on a specific topic, as shown here:

- Thursday, February 6 Healthcare
- Thursday, February 27 Education
- Thursday, March 20 Housing

The Healthcare, Education, and Housing portfolios will invite presenters for their respective topics. Presenters will discuss the challenges we're facing, what is being done to address them, and recommendations for additional legislative remedies.

Our in-person event will take place in Dover on Wednesday, April 9, with a morning presentation, followed by lunch and an afternoon of lobbying.

We plan to invite speakers to work with us in the morning to identify a strategic plan and recommend timely legislation that would address Delaware's overlapping needs to increase our healthcare workforce, provide adequate housing and childcare, and improve public education outcomes.

Be sure to mark your calendars for these 4 events and come help us discover solutions.

VOTE411 STATUS – 2024 Primary and General Election

- For the 2024 primary election there were 82 candidates, the largest number candidates for a primary. Vote411 had a candidate participation rate of 72% with US Congress race at 20%, statewide races at 80%, state general assembly at 77%, New Castle County races at 90%, Kent County races at 75%, Sussex County races at 77%, and city of Wilmington at 63%. From August through the primary date, 7,300 users accessed Vote411. Of these users 67% were from New Castle County, 27% from Sussex, and 6% from Kent. About 4% of the voters viewed Vote411, and in New Castle County the percentage of voters was 10%.
- For the 2024 general election there were 80 candidates in competitive races. The Vote411 candidate response rate was 68% with the federal offices at 14%, statewide at 100%, and state assembly races at 70% (NCC at 56%, Kent 66%, and Sussex at 83%). During this election, 14,000 users accessed Vote411 which was an increase of 35% from 2022.

It was difficult contacting candidates and getting their attention this year due to the considerable number of surveys and forums organized by many organizations. The 14 LWVDE volunteers did an excellent job of getting the candidates to respond by calling, texting, emailing, and posting on their Facebook and web pages. I would like to thank Karen Barker, Dini Silber, Catriona Binder-Macleod, Janice Heinssen, Alan Evantash, Marj Johnson, Kim Wells, Joyce Ford, Ann Lopez, Susan Mitchell, Letty Diswood, Connie Jones, Linda Barnett, and Susan Curtin for their efforts.

League of Women Voters US Statement on 2024 Election Results

Press Release / Last Updated: November 6, 2024

WASHINGTON — The League of Women Voters of the United States president Dianna Wynn and CEO Celina Stewart released the following statement on the 2024 election results:

"The 2024 election underscores the dedication of poll workers, election officials, and volunteers nationwide, who ensured that every eligible vote was counted, and every voice was heard. This year's election was marked by integrity, transparency, and high turnout. The American people have spoken.

"While we celebrate a fair and secure election, the outcome of this election has made the future for women unclear.

"Given the disturbing rhetoric made during this election season, we are deeply concerned about challenges we may face, particularly regarding the issues that disproportionately affect women, from health care and reproductive rights to economic security and equal representation.

"We are thankful to Leagues across the country for their tremendous work supporting the election infrastructure and supporting voters, as well as every election worker and democracy defender who guaranteed our fair and free voting process. We are thankful for the work they have done so far this cycle and the counting, curing, and certifying work that will take place in the weeks ahead.

"The League is dedicated to our mission of defending democracy. As we move forward, we remain steadfast in our commitment to advocate for policies that uplift women and ensure equitable representation in all levels of government."
