## Framing our Future LWV Membership Changes

A Summary of Upcoming Changes Prepared for Members of the League of Women Voters of Delaware

In 2025, LWVUS will implement significant changes to League membership and dues structure, which will require certain changes for LWVDE's By-Laws. These changes will be proposed at the May 22 Council.

This document summarizes the changes for LWVDE members and provides context for the Board's recommendations.

- These changes will have greater operational impact on Delaware's three Local Leagues,
- The changes proposed will not go into effect until January 2025.

#### **Specific Changes to Be Made**

- Article III Membership: Section 2: Removing the Student Membership Category
- Article VIII Administration:
  - Section 3: Budget Removing references to the Per Member Payment (PMP) process of determining how and how much Local League Member Dues are to be sent to LWVUS.
  - Section 5: Complete rewrite of this section to remove former language relating to the Per Member Payment System and replace with language that conforms to LWVUS Membership By Laws
- Article X Convention: Section 5 removal of "and per member payment"

# Addressing one of the Crucial Issues of our Time

The League confronted the issue of Mis/Disinformation at League Day in Dover 2024. This event, held in-person for the first time since the Covid 19 pandemic, provided the opportunity for League members to gain an in depth understanding of an issue that is widely discussed and debated around the country – and around the world.

Attendees were exposed to the thinking of six panelists providing their insights into what is happening in Delaware and around the nation when false information is deliberately amplified with the intention to deceive.

The panelists, shown in the accompanying pictures, addressed questions such as:

 What do we need to understand about the current environment wherein disinformation/misinformation is flourishing on the national and international levels?

- How can/should citizens respond to disinformation/misinformation when they see it? Why are people so receptive to it?
- What are the challenges posed by the need to control disinformation/misinformation while ensuring the right to free speech? Indeed, are dis/misinformation "controllable"?
- What more needs to be done in our state and who needs to take ownership to ensure that needed steps are taken?

An illustration of disinformation being distributed in Delaware is contained in the following analysis of disinformation pertaining to Wind Power prepared by League member Peggy Schultz:

According to the Caesar Rodney Institute," Our Delaware beach community urgently needs your attention and support to safeguard our coastline, economy, and marine life from a pressing challenge. This issue impacts everyone who cherishes and visits Delaware's beaches each summer.

"Our Governor and local leaders are on the brink of a decision that could have severe consequences for our beach community. The proposed Maryland-based offshore wind project, intended to bring power ashore in Delaware, poses substantial risks to our economy, property values, and marine environment. (NOTE: This is a Maryland project; power should come ashore in Maryland.)"

The previous statements were contained in a solicitation received by League of Women Voters members, asking for donations to the Caesar Rodney Institute's legal fund. These statements contain information that is misleading and/or incorrect. The analysis below addresses those statements, as well as others contained in the solicitation.

#### THE MISLEADING ISSUES AND THE FACTS:

• **Issue:** Giant industrial wind turbines close to Delaware beaches will change our pristine view and lead to lost tourism and lower property values.

**Response:** Several visual simulations prepared by US Wind for its Marwin /Momentum projects show that the wind turbines are visible from Bethany Beach, but because they are white in color and the seascape is also pale blue to white, the turbines do not have an obtrusive appearance.[ https://www.boem.gov/renewable-energy/state-activities/appendix-visual-simulations] Lower property values because of offshore wind is undocumented; the assertion that offshore wind causes a devaluation in home values is discussed below.

• **Issue:** There is the potential to lose an estimated 24% in tourism revenue, costing Delaware's economy millions and risking jobs.

**Response:** A 2020 study by the University Of Rhode Island shows that the 5 wind turbines just 3.8 miles from Block Island have **added**\_slightly to tourism in the area. [https://digitalcommons.uri.edu/cgi/viewcontent.cgi?article=1104&context=enre\_facpubs]

 Issue: A University of Connecticut report estimates a first-year loss of up to 11% in property values.

**Response:** A 2014 University of Connecticut study finds no evidence that off shore wind turbines negatively affect home prices or sales. [https://today.uconn.edu/2014/01/no-evidence-wind-turbines-depress-property-prices/]

No further University of Connecticut studies were found. We did, however, locate a 2023 article published in *Energy Policy*, that uses "11%" in relation to turbines, though this article discusses onshore wind, and not offshore. Study results show that properties within a mile of a proposed *onshore* wind project experience an average decrease in value of 11% following the announcement of the project, compared to properties located three to five miles away, though the difference fades away after a few years. Could this have been the research to which the writer refers? If so, it not only deals with *on*shore wind, but the turbines are only three to five miles from the homes. #### ADDITIONAL CONCERNS:

• **Issue**: Power cables will enter Delaware instead of Maryland, which is the state that is sponsoring this project.

**Response:** It is correct that the power cables will enter Delaware. However, benefits to Delawareans include cleaner air and other community benefits described briefly below.

• **Issue**: Empty promises have been made by the developer regarding lower electric rates and free energy credits.

Response: It is unclear why these promises are "empty." Such benefits are often required by law in Europe, but in the U.S. they are voluntary. No evidence has been found, and none has been offered by those who oppose this project, to suggest that developers do not follow through on their community benefit promises. Ratepayer costs are written into the contract between the developer and the off-takers, so the developer is obliged to follow the terms of the contract. The ratepayers for this US Wind project are residents of Maryland. In the case of the US Wind proposal to Delaware, US Wind has offered to the state 150,000 Renewable Energy Certificates annually, worth an estimated \$76 million over the life of the project. US Wind says they will spend \$200 million to upgrade the grid, a distinct advantage for Delaware when it solicits bids for its own offshore wind project. US Wind has also agreed to pay the state a lease rental fee of \$350,000 annually for the privilege of making landfall at 3 Rs Beach.

• **Issue:** There will be a negative impact on the Carl N. Shuster, Jr. Horseshoe Crab Reserve and other marine life.

Response: It is true that the two US Wind Maryland projects overlap the Horseshoe Crab Reserve. US Wind reports that turbines for their Marwin and Momentum projects off the southern-most coast of Delaware will be a mile apart. Each turbine will take up a circle 45 feet in diameter. There will be 77 turbines in both projects, for a total of 217,679 square feet, or almost 5 acres devoted to turbines. The entire area is 46,970 acres, so that leaves about 46,965 acres undisturbed. Ideally, clean energy from offshore wind would be totally without an environmental cost, but 5 acres (.01%) out of 46,970 seems not a big price to pay in exchange for adding 1,056.5 MW of clean electricity to the grid, capable of powering 285,000 homes. BOEM, NOAA, and the Marine Mammal Commission all agree that there is no evidence linking whale deaths to offshore wind development activity. Examination of dead whales shows evidence of entanglement in fishermen's nets and collisions with fast-moving cargo ships as major causes of whale mortality .[https://mdcoastdispatch.com/2023/03/02/commission-joins-agencies-in-whale-death-dispute/]

There is some potential of harm to whales during construction, but great care is required during these operations to keep whales safe. Mandatory professional whale watchers are onboard whenever there is a possibility of harm to whales. These whale watchers are empowered to halt all construction activity if a whale is sighted. BOEM also requires bubble curtains to ensure that sounds emanating from construction activity do not harm the whales. Furthermore, the law prohibits offshore wind construction during whale migrations. [https://www.noaa.gov/news-release/noaa-boem-announce-final-north-atlantic-right-whale-and-offshore-wind-strategy]

Research from the University of Rhode Island shows that the offshore wind turbine foundations provide habitat for Black Sea Bass and Atlantic Cod, making the turbines fruitful fishing grounds for sports fishermen.



On April 15, 2024, LWVDE launched the VOTE411 voter guide for the May 14, 2024, Delaware school board elections. There are only 8 elections this year compared to the normal 16 due to the small number of candidates running.

These Delaware school districts will hold school board elections on Tuesday May 14th, 2024:

- New Castle County: Appoquinimink, Christina, Colonial, Red Clay.
- Kent County: Lake Forest, Woodbridge.
- Sussex County: Delmar, Indian River (nominating district 4 only).
