SOUTH CAROLINA VOTER REGISTRATION GUIDE

- 1 Check both boxes. Both must be "yes" to be eligible to register to vote.
- 2 Check the appropriate box. For new voters and those who have moved across county or state lines, check "New Registration".
- 3 Add your name, last name first.
- 4 Check the appropriate boxes for Gender and Race and enter the last 4 digits of your Social Security Number.
- 5 Add your residential address. (For students registering at college, this is your dorm address.)
- 6 IF YOUR MAILING ADDRESS IS DIFFERENT, add yours.
- 7 Add your birth date and a contact phone number.
- 8 IF YOUR NAME HAS CHANGED, add your previous name. IF YOU MOVED FROM ANOTHER COUNTY OR STATE, add your prior county/state of residence (and, if you know it, precinct).
- Preview the Voter Declaration, and then sign and date your application.

Once the form is completed, it should be returned to the applicant's county voter registration office. Delivery can be by fax, mail or personal delivery of the completed form or by emailing a scanned copy of it.



ID Required: If you are registering for the first time in this county, you **must** attach a copy of a current valid photo ID <u>or</u> a copy of a current utility bill, bank statement, paycheck or other government document that shores your name and address in this county. If you do not provide this identification now, you will be required to provide this information when you vote. Vote, who are age 65 and over voters with disabilities, members of the U.S. Uniformed Services or Merchant Marines and their families, and U.S. Citizens residing to side the U.S. are tempt from this requirement.

* Social Security Number (SSN) is required by the S.C. Code § 7-5-170, transactions containing only the last four digits of your SSN will be accepted. Your SSN is used for internal purposes only and eliminates multiple registration of a single individual. Your SSN is not released to any unauthorized individual.
