• 2017 Use of Force Report should be ready in February: 1.6 million traffic stops;

2121 incidents of use of force; 45 officers investigated; 17 fatalities; 15% decrease over last year; 7% decrease in the last 5 years.

There were several public comments opposing the receipt of the donation of drones: The public is opposed to the use of drones because of their ability to collect data, spying on innocent citizens;

Drones contribute to the perception that police are an occupying force meant to control black and brown people;

Suggest wait for environmental impact report, including social/emotional impact, before implementing.

Donations are not subject to oversight by the Police Commission.

Potential conflict of interest – Hugh O'Donnell, one of the board members of the L.A. Police Foundation, works for Motorola, the manufacturer of the drones.
