The focus of the meeting was the latest homeless count and the dispersal of Measure H funds during the last 9 months.

2018 Homeless Count:

- Total homeless individuals in LA County, 53, 195 3% decrease from last count
- Total homeless individuals in City of Los Angeles, 31,516 5% decrease
- SPA 1, 4, 5, and 6 saw decreases
- SPA 2, 3, 7, and 8 saw increases
- 22% increase in people 62 or older
- 75% (39,826) remain unsheltered

Who are they?

- 80% are single adults
- 2/3 identify as male
- 27% report a serious mental illness
- 15% report a substance use disorder
- 65% have been in LA County for more than 20 years
- 75% lived in Los Angeles before becoming homeless
- 6% were fleeing domestic/intimate partner violence
- 9,322 people were experiencing homeless for the first time (an increase from 8,044), 45% for economic reasons
- The data were also broken down by race/ethnicity

Some results:

- Youth housing placements increased 43%
- Veteran homelessness decreased 18%
- Chronic homelessness decreased 16%

Median rent in the county has increased 32% since 2000, while median renter household income has DECREASED 3%. LA County has the highest poverty rate in the state.

Phil Ansell presented the Homeless Initiative Quarterly Report and reviewed the measures taken on various strategies to:

- prevent homelessness
- subsidize housing
- increase income
- provide case management and services
- create a coordinated system
- increase affordable homeless housing
- Measure H administration

LAHSA has also created an Impact Dashboard which will display data in an easy to view graphic format.

The Measure H goal is to house 45,000 people in 5 years across all populations. Currently they have reached 8% of that goal.

- 12,248 people were sheltered or served in interim housing
- 8,220 people were permanently housed (3,350 of these using Measure H funding)
- 5,870 people in families were prevented from becoming homeless (this is a joint project with the Department of Social Services and CalWORKS)
