# Bills on the regular calendar (suggesting there will be debate) include the following:

COMMERCE, HB 250, establishing a committee to consider revisions to the New Hampshire health insurance laws, specifically establishing a commission to assess the benefits and costs of a "health care for all" program for New Hampshire. Committee recommends Inexpedient to Legislate, Vote 3-1. (We apologize for missing the hearing on this bill in our last alert—several people called us to task. Apparently there was much public support in the hearing for establishing this study committee, perhaps even more now that the AHCA federal plan passed the House on May 4, 217-213.)

EDUCATION, HB 356-FN, establishing a committee to study education funding and the cost of an opportunity for an adequate education. Committee recommends Ought to Pass with Amendment, Vote 4-1.

FINANCE, HB 652-FN, establishing a veterans track within the court system and relative to annulment of a sentence imposed by a mental health court. Committee recommends Ought to Pass, Vote 5-0. (While the League's study of women incarcerated in NH didn't specifically address female veterans, we did learn about alternative courts during our study. Our resultant position supported both alternatives to incarceration and specialized courts, such as drug courts and mental health courts, that focus on the underlying issues offenders deal with. The veterans' track in the court system would seem to meet our criteria for improved justice. We support this bill.)

JUDICIARY, HB 640-FN, relative to the penalties for possession of marijuana. Committee recommends Ought to Pass with Amendment, Vote 3-2. For those of age, the possession of a small amount becomes a violation rather than a misdemeanor. The bill as amended from the original version seems to reduce the amount from one ounce to three-fourths ounce as the threshold. The amended bill begins thus: "Reducing the penalty for possessing \(^3\)4 of an ounce

or less of marijuana to a violation and allowing offenders to pay fines by mail will result in less time and resources spent on such cases, allowing police and courts to spend more time and resources dealing with serious crime."

ELECTION LAW, Room 308, Legislative Office Bldg 10:00 a.m. Full committee work session on SB 113, relative to an electronic poll book trial program; (League supports).

Work session on **SB 3**, relative to domicile for voting purposes. <u>League opposes</u> as did nearly all the hundreds of people who came to public hearings on this bill. Executive session may be held throughout the day (very likely). Might include <u>SB 33</u> closes the loophole that allows independent spending groups to avoid registering with the Secretary of State and filing expenditure reports. (League supports closing campaign finance loopholes.)
