Vote411

Vote411.org is the LWV website for candidate information. Information for the upcoming Municipal Election is publicly available in Vote411.org now. November candidates are listed, and candidate responses should be updated by September 9th. Vote411.org contains the same candidate information as our printed *Voters Guide*, but it allows you to see what will be on your ballot based on your

STATE LEAGUE CONVENTION

Our State League (LWVPA) holds a biennial convention to which each League in Pennsylvania may send representatives. This convention discusses the "State of the League", the LWVPA budget, changes to its by-laws, and possible state-level studies. In addition, it provides "breakout sessions" on topics of interest to the individual Pennsylvania Leagues.

The State Convention was held this year, from Friday, June 13th to Sunday, June 15th in Lancaster, PA. Our LWVLA sent three delegates: Jenni Stieler, Teri MacBride, and Dawn Maneval. Jenni is new to our League, so this was her "big introduction" on how the League works. Teri is the experienced one, having been to several state conventions before. Dawn, while not new to the League, had never been to a state convention before. The three of us brought a range of perspectives to the conference.

We gathered lots of information, made new contacts, and got ideas for how to better use the State League to support our own League. As all three of us are members of the LWVLA Board, we hope to incorporate what we learned into the plans for moving our League forward.

LWVUS POLICY: FAIR DISTRICTS

The League stands for fair districts. Here's what LWVUS has said on this issue and what you can do to tell our legislators that we want fairness to determine voting districts:

- **1.** Mid-cycle redistricting threatens the fairness and stability of our democracy.
- District maps should be drawn once every 10 years, after the census, to reflect population changes. Mid-cycle redistricting undermines this stable process and invites partisan manipulation.
- Frequent changes to district lines create confusion for voters, dilute community voices, and can be used to entrench political power at the expense of fair representation.
- Mid-cycle redraws are too often driven by political motivations rather than the needs of communities — they open the door to gerrymandering, where politicians choose their voters instead of voters choosing their leaders.
- **2.** Redistricting must always be transparent, participatory, and community-centered.
- Fair maps must be drawn legally, with public input, and with full transparency; whether during the standard redistricting cycle or in rare cases when a redraw is necessary due to court rulings aimed at correcting legal violations.

- Communities of interest, groups of people with shared interests or identities, must be kept together in a single district where their voices aren't diluted.
- We call on legislators and commissions to hold public hearings, release draft maps, and provide clear explanations for any proposed map changes.
- **3.** Racial equity and legal compliance must remain at the forefront.
- Any redistricting effort, mid-cycle or otherwise, must comply with the Voting Rights Act and protect the voting power of communities of color and lower income communities.
- Mid-cycle changes often disempower historically marginalized communities, including people of color, women, language minorities, and youth. These changes must be closely scrutinized and challenged if they reduce fair representation.
- The League is committed to ensuring that maps are drawn equitably, and that Black, Latino, Indigenous, Asian American, and other communities of color are fully represented and included in the process.
- **4.** Redistricting is a political act, but it must remain nonpartisan.
- The League of Women Voters position on redistricting is rooted in fairness for voters, not political expediency.
- The League has fought for decades to ensure redistricting processes represent voters, not politicians or parties. We will not stop now.
- States have different rules on redistricting, and some state constitutions do not allow for it
- The League can, and will, leverage every tool in our toolbox to make sure, where mid-cycle redistricting occurs, that voters have a say.

Call to Action: Defend Fair Maps Now

- The League urges the public to stay informed and engaged: attend hearings, submit public comments, and join local advocacy efforts to stop unjustified midcycle redistricting.
- Redistricting should serve the people, not politicians. Let's keep the power in the hands of voters, not in the backrooms of political gamesmanship.
- Share the truth: redistricting is just the tool being used, but the real game is trying to keep us from knowing the corruption happening within the highest levels of power in DC.

Contact your legislators to tell them you stand for fair districts!
