OCTOBER FORUM

On October 19th, Robin Stelly from the PA Health Advocacy Network, spoke on "Challenges of Affordable and Accessible Health Care in Pennsylvania." Ms. Stelly credited advocacy by many groups, including general consumers, as driving the 2010 passage of the Affordable Care Act and the 2015 expansion of Medicaid in PA. Similarly, the Inflation Reduction Act of 2022 is a reflection of perseverance and advocacy at work. It created enhanced subsidies, negotiated drug prices, and lower prescription drug costs for some Medicare subscribers for a limited number of drugs. It also expanded eligibility for assistance, lowered premiums so there are fewer people uninsured, and capped insulin costs - for some. Continued advocacy is needed with lawmakers, PA's state-based marketplace (Pennie) and the next Governor's Administration, to lower out of pocket costs for consumers, and prescription drug prices. Ms. Stelly also encouraged continued advocacy around medical debt issues and network access; that is, meeting people's needs with a sufficient number of in-network providers within a reasonable distance.

DISTRIBUTION LIST MANAGER

Qualifications: Because we already have an established list of volunteers, the main job is to maintain the distributors' lists, which we use to distribute the bi-annual Voters Guide and the yearly Facts for Voters. The distribution manager will contact volunteers via email and phone calls to remind and coordinate distribution, and have a willingness to contact members to fill vacancies. This position offers a chance to get to know and talk with members. The distribution manager will communicate with all distributors to ascertain their availability 3 times per year: at least 8 weeks before the two election cycles, and before the disbursal of the Facts for Voters. Very basic knowledge of Excel would be helpful. Training is available.

1. Voters Guide

In Print: The LWVLA printed the *Voters* Guide on October 14th and volunteers began distributing them to 124 sites in Union County. If you go to a store/library/ post office that doesn't have one, ask if it is available. If not, but the proprietor is willing to provide them, contact me and I'll drop some off. With Vote411, you can compare candidates' information side-by-side, and create your own custom ballot based on your address. One advantage to this website: candidates who don't answer the questions by the Voters Guide printing cutoff date can do so on the VOTE411 website, right up to the election. For example: Mary Forzani, a write-in candidate for the 85th district PA House of Representatives, is not in the *Voters Guide* but is on Vote411.

VOTE**411** also provides links to register to vote, check your voter registration, find your polling place, discover upcoming debates in your area, and much more!

Ballot Questions in November Election

There are no ballot questions for the November election. Local newspapers recently printed a full-page public notice titled: Proposed Amendments to the Constitution of Pennsylvania.

A careful reading of this notice is needed to understand there will be NO ballot questions about the proposed Constitutional amendments on the November 2022 ballot. A brief explanation follows.

- Paragraph 2 of the notice, beginning "The General Assembly...", explains what must happen before these proposed amendments can become questions that appear on the ballot or become law. These amendments have been approved once by a majority of the current Senators and Representatives of the 2021-2022 PA General Assembly in July 2022. If a majority of the Senators and Representatives in the PA General Assembly elected this November approves one or more of the proposed amendments for a second time by the end of the 2023-2024 session, they would appear on the next ballot. The earliest any questions could appear on the ballot would be May 16th, 2023. Each approved amendment would appear on the ballot as a separate question for voters to approve or reject.

- Paragraph 4 of the notice says, "Words that appear in bold print are changes to the words of the Constitution that are proposed by the General Assembly." If it is NOT in BOLD PRINT, it is NOT a proposed change. The notice contains parts of the PA Constitution that are no longer the law. Part 4 of Joint Resolution 2022-1 seems to indicate that the voting age is 21, instead of 18, and that residency requirements for voting are more than 30 days. However, this text does NOT propose changes to voting age and residency requirements because it is not in bold print. It is outdated information that hasn't been formally changed in the PA Constitution. The 26th Amendment of the U.S. Constitution made 18 the legal voting age in 1971. The PA Constitution states this elsewhere, but that statement does not appear in the notice. Also, residency requirements to vote in PA have been 30 days since 2002 (see Statutes of Pennsylvania, Title 25, Chapter 13).
