# STRATEGIC PLAN UPDATE

In the November 19th LWVLA Town Hall, the question was asked, "What are our values?" Part of the answer can be found in the LWV Transformation Roadmap, published in January 2018: "Our Value Statement: The League believes in the power of women to create a more perfect democracy." This belief is coupled with other values woven throughout our LWVLA bylaws: integrity, nonpartisanship, grassroots governance, education, active participation, and conviction that all people are capable of acting in good faith.

The LWV Transformation Roadmap explicitly calls for a culture change - one that acknowledges the importance of our suffrage history and declares what's required for the future League. Keys to success in "Defending Democracy. Empowering Voters" (the LWV Mission), are a commitment to diversity, equity and inclusion; building greater trust across all levels of the League; adapting historic 'League Way' to current needs; engagement, membership, retention; and communications – both internal and external. As we continue envisioning our LWVLA future and recognizing what capabilities and resources we need to achieve it, these values will be critically important touchstones.

# Candidates Night

Over 100 community members attended all or part of Candidates Night on Wednesday October 30th, 2019, at the East Buffalo Township Building. Three panels were presented: Union County Commissioners; Supervisors for East Buffalo, Union and Lewisburg Borough Ward 4; and School Director for Lewisburg, Milton (region 3), and Mifflinburg (region 2). # Update on New Voting Machine Demonstrations

In the November League Line, we identified the 43 volunteers who were trained by the Union County election office on the new machines. Starting six weeks prior to the November 5<sup>th</sup> election, these volunteers appeared at 30 sites and trained 646 community members on how to use the new equipment.

# Transparency Initiative

We included new language at Candidates Night to explain how we record and publicize our video recordings. The following information was explained at the event by Janice Bigelow, moderator, and to all the candidates prior to their agreement to attend:

The League of Women Voters of the Lewisburg Area is a political organization, but it is also nonpartisan. Nonpartisanship toward candidates and political parties is critical to the effectiveness of the League's unique voter services work. Candidates Night is provided by the League as an opportunity for citizens to learn and to hear directly from candidates. The event will be recorded from start to finish and provided, unedited, online via YouTube and the LWVLA Facebook page and website soon after the event.

We also explained to the audience how our League questions are created and the vetting process that is used at Candidates Nights to determine which questions asked by community members are posed to the candidates.

The selection criteria for LWVLA questions are that questions:

- 1. Must be relevant to current issues
- 2. Must be relevant to the offices being considered
- 3. Need to be carefully phrased as to prevent bias and partisanship

#### Audience questions:

- 1. Must be relevant to all candidates for the office in question
- 2. Must be comprehensible
- 3. Must not be inflammatory
- 4. Must not contain any gratuitous attacks on any candidate
- 5. Must be relevant to the office in question
- 6. Must not repeat a previously submitted question

Kandy Duncan continues to facilitate the committee within Voter Services that is addressing how we can become more transparent. We have completed the Candidates Night procedures (as mentioned above), and we are now working on specifying the procedures involved in creating the *Voters Guide*.
