- Send agendas and minutes from your board meetings to your LLC. ***Please do not send them to the LWVC.***
- Send your Annual Meeting materials to your LLC. ***Proposed local bylaws changes must be submitted to your LLC for review prior to presenting them to your membership for consideration with annual meeting materials.***
- Send your *VOTER* to your LLC.
- Schedule a date for board training with your LLC. Please have several possible dates ready when you contact your LLC.
- Contact your LLC for help with organizational problems, routine visits to your League, board meetings, and requests for training.
- For assistance in a specific area, contact the LWVC board member whose portfolio covers the area of your concern. If you are not certain which member of the board to contact, ask your LLC.
